Officers discovered two casings in front of the location. The clerk, Pavan Surapuneti, told officers he heard a loud noise around 2:30am, but he was not sure if it was a gunshot. Milwaukee police incident report #151360032 filed.
- 5. On 09/02/2015 Milwaukee police responded to 1432 West Locust Street regarding a battery. Video obtained from the business depicts a female being assaulted outside the business. This incident was recently publicized on YouTube, but was never reported to the police by the business, the victim or any additional witness's.

8. On 09/11/2019 at 4:18am officers were dispatched to a Shots Fired complaint at N. 14th St and W. Locust St. While on scene they were flagged down by the clerk of the Locust Gas and Food Mart, who stated the shooting occurred on their property. While on scene the officers were advised there were shooting victims at Mt Sinai from this location. The applicant arrived on scene and provided the officer with the video surveillance, which did capture the incident. The video showed the victims parked in the lot for about 15 minutes prior to the shooting. It showed multiple people approach the auto. It also showed the suspects approach on W. locust St and fire at the car from a distance. The clerk and applicant were cooperative.

- 9. On 05/09/20 at 9:25pm, Milwaukee Police were dispatched to 1432 W. Locust Avenue for a theft complaint. Upon arrival, officers interviewed the caller who stated that she put \$20 into an amusement machine, at 9:00am, to charge her phone and play video games. When she left the location, she forgot to retrieve the remaining balance from the machine. At 9:20pm, she went back into the establishment and was told there was no refund ticket. The clerk stated that that a refund ticket would usually print out, but that ticket was not in the cash drawer. The clerk told the caller she would have to come back in the morning and talk to the employee who was working at the time.
- 10. On 05/12/20 at 10:04am, Milwaukee Police conducted a license premise check at 1432 W. Locust Street. Upon entering the store, officers observed 2 entertainment machines on the east wall of the filling station which were turned off and a sign saying, "out of order". The employee stated that the machines were "out of order" because of the safer at home order and he did not want customers to gather inside the establishment. The employee was told that he needed a Public Entertainment License to operate the machines and that they were for entertainment purposes only. The employee understood and would inform the applicant.
- 11. On 11/18/20 at 3:41am, Milwaukee Police were dispatched to 1432 W. Locust Avenue for a property damage complaint. Officers spoke with the store clerk who gave officers the agent information. Officers spoke with the agent who was able to provided video access regarding the incident. The business was cooperative with police during the investigation.
- 12.On 03/22/21 at 12:55 pm, Milwaukee Police conducted a license premise check at 1432 W. Locust St. Officers spoke with the owner regarding his interest for being a standing complainant for Loitering/Trespassing violations. The owner agreed and filled the complaint forms, which allow police to enforce loitering/trespassing ordinances on the premise. The agent was then provided with No Loitering No Trespassing signs to display around the business.
- 13. On 04/20/21 at 9:00am, Milwaukee Police conducted a license premise check at 1432 W. Locust St. Officers observed that the location had one amusement video gambling machine operating within the location. Officers looked over the listed city licenses and it was discovered the business did not have a Public Entertainment License for the machine. Officers spoke with the agent on scene and were shown proof of an application for the license. The agent was advised to have the machine unplugged and not operating until the city grants the license approval. The agent was cooperative, unplugged the machine and stated that he would wait for his license.

14. On 09/07/2021 at 1:18pm officers were dispatched to a Shooting at Locust Quik Mart, 1432 W. Locust St. The officers interviewed the clerk, who allowed the officers to view video of the incident. The video showed a vehicle on the street firing at a group of people on the lot. The vehicle then fled westbound on Locust.

15.On 11/19/2021 at 1:28am officers were dispatched to a Shotspotter at 1432 W. Locust St. The officers interviewed the clerk, who stated he heard several shots but did not see the suspects. The business had video but the room where it was located is locked until 7:00am. The business had security but he took cover when he heard the shots fired.

INITIAL INVESTIGATION

This supplement report is submitted by Police Officer De' Shon NASH assigned to District 5, Early Power shift.

On Tuesday September 7, 2021 Squad 5263 (myself and P.O. Leon YOUNG) was dispatched to a Shooting complaint at the Locust Quik Mart at the address of 1432 W Locust which is located in the City and County of Milwaukee at approximately 1:18PM.

Upon arrival on scene I spoke to employee OJEDA, Mario E (W/M 12/1/1999) who allowed us to view video footage surveillance which was a vital piece of evidence regarding this crime.

We were able to determine the make and model of the vehicle due to viewing the surveillance footage.

The Locust Quik Mart had no involvement with this shooting incident other then the shooting occurring in the parking lot.

Details of the shooting

I was able to review the surveillance video footage of the incident.

At approximately 1:05PM 4 black male subjects enter the gas station, at approximately 1:10PM those same subjects exited out of the Locust Quik Mart gas station. One of those subjects entered a the front seat passenger door of a white Hyundai Elantra, unknown plate with plastic covering the drivers side window. The other 3 subjects walked east bound on W Locust St, outside of the camera view. At approximately 1:12PM those same subjects then began to walk West bound on Locust and into the gas station parking. At approximately 1:13PM a Gray Kia Sportage SUV, unknown plate number, unknown number of occupants, appeared on camera traveling West bound stopped and began discharging a firearm striking one of the subjects. The vehicle then fled at a high rate of speed west bound on locust and then traveled North bound on Teutonia Av.

This concludes my report.

This report is being written by PO Hector M SOSA, assigned to District#5 Late shift on squad 5371, with PO Bradyn RIECK. Body worn camera used during this investigation.

On Friday, 11/19/2021 at 1:28am, I was dispatched to a Shotspotter complaint, F81-722832, at 1432 W Locust St. The location is the Locust Quick Mart, Filling station. The system detected 12 shots, at 1:25am, in the southeast entrance of the station. The casings extended into the parking lot of the gas station.

No victims' were located at the location. PO RIECK made contact with the store clerk, Mario E OJEDA (w/m 12/01/1999), who heard several shots fired from the location. He stated that there is a functioning surveillance system but the room was securely locked and there was no access until 7:00 am. He also directed me to the licensing placards against the east wall inside the clerk section of the station. There was a Filling Station License #0199611, exp 6/30/22. The licensee was identified as, JASJEET SINGH (AGENT). OJEDA didn't see any suspects shooting.

PO RIECK, also spoke with Laron A WILBURN (b/m 05/06/73). He stated that he is Security for the premises. He stated that he heard several shots and took cover. He stated that he then heard a vehicle squealing its tires, but did not see the suspect shooting.

No calls for service were made from the location after the shots fired occurred.

Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
