"This report is written by PO Chris DANDROY assigned to District 6 Late Shift on Squad 6350.

On Wednesday January 1st 2025 at approximately 12:17 AM, PO CONNER and I were dispatched to a battery call located at 5105 S. Howell Av (Best Western Plus Milwaukee Airport Hotel) which is located in the City and County of Milwaukee.

Due to the nature of the call, there was 4 squads dispatched to the scene, Squad 6250, Squad 6252, Squad 6290, and Squad 6350.

Upon arrival we everything had settled down and found the main party on the second floor right down the hallway from the pool area where their rooms where located. I spoke with a person involved later identified as Tameka K. THOMAS (B/F 06-30-78) who stated that there was a fight between one of the staff members and someone from their party. THOMAS stated that there was a buffet for the new year's celebration and the cook's son came out of the kitchen and saw someone from THOMAS' party that was looking at the buffet but did not pay for the buffet and the cooks son told her that she could not have any because she did not pay for it. A verbal argument ensued, and things escalated between the cook and her son and two members of THOMAS' family.

When Officers arrived the cook and her son were no longer on scene and an employee who was working at the time did not notice the fight between employee and guest. We spoke with the employee of the hotel, and they did not want to press charges and just wanted the two subjects that were involved to leave the premises. THOMAS stated that they were all leaving because they thought the hotel staff handled themselves poorly and THOMAS and family were cooperative with leaving the hotel. Officers remained on scene until guests left the Hotel.

Unarmed Security was on scene and an employee who were both cooperative during the investigation. I did not observe any license posted but upon a check online, their licenses were up to date and did not observe any violations while on the premise.

Upon our arrival I observed, two white males in the lobby of the hotel one with a bloody tissue paper and blood stains on his t shirt. Frederick ROSENBERG (w/m) 11-02-1956, the caller stated that he was watching tv with three other persons in room #158 when the subject Richard J COOK pushed ROSENBERG knees out of the way and struck ROSENBERG in the nose with a closed fist without consent causing ROSENBERG nose to bleed. ROSENBERG then used the lobby phone to call MILWAUKEE POLICE DEPARTMENT. Upon our arrival to the room COOK was willing to leave which was okay with both the business and ROSENBERG. Nobody from the business witnessed the actual fight.

I spoke to the manager who was at the front desk, Michelle L BANASZAK (w/f 04/28/1973) who wanted COOK removed. Best Western was completely cooperative. MAMAHUA stated she was on the premise for over 3 hours. It should be noted the employee was fully Cooperative during this investigation.

While on scene, I observed the license posted and observed they were up to date. During my investigation for a trouble with subject, I did not observe any violations in the licensed premise.
