DEAR PERSON OF INTEREST:

The Common Council has referred File No. 240937 to the City Plan Commission (CPC) for recommendation. This file relates to the 1st Amendment to the Detailed Planned Development (DPD) known as Southgate Marketplace, Phase 2 to add "assembly (banquet) hall" as an allowable use within the former cinema building, and approve site and exterior building changes for the property located at 3300 South 30th Street, on the west side of South 27th Street, south of West Euclid Avenue, in the 11th Aldermanic District.

Kanaan LLC recently purchased the subject site, and is requesting to amend the DPD zoning to allow the former cinema building to be reused as a banquet (assembly) hall with a maximum capacity of 1,068 people. A warming kitchen is proposed to be added within the building to aid the catering staff in serving the banquet hall. Additionally, one of the existing theaters will remain as a theater for special events. The main entrance area on the east side of the building will be remodeled, and a covered porte-cochere drop off area will be provided along the entrance. The portion of the parking lot that will be utilized by the banquet hall will be repaved and restriped to provide approximately 184 parking spaces for guests and staff, and new landscaping and light poles will be added.
