This is to notify you that on March 6, 2007 the City's Licenses Committee voted to recommend to the City's Common Council that your renewal application for a Class "B" Tavern license for the premises at 2492 South 13<sup>th</sup> Street ("El Azteca Bar") be approved with a ten (10) day suspension based upon a police report.

On March 8, 2007 you were sent a true and correct copy of the findings of fact, conclusions of law and recommendations of the Licenses Committee with respect to your renewal application for a Class "B" Tavern license in which the Committee recommended that your license be renewed with a ten (10) day suspension. You were further notified that the Milwaukee Common Council would consider the matter at its meeting of March 22, 2007 commencing at 9:00 a.m. in the Common Council Chambers on the third floor of City Hall, 200 East Wells Street, Milwaukee, Wisconsin. You were advised of your right to file written objections and to appear personally or by counsel to address the Common Council. At that date, time and place you did not appear, nor did you file written objections to the report of the Licenses Committee. You were not represented by counsel.

Following consideration of the report of the Licenses Committee, the Common Council approved the recommendation of the Licenses Committee by a vote of fourteen (14) Ayes, zero (0) Noes and one (1) Excused to renew your license with a ten (10) day suspension based upon a police report.
