I Linda Stephens (Complainant), an adult residing at 3553 North Martin Luther King Jr. Drive in the city and county of Milwaukee, Wisconsin do respectfully show and allege as follows:

- I am a neighbor of the tavern known as "Tap Whatever" and have resided in this neighborhood for over 30 years. I have witnessed the steady incline of violence involving patrons of this tavern.
- The shooting just a year ago on February 13, 2006 was terrible and ended the life of one man and endangered the life of others.
- After that shooting, I took action and came down to the hearing, along with Alderman McGee, to speak against the renewal of Mary Greenlee's license. She said she had no knowledge of the argument that led to the shooting on February 13, 2006. She also said that after 2006 she and her sister (who was sick and could not be there) were going to be getting out of the business (at Tap Whatever). She also spoke of not seeking to renew her license in 2007. The court should have record of her statements to verify my account. I still gave my testimony against the renewal because of the increased violence.
- On September 19, 2007, I was awakened (just before midnight) to what sounded like a mini war. Some shots were so loud, they sounded like canons. Truly, In all my years here in this neighborhood, I have never heard anything like the shooting I heard that night.

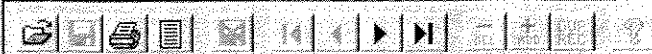
