Upon our arrival, we were in the rear of the business and heard numerous gunshots. We immediately ran to the business and broadcasted what we heard. Numerous vehicles were fleeing the area and we tried to get all the information out over the radio.

The initial caller stated there was a brawl inside of the store with 12-15 subjects. The caller stated no medical attention was needed and the store was being tore up. The caller stated they were using sticks and brooms to hit each other.

Due to the nature of the call and officers hearing shots fired, the call required 4 2 man squads and 2 Sgts. on scene.

The video captured approximately 8-10 people fighting inside of the store and leaving the store in disarray. The video also shows the subjects go outside and one of the female subjects fire a gun. The female fires the gun approximately 6 times towards N 20th St. PO SANTIAGO is in the process of uploading the video to evidence.com.

The was a Shotspotter Alert that came over regarding the shots fired at the same address. CAD P2601091544- Flex ID 81-1272096 6 Rounds- 6 Casings were recovered

We originally had one victim on scene, but she later left the location before being properly identified. It turns out she was the subject who was firing the gun.

PO MENDOZA completed the report regarding the property damage, disorderly conduct and ESBUDW.

The store was in complete disarray with numerous food items and racks all over the store.

I spoke to the store employee identified as Harjinder SINGH (W/M 02/10/1992).

Interview of Harjinder SINGH (Employee):

SINGH stated they are open 7 days a week and from 5 AM until 12 AM. SINGH stated the store does not have a phone. SINGH stated they have security at the location and they are not armed. SINGH stated they have cameras and they work. (We did view them on scene). SINGH stated they rarely have problems at the location.
