Please be advised that on January 15, 2008 Mr. McNeal, by Attorney Franklyn M. Gimbel and Michael D. Guerin, filed a summons and complaint seeking review of the action of the Milwaukee Common Council in revoking the Class "B" Tavern License and various tavern-related licenses and requested an temporary injunction ordering the City of Milwaukee to not enforce the revocation of the Milwaukee Common Council. This office filed the record and brief in objection to the entry of a temporary injunction. The matter was heard by the Honorable David A. Hansher on the afternoon of January 24, 2008.

The court denied the injunction citing the numerous instances of violent behavior taking place at the premises and set the matter for a status conference on April 3, 2008. As events in this matter further unfold this office will keep you advised.
