INITIAL INVESTIGATION

This report is written by PO Scott DAVIS, assigned to D7, early shift on squad 7263 with PO Lawrence TETZLAFF. Today we were working in full police uniform with badges and nameplates affixed to our outermost garment, with working body-worn cameras. We were operating a white, unmarked police squad car with working LED red and blue lights and siren. I was driving the squad while PO TETZLAFF was the passenger. Our regular daily duties on the Milwaukee Collaborative Offender Re-Entry Program involve locating and arresting offenders in the District 7 area who are wanted for Violation of Parole (VOP) warrants from the Wisconsin Department of Corrections.

On 9-11-18 at about 4:00 PM, during a time of bright clear sunny weather on a 65 degree Fahrenheit day we went to the area of 4900 W Hampton Ave to check for a known wanted subject, Michael J CALVIN (B/M, 5-11-96) who was wanted on a VOP hold since August 9, 2018. According to a prior police report, CALVIN had listed an address of 4948 W Hampton Av and was known to frequent the area of Wahl Park, a block south and a block to the east of that address. I had also learned in the course of our investigation from a confidential source that CALVIN would likely be in possession of a firearm. In our squad car, PO TETZLAFF had a paper copy of a picture of CALVIN from the Wisconsin DOC which depicted his face and hairstyle, and listed his physical description of 5'7" and 160 pounds. While I was driving in the area of 49th and Hampton, I observed a black male subject walking westbound on the north side of Hampton heading towards the 5000 block. This male appeared to match the picture PO TETZLAFF had of CALVIN which I had previously studied. He was wearing a dark jacket over a red t-shirt and grey pants. I did a u-turn on Hampton to check the area but did not see the male subject on the street any longer. We checked the corner store (Poppa C's Food Market, LLC) at 5022 W Hampton Av and located the male subject towards the rear of the store, wearing the same clothing, near what appeared to be a deli counter, about 10-15 feet inside the store from the front door. PO TETZLAFF asked CALVIN his name and

he did not say, and denied having any identification on him. From standing near him and observing his face and physical characteristics, I was able to positively identify him as CALVIN and took control of his left arm as PO TETZLAFF put his right wrist in a handcuff.

As PO TETZLAFF attempted to place CALVIN's left wrist in the other handcuff, he was not able to because of the sleeve of CALVIN's jacket. While taking control of CALVIN's left arm, I could feel it go from relaxed to tense almost immediately after I placed my hands on it. I told CALVIN to relax and to not tense up his arm. CALVIN then took a step towards the direction of the front door. In my experience, subjects in the process of being handcuffed often take steps away from officers in an attempt to escape the arrest. I then re-positioned myself to stand between him and the direction of the front door while maintaining control of his left arm, which was still tensed up. CALVIN said many rhetorical statements while we were attempting to handcuff him and while PO TETZLAFF was telling him to stop resisting, such a "What are y'all doing, bro?" and "They trippin'" to other customers in the store, seemingly ignoring our instructions to stop resisting. CALVIN then attempted to take another step towards the front door in an apparent attempt to escape arrest, which caused me to lose some control over his left arm. At this point I called on my hand-held radio for backup officers to assist us. CALVIN then reached towards the front of his body, while spinning his body so that he was facing me. Having not been able to conduct a search incident to arrest of his pockets, rather baggy coat, and waistband because of his resistance, and because his reaching towards the front of his body is a possible location to keep a firearm that could potentially kill me or my partner, I then attempted to place CALVIN on the floor of the aisle we were in to facilitate handcuffing, as well as reduce the possibility of him using a deadly weapon to kill us. He tensed his upper body which made decentralizing him momentarily impossible. I attempted to take control of his head to perform a "secure the head" decentralization, but instead his head struck the top shelf of the aisle in which we were standing. I gave CALVIN repeated orders to get on the ground but he did not comply. His non-compliance further worried me that he would try to escape and/or kill us. Since I was unsuccessful to this point in decentralizing him, we tried yet again to handcuff him while standing, since PO TETZLAFF still had control of his right arm, which was still handcuffed. I then heard PO TETZLAFF say "pistol" at which point I quickly took control of CALVIN's head and decentralized him to the floor. At this point PO TETZLAFF was able to finish handcuffing him. I then observed a tan and black pistol laying on the floor right where we had been struggling with CALVIN. There were other people in the store, between us and the front door who I told not to approach the pistol.

PO TETZLAFF told a female who was standing in the aisle behind us, later identified as a store employee, Keesha P TAYLOR (B/F, 12-31-73) to leave the gun where it was. TAYLOR apparently ignored the order from PO TETZLAFF and stepped over where the pistol was to pick up a cell phone and some loose dollar bills that was also on the floor in the aisle. Believing that it was CALVIN's phone and in order to secure my arrestee's property, I went to tell TAYLOR to give me the phone, at which point I saw the phone in her left hand and recognized it as my personal cell phone. She refused to give it to me, telling me I didn't have the right to touch her to retrieve my property. She eventually placed it behind her, on a counter at which point I was able to retrieve it. TAYLOR was inexplicably angry and continued to yell in a loud manner at me for retrieving my property and for arresting CALVIN. I then secured the gun on the floor while awaiting backup officers. Squad 7282 PO Andrew LANGER responded and assisted us with moving CALVIN to a marked squad outside the store. By this time, about 10 customers were present in the store.

The following squads responded to our call for assistance and for a supervisor for the use of force: 7213 Sgt Brian BLUM, squad 7249 PO Herb DAVIS and PO Chelsey MCDOWELL, squad 7269 PO Troy MASON and PO Matthew KNAACK and squad 7284 PO Kevin KAMPS and PO Nesrodene GHASSOUL. While en route (in a marked squad car and with lights and siren activated) to our location to assist us, Squad 7269 was involved in a two-car crash at the intersection of W Hampton and N Hopkins in which their squad was struck by a citizen's car. Both PO KNAACK and PO MASON were transported to Froedtert Hospital with injuries.

I secured the pistol in our squad and unloaded it, at which point I observed there were four (4) unfired cartridges in the magazine. The pistol is Kel-Tec LaserLyte 9MM semi-auto pistol with a 7-shot capacity magazine, with a serial number of RX241. It did not list as stolen.

The firearm, magazine and cartridges were conveyed to D7 and placed on MPD inventory #18034528 and gun tag #83956. CALVIN is a convicted felon in Wisconsin, case number 2014CF003468 in which he was found guilty on 3-16-2015 of Theft-Party to a crime, a class G felony.

PO TETZLAFF retrieved a DNA swab from CALVIN and also attempted a custodial interview of CALVIN (see PO TETZLAFF's supplemental report for more details regarding). The DNA swab was placed on MPD inventory #18034564.

The store owner Calvin L SMITH (B/M, 5-2-65) came to the location in an attempt to retrieve video footage of the arrest from the store's video camera system. He was unable to create a hard copy for us on 9-11-18, stating that he would have to call the service provider since the video footage is not stored on a DVR at the location. I called him by phone on 9-12-18 to check his progress on retrieving video but got no answer.

Other employees on scene during this incident were Terrence L WALLS (B/M, 9-10-64) who was working in the front plexiglass-enclosed area, and Jerome S SMITH (B/M, 9-11-80). Both SMITH and WALLS were relatively cooperative and were interviewed by Sgt. BLUM as to what they witnessed with regard to the arrest of CALVIN.

This report is written by PO Scott DAVIS, assigned to D7, early shift on squad 7263 with PO Lawrence TETZLAFF.

On 9-11-18 at 4:00 PM we were at the corner store Poppa C's Food Market LLC at 5022 W Hampton Av with a subject in custody for a Violation of Parole (VOP) hold with the Wisconsin Department of Corrections, Michael J CALVIN (B/M, 5-11-96). The circumstances of this arrest are detailed in Incident Report 18-254-0101.

During this arrest there were employees of the store present: Terrence L WALLS (B/M, 9-10-64) who was working in the front cashier area, Jerome S SMITH (B/M, 9-11-80) who was towards the rear of the store

along with Keesha P TAYLOR (B/F, 12-31-73). I observed that TAYLOR was wearing a grey sweatshirt and grey sweatpants, and was holding a cell phone in such a manner that would be consistent with her filming the encounter between PO TETZLAFF and I and Michael CALVIN. TAYLOR was the only person nearest to us after we finally had CALVIN in handcuffs on the floor of the westernmost aisle of the store. Next to CALVIN on the floor were 4-5 dollar bills, some items which had fallen from the shelves of the aisle, a cell phone and a pistol which had fallen from CALVIN's waistband during his resisting arrest. PO TETZLAFF was kneeling with CALVIN on the floor, handcuffed, while I stood between them and the 4-5 customers who were standing near the front store entrance, one of who asked if he could retrieve CALVIN's property. I told him that no one was going near the gun. I then heard PO TETZLAFF say to TAYLOR "Don't touch that gun!" which re-focused my attention away from the front door and towards TAYLOR.

I stepped past PO TETZLAFF and CALVIN in TAYLOR's direction, fearful that she had picked up the firearm and was going to shoot and/or kill us. I was able to see that she had instead picked up a cell phone and a couple dollar bills, and at first I thought it was CALVIN's cell phone. Since it was not TAYLOR's I attempted to retrieve it in order to protect my arrestee's property. Since my attention was now focused on TAYLOR, I was unable to stand by with PO TETZLAFF and Michael CALVIN to ensure their safety. Instead, I now had to retrieve property from a citizen.

After a few seconds of TAYLOR screaming at me, I then recognized the cell phone she picked up as my personal cell phone which had apparently fallen from my external vest carrier pocket during the arrest of CALVIN. TAYLOR still had a cell phone in her right hand and turned her body away from me to prevent me from retrieving my phone from her left hand. She finally placed it on a counter at the rear of the store and walked away, allowing me to retrieve my property.

Other squads arrived and officers assisted PO TETZLAFF and I with securing the firearm and Michael CALVIN in a squad. Sgt. Bradley BLUM arrived to investigate the use of force and spoke to TAYLOR, Jerome SMITH and Terrence WALLS regarding what they saw of the arrest. TAYLOR told Sgt. BLUM she had been filming our arrest of Michael CALVIN with her cell phone but had since deleted the video, further obstructing our investigation. The few dollar bills that CALVIN had in his possession before and during the arrest which fell to the floor were missing upon our return to the store.

The owner of the store later came to the scene, identified as Calvin L SMITH (B/M, 5-2-65). He showed store video of the incident to Sgt. BLUM using a cell phone-based application, but was unable that day to make a hard copy of the video on a disc or flash drive since there is no recording equipment at the store. As of the writing of this report, Calvin SMITH still has not responded regarding our request for a hard copy of the video.

This case to be reviewed at the Milwaukee County DA's office, date pending the order-in of TAYLOR.


