There is a possibility that your application may be denied for one or more of committee regarding the application shall be based on evidence presented at the heat of the per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. It is the intention of the Common Council to suspend or non-renew the licenses if objectors provide testimony related to the factors enumerated in MCO 85-4-4 that the Common Council finds to be true by a preponderance of the evidence and/or police reports are found to be true by a preponderance of the evidence. The police reports and other attached documents relating to objections to the license are a part of this notice and expressly incorporated in this notice. The licensee should be prepared to addre

Notice for applicants with warrants or unpaid fines:

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing. You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing. You are hereby notified that the Milwaukee Common Council will hold a hearing on Tuesday, April 18, 2023, commencing at 9:00 a.m., or as soon thereafter as this matter may be heard, in the Common Council chambers on the third floor of City Hall, 200 East Wells Street, Milwaukee, Wisconsin to consider whether to renew, renew with a suspension between 10 and 90 days, or not renew your Class A Fermented Malt and Food Dealer licenses for the premises located at 200 E Chambers St. ("Chamber East Food").

Attached you will find a copy of the Report of the Licenses Committee, which includes its Findings of Fact, Conclusions of Law, and Recommendation, recommending not to renew the Class A Fermented Malt and Food Dealer licenses based upon the preponderance of the evidence in the police report that demonstrates the operation results in a threat to health, safety or welfare of the public for the violations to the license, the behaviors displayed in the video, the loitering inside the store, the illegal drug activity, drinking in public and the display of materials harmful to minors. This recommendation is the result of a public hearing before the Committee held on Wednesday, March 29, 2023.

Please be advised that the Common Council will determine whether to renew, renew with a suspension between 10 and 90 days, or not renew the Class A Fermented Malt and Food Dealer licenses based upon the Findings of Fact contained within the Licenses Committee report.

You may file a written response to the report of the Licenses Committee. The written response must be filed with the City Clerk by 4:45 p.m. on Wednesday, April 12, 2023 in Room 205 of City Hall. If you wish to file both jowcza@milwaukee.gov objections e-mail, they must be sent to via stasst5@milwaukee.gov. Within 24 hours, you will be sent an e-mail notification that your objections were received. If you do not receive this notification, please contact City Clerk Jim Owczarski at (414) 286-2998. If you file written objections, you or a legal representative may then also appear at the Common Council to make oral arguments supporting the written objections. You will be given approximately five minutes to present the oral argument.

Re: Report of the Renewal Application of Davinderjit Kaur, Agent for Chamber East Food Market LLC, for Class A Fermented Malt and Food Dealer licenses for the premises located at 200 East Chambers Street in the City and County of Milwaukee, Wisconsin ("Chamber East Food").

FINDINGS OF FACT

- 1. Davinderjit Kaur (hereinafter the "Licensee") is the holder of Class A Fermented Malt and Food Dealer licenses for the premises located at 200 East Chambers Street in the City and County of Milwaukee, Wisconsin ("Chamber East Food"). Said licenses expired at midnight, April 21, 2023.
- 2. An application to renew said licenses was filed with the Office of the City Clerk on February 15, 2023.
- 3. Pursuant to Chapters 68, 85, and 90 of the Milwaukee Code of Ordinances, the matter was referred to the Milwaukee Police Department for investigation.
- 4. On February 16, 2023, the City Clerk's Office provided notice to the Licensee pursuant to Chapters 68, 85, and 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the police report and neighborhood objections and included a copy of the police report and objections. The matter was scheduled for a hearing on the police report and objections on March 29, 2023, commencing at approximately 3:20 p.m. in Room 301-B of the third floor of City Hall. At said date, time and place, the Licensee appeared with counsel, Attorney Michael Maistelman, and admitted receipt of the notice of hearing, together with a copy of the Milwaukee Police report and objections.
- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. On January 11, 2023 at 5:44 p.m., officers conducted a License Premise check at 200 East Chambers. Officers interviewed the manager who stated





- since the last inspection they have been more vigilant about calling the police regarding people loitering or using drugs. Officers did locate three (3) calls for police placed by the manager. The interior appeared to be clean with no odor of cigarette or marijuana smoke.
- B. On January 20, 2023 at 5:58 p.m., officers conducted a License Premise check at 200 East Chambers. No violations were found and the employee stated they are having less problems with people loitering since officers have been conducting regular business checks at the location.
- C. On January 30, 2023 at 6:08 p.m, Milwaukee Police conducted a license premise check at 200 East Chambers Street. While conducting the check, an employee told police about a customer, who had just left, who was selling drugs inside the store. The employee said he's called police on numerous occasions but the subject is gone before police arrival. While talking to the employee, the same subject entered and exited the store approximately six times. The employee told officers that he wanted him "trespassed" and when the officers told the subject to leave, he began shouting profanities at the employee. The subject eventually left. The employee was cooperative throughout the license premise check no violations were observed.
- D. On February 1, 2023 at 7:45 p.m., Milwaukee Police conducted a license premise check at 200 East Chambers Street. Upon arrival to the location, officers did observe numerous vehicles occupied and running on both N. Palmer Street and E. Chambers Street. While officers were inside the store, they observed no violations and the manager was cooperative.
- E. The Licensee was present along with Attorney Michael Maistelman who said that they are not disputing the item #7, that the employee was terminated immediately and, that the incident happened while his client was in India. He added that the expired food and pest control issues are going to be addressed, that there is no excuse for these, and that his client has never had any problem with his license before. He also acknowledged the meeting that his client's employee had with the police and Alderwoman Coggs regarding the video, which is not part of the police report and PA 33's. He also said that he believes the employee present at the meeting is the person his client fired.

Individuals in support:

- F. Sandra 3034 N Commerce St said that she has lived there for 30 years and that she has seen some improvement and that she wants that the store remains open.
- G. Tammy Carrington N Commerce St -said that she almost got killed in the middle of a gunshot on Chambers St and that the gunshots have nothing to do with the store and, that it is the neighborhood store.



- H. Robert Jordan 3036 N Palmer St said that people that do not live there come for trouble and that they have seen some improvement with the police patrolling.
- I. Alderwoman Coggs asked the witnesses if they have smelled the weed, seen expired food and/or people displaying firearms in the store.
- J. The witnesses said that they have smelled the weed from the people outside and people with firearms upholstered but nothing inside the store.
- K. Alderwoman Coggs asked to play the video posted on Facebook that was submitted by one neighbor.
- L. Alderwoman Coggs asked the Licensee if the person in the Nike yellow shirt is an employee.
- M. The Licensee said the he is not an employee.
- N. Alderwoman Coggs said that she is asking it because that person goes behind the cash register at some point in the video. The video continued playing.
- O. Alderwoman Coggs asked who is the 4th person wearing black in the video.
- P. The Licensee said that is his wife's brother and that he owns the building. He also said that they asked the brother to take care of the business while they were in India.
- Q. Attorney Maistelman said that he was the employee that was terminated. The video continued playing.
- R. Alderwoman Coggs asked Mr. Cooney what type of license they have.
- S. Mr. Cooney said that it is a Class A Malt to sell beer and malt beverages for off the premises consumption.
- T. Alderwoman Coggs asked the Licensee that regarding the bottle of alcohol showed on the video, if they sell hard liquor at the store.
- U. The Licensee said that he does not sell hard liquor at the store.
- V. Alderwoman Coggs asked if he allows people to consume alcohol inside the store.
- W. The Licensee said that he does not allow people to drink alcohol inside the store.
- X. Alderman Borkowski asked if the video is from the inside the store.



- Y. The Licensee said that it is inside the store by the entrance. The Licensee said that her brother was the one who managed the business while they were gone for 5-6 months and that he was fired.
- Z. Alderwoman Coggs said that the majority of the dealings for this building has been done with the brother. She added that when she called requesting the meeting with MPD, the Licensee's brother was the one who showed up. She also said that it is hard for her to understand why the brother is there all the time if he is not an employee or the agent
- AA. Alderman Brostoff asked what has been the relationship of the brother with the business.
- BB. The Licensee said that he is only the building's owner.
- CC. Alderman Brostoff said that this narrative is very conflicting and that there is a lack of credibility.
- DD. Alderwoman Coggs said that we saw a man smoking and displaying what seems to be weed, displaying a gun with a silencer on it and drinking alcohol, which is something that should have not happened inside the store. She added that there were many violations and that the brother did not take care of it and even joined the video. She also said that it is an indication that this is not a thing that happened only one time and that the person in yellow even went behind the register without being stopped.
- EE. Alderwoman Coggs agreed with the neighbors that sometimes the congregations are not people from the neighborhood but that allowing that behavior inside the store is different because they are calling for people to come and get illegal drugs from people with firearms and, that it is a challenge for her to support a license where a real change is not going to happen.
- FF. Alderwoman Coggs asked Officer Garland if he has something to say about this license.
- GG. Officer Garland said that he smelled the marijuana in the store and that it seemed that the operation was set up. He added that he has been working in the district for 14 years and that Mr. Singh has been always involved in the store for at least the past 3 years.
- HH. Alderwoman Coggs asked Officer Garland if the Licensee has been proactive addressing issues.
- II. Officer Garland said that they have not been proactive.
- JJ. Alderman Brostoff asked if the Licensee is at the store.



- KK. The Licensee said that she goes for 2-3 hours every day and that those events happened while she and her husband were out of the country.
- LL. Alderman Brostoff said that even if they were not here when those issues happened, they are responsible still and that there is an effect and damage in the community.
- MM. Attorney Maistelman asked Officer Garland if he has come to the committee table to express the issues with this business in the past 5 years.
- NN. Officer Garland said that he has not.
- OO. Attorney Maistelman asked what about his other colleagues.
- PP. Officer Garland said that he can only speak for the three years that he has been around and that a lot of these things are handled by different channels and procedures.
- QQ. Alderwoman Coggs said that the brother did not take the matter seriously when he was approached and, that the vote that she will take here today, will be based on the future of the neighborhood and that she will take part on the efforts for improvement.
- RR. Attorney Maistelman said that there were no issues on the police report before today and that neighbors will have a real problem if the store is not there for them anymore. He added that he does not see anything on the police report that indicates that there is a pattern on the behavior and, requested that the licenses be renewed with a warning letter. He also asked that the committee follow the pattern that have done for the last 5 years for this business.
- SS. Alderwoman Coggs said that she always wants to keep an open mind at every hearing but that she is disappointed because she knows that the Licensee knew about the video, that the brother was fired but still owns the building. She added that there are many red flags that eventually are going to take us to a shooting and that it is the committee's responsibility to avoid it. She added that it is hard to believe that those behaviors from the video are not going to ever happen again and, that she is not confident about the brother being involved with the building because she does not believe that the video was a one-time thing. She also said that the Licensee has surveillance cameras and that she must have noticed the videos before it made it to Facebook and that she should have reported to the police as well.
- TT. Alderwoman Coggs moved nonrenewal based upon the preponderance of the evidence in the police report that demonstrates the operation results in a threat to health, safety or welfare of the public for the violations to the license, the behaviors displayed in the video, the loitering inside the store, the



illegal drug activity, drinking in public and the display of materials harmful to minors. There were no objections. (Prevailed 3-0-2)

CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provided Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapters 68, 85, and 90 of the Milwaukee Code of Ordinances.
- 2. Based upon the above facts found, the Committee concludes that the Licensee, Davinderjit Kaur who holds Class A Fermented Malt and Food Dealer licenses for the premise located at 200 East Chambers Street in the City and County of Milwaukee, Wisconsin ("Chamber East Food") has not met the criteria of Chapters 68, 85, and 90, of the Milwaukee Code of Ordinances to renew the Class A Fermented Malt and Food Dealer licenses. The Committee finds police report as stated above to be true. The Committee finds the nonrenewal based upon the preponderance of the evidence in the police report that demonstrates the operation results in a threat to health, safety or welfare of the public for the violations to the license, the behaviors displayed in the video, the loitering inside the store, the illegal drug activity, drinking in public and the display of materials harmful to minors.
- 3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council of the City of Milwaukee should exercise its judgment to not renew the Class A Fermented Malt and Food Dealer licenses for the premises located at 200 East Chambers Street in the City and County of Milwaukee, Wisconsin ("Chamber East Food"). The Committee based its recommendation upon the preponderance of the evidence in the police report that demonstrates the operation results in a threat to health, safety or welfare of the public for the violations to the license, the behaviors displayed in the video, the loitering inside the store, the illegal drug activity, drinking in public and the display of materials harmful to minors.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of three (3) ayes, zero (0) noes and two (2) excused recommends that the Class A Fermented Malt and Food Dealer licenses held by Davinderjit Kaur for the premises located at 200 East Chambers Street in the City and County of Milwaukee, Wisconsin ("Chamber East Food") not be renewed based upon the preponderance of the evidence in the police report that demonstrates the operation results in a threat to health, safety or welfare of the public for the violations to the license, the behaviors displayed in the video, the loitering inside the store, the illegal drug activity, drinking in public and the display of materials harmful to minors.

Re Mitigation Plan, "Chamber East Food Market LLC," Class A Fermented Malt and Food Dealer License Renewal Applications for "Chamber East Food" at 200 E Chambers St.

This supplemental information should be incorporated into my client's most recent Plan of Operation and shall amend the current renewal application.

My client has implemented a Mitigation Management Plan to address Aldermanic & MPD issues, control noise, security, litter, drug use, graffiti, etc., and provide a protocol for communicating with police to resolve potential problems with loitering, noise, and other issues.

Mitigation Management Plan

Through this Mitigation Plan, my client reached out to MPD Community Liaison Officer Jocelyn Kalmanson to schedule a meeting to walk the property with them and discuss what additional actions we can take to make the neighborhood safer.

My client will also schedule follow-up onsite meetings with the MPD Community Liaison Officer Jocelyn Kalmanson to review and advise us on our security and other measures in the future.

My client will also retain Les Johns, a licensed security professional, to assess their security needs and develop a game plan for the safety and security of the premises and to provide protection for the premises. My client will only hire licensed security personnel for the premises.

My client has installed sixteen cameras. My client has ten cameras in the premises and six around the perimeter of the premises. Eight of the cameras are fed into MPD. My client will add additional security video cameras in and around the perimeter of the establishment as recommended by our security consultant and/or MPD.

My client will install new light fixtures designed to minimize the impact on the residence while providing adequate lighting levels to assure security and discourage loitering. My client will also add additional light fixtures as recommended by MPD and/or our security consultant.

My client will have monthly employee meetings to review these policies and procedures.

Customers will be discouraged from loitering outside the property and surrounding neighborhoods. My client will have their employees/security make hourly sweeps of the surrounding community to ensure no one is loitering.

My client will post signs that police will be called for loitering, littering, and loud noise. Any customer who violates these rules and regulations will be placed on a list and banned from our premises.

My client will immediately notify MPD if any issues arise without concern about having a PA-33 issued.

My client will control and inspect the litter emanating from our site and the general perimeter from their location in the public right-of-way three times per day, in the morning, mid-day, and an hour before close.

My client will participate in a local block watch should one exist.

My client will attend the monthly Crime & Safety Meetings conducted by MPD.

My client will participate in the E-Notify system for email updates regarding the premises.

My client will regularly file open records requests for Milwaukee Police Department Computer Aided Dispatch System (CADS) reports regarding the property.

My client will institute a standing complaint with MPD to allow the police department to remove any individuals loitering on the property.

My client will serve a no-trespassing order against identified nuisance persons and provide the local police district station with a copy of the served order.

My client is also open to suggestions from MPD, Alderwoman Coggs, and the neighbors on how we can effectively address any issues and concerns that may arise.

This mitigation plan is made part of my client's plan of operation.

- 2. On 03/07/2021 officers conducted a license premise check at 200 E. Chambers St. The officers spoke with the manager, who signed a standing No Loitering complaint form. The officer provided the manager with a No Loitering sign to display outside.
- 3. On 05/18/2021 at 4:14pm officers, along with Wisconsin Department of Revenue agents, conducted a license premise check at Chambers East Food Market, 200 E. Chambers St. The officers spoke with the clerk about invoices for tobacco and liquor. The clerk did not know where they were located but contacted the owner by phone. The owner stated the invoices were at his accountants. The Wisconsin Department of Revenue agent advised the owner to come to the business with the invoices. The clerk did not have a Class D operator's license.

Wisconsin Department of Revenue agents removed six boxes of tobacco. The owner signed a standing no loitering complaint and was given a No Loitering sign.

- 4. On 05/31/2021 at 5:49pm, officers investigated a shooting at N. Palmer St. and E. Chambers St. During the investigation, the officers went to East Chambers Foods to check for video. The manger was cooperative and provided video of the incident to the officers.
- 5. On 09/19/2021 at 4:44pm, officers were dispatched to a Shooting at 200 E. Chambers St. The officers spoke with the clerks who stated they did not hear a shooting. The officers then located a bullet hole in the front door that went through an interior wall and a cooler door. The officers asked the clerks why they stated they lied and they stated they did not lie because they did not hear the gunshots.

- 6. On 04/10/22, officers responded to a shooting on E. Chambers St., and W. Palmer St. The shooting was unrelated to the business at 200 E. Chambers., however, the employees were cooperative and allowed officers to view video surveillance of the incident.
- 7. On 11/29/22 at 9:50am., officers conducted follow-up at 200 E. Chambers. This was in regards to an Aldermanic complaint of subjects engaging in health and safety violations inside the establishment. Officers were able to view a Facebook video depicting several subjects inside the establishment smoking, drinking, dancing, throwing up gang signs and pointing a firearm at the camera. The video further depicts what appeared to be an employee entering the video and also throwing up a gang sign. During the video customers can be seen entering the business, many of whom appeared to be juveniles. Upon officers arriving at the establishment several individuals were observed loitering both outside and inside the store. Upon entering the store officers could smell a strong smell of burnt marijuana and a subject was observed smoking a Black and Mild cigar inside the store. Officers further observed one of the male subjects that was in the video displaying a firearm, in the locked employee area with the employee on duty. Upon seeing the officers, the male subject exited the locked employee area and left the store. Officers introduced themselves to the employee and requested his identification, however, the employee stated he did not have one, but provided officers with his name. Officers advised the employee they believed him to be the owner of the building, and the subject in the video throwing up gang signs, however, the employee denied being the owner of the building or the agent. The video and the possible repercussions of that specific behavior was discussed with the employee, who never admitted or denied to incident. Further inspection of the establishment revealed clear plastic bags of chicken for sale with no labeling or expiration date, and vacuum sealed bags of cheese, which had expiration dates of April 2022. Officers observed spring loaded mouse traps in the grocery area of the store. As officers completed the License Premise check, they observed several individuals entering the store smoking. On 11/30/22, officers conducted follow up and requested to see the video surveillance from the day the Facebook video was posted. The surveillance video depicted the same activities that officers observed on the Facebook video and the employee seen in the video was the same employee officers interviewed on 11/29/22. While on scene, a young individual entered the store; approached the counter area, and the employee was observed shaking their head as if to say no. The subject then walked away, browsed a little then left the store without making a purchase. Several other subjects were observed wandering around the store, but did not appear to be shopping. It was later determined through investigation the employee the officers initially interviewed was in fact the owner of the building and the employee in the video. The employee could not answer why they were untruthful to the police when initially

questioned. The employee was cited for Resisting/Obstructing and Smoking Prohibited. Upon in person service of the citations to the employee, a large rat was observed running in the grocery area. Officers made a referral to the Milwaukee Health Department for the observed violations.

- 8. On 01/11/23 at 5:44pm., officers conducted a License Premise Check at 200 E. Chambers. Officers interviewed the manager who stated since the last inspection they have been more vigilant about calling the police regarding people loitering or using drugs. Officers did locate 3 calls for police placed by the manager. The interior appeared to be clean with no odor of cigarette or marijuana smoke.
- 9. On 01/20/23 at 5:58pm., officers conducted a License Premise check at 200 E. Chambers. No violations were found and the employee stated they are having less problems with people loitering since officers have been conducting regular business checks at the location.
- 10. On 01/30/23 at 6:08pm, Milwaukee Police conducted a license premise check at 200 E. Chambers Street. While conducting the check, an employee told police about a customer, who had just left, who was selling drugs inside the store. The employee said hes called police on numerous occasions but the subject is gone before police arrival. While talking to the employee, the same subject entered and exited the store approximately six times. The employee told officers that he wanted him "trespassed" and when the officers told the subject to leave, him began shouting profanities at the employee. The subject eventually left. The employee was cooperative throughout the license premise check no violations were observed.
- 11. On 02/01/23 at 7:45pm, Milwaukee Police conducted a license premise check at 200 E. Chambers Street. Upon arrival to the location, officers did observe numerous vehicles occupied and running on both N. Palmer Street and E. Chambers Street. While officers were inside the store, they observed no violations and the manager was cooperative.

This license premise report was written by PO Nora BURLO, assigned to District Five Late Power Shift, Squad 5468 with my partner PO James TERRELL. On Sunday April 10, 2022, PO TERRELL and I responded to a Shooting complaint at the intersection of N Palmer and W Chambers St.

Upon officer arrival at the intersection, officers located one male subject who was deceased on the ground. Officers were also calling for other squads, due to the amount of people in the immediate area of this incident. Officers observed a small store (Chambers East Food Market) on the N/W corner of the intersection, approximate address being 200 E Chambers St. Officers observed surveillance cameras, which faced the intersection, on the exterior of the store.

PO TERRELL was able to make contact with the store employees and was able to watch the surveillance video to see what had occurred. Due to this being an active homicide investigation, this report will be a general summary of what occurred during this incident.

SURVEILLANCE VIDEO SUMMARY:

Upon watching the store surveillance, PO TERRELL observed the victim travel in a black four door sedan W/B on E Chambers from N Richards St. PO TERRELL then observed the victim travel S/B on N Palmer St from E Chambers St and park his vehicle facing S/B on the S/W corner of N Palmer St and park his vehicle on the west side of N Palmer St. PO TERRELL observed the victim exit the driver side of his vehicle and walk N/B on N Palmer St approaching the driver side of a white SUV which was parked facing S/B on the west side of the St directly across from Chambers East Food Market. The victim was observed standing near the driver side of the white SUV. At this moment, PO TERRELL observed from another camera view (facing south side of location) a black Volkswagen four door sedan travel W/B on E Chambers from N Richards St and park the vehicle facing W/B on the N/E side of E Chambers and N Palmer St directly next to the location. PO TERRELL then observed a B/M unknown subject exit the driver side of the Volkswagen in addition to one unknown B/M subject exit the front passenger side of the Volkswagen and two unknown B/M subjects exit the rear of the vehicle.

As the victim walked away from the white SUV S/B on N Palmer St towards his vehicle; PO TERRELL observed the unknown B/M driver of the Volkswagen run W/B on E Chambers towards the victim as he pointed a firearm directly towards the victim. The unknown driver of the Volkswagen discharged the firearm towards the victim fatally striking him multiple times. PO TERRELL then observed the driver of the Volkswagen run back E/B on E Chambers and enter into the driver side door. The front passenger of the Volkswagen was observed getting into an additional vehicle which was parked facing N/B on N

Palmer St on the east side of the street directly next to the location. The two rear passengers were observed walking on foot N/B on N Palmer St from E Chambers St as the black Volkswagen traveled N/B on N Palmer St at a high rate of speed.

End of summary.

PO TERRELL and I then conducted a license premise check of Chambers East Food Market, which is a licensed premise in the City of Milwaukee.

PO TERRELL spoke with the employees which were on scene, identified as *Amardeep SINGH (a/m, 12/26/90)* and *Fransisco A VALASQUEZ (h/m, 10/10/74)*. He also spoke with an assistant owner of the store, identified as *Kulwinder SINGH (a/m, 1/19/82)*. PO TERRELL and I asked Kulwinder if we could inspect his Class A License (# 0199371).

Kulwinder showed us his license, which also incorporates the store's food dealer's license, weights & measurements license and cigarette & tobacco license as well. The license was posted near the cash register area, on a wall available for inspection. The licenses are current and are set to expire on 04/21/22.

We conducted an overall check of the business, both first floor and basement, and did not find anything that was negative or bad.

INITIAL INVESTIGATION

This report is being written by PO Stephen COLWELL, assigned to District Five, Early Power Shift.

On Tuesday, November 29th, 2022, at 9:50 AM, I received a Facebook video link via email from the 6th Aldermanic District Office. The email described subjects in the video to be "smoking blunts, flashing gang signs, drinking, and flashing guns". This video was suspected of being recorded inside a licensed premise, located at 200 E Chambers St (Chambers Food Market), which is located within the City and County of Milwaukee.

This video was from a Facebook account by the name "Won Bmt East" and stated it was posted "3 Days Ago" when I viewed it on 11/29/22 at 7:00PM, which would indicate the video was posted on or around the date of 11/26/22. The only text accompanying this video were the words "I don't own right to music in background". This video was viewable to the public and not protected by any sort of privacy setting or permissions. This video was approximately 32 minutes in length.

Summary of Video:

This video starts only showing the face of one individual inside the Chambers Food Market. After several minutes, more subjects are observed congregating around the phone. After approximately four minutes, a black male subject, approximately 30 years old, wearing an orange shirt and black durag is seen with a black firearm in his hand. This subject in orange is observed dancing around with the firearm in his hand and at one point, points it directly at the camera. The barrel of the pistol can clearly be seen and it appears to have a large bored barrel, indicating it was not a BB gun. This subject in orange is also seen smoking what appears to be marijuana and is seen, several times, blowing large amounts of white colored smoke into the air. This subject is suspected to be smoking marijuana due to the brown blunt style wrapper appearing to be hand-rolled and non-symmetrical. Multiple subjects continue to dance to the music and making various statements into the camera. Shortly after the five minute mark, a male subject who appears to be an Indian male in his 30's, wearing a button up shirt, enters the frame and throws up hand signs making the letter "W" with hands directly towards the camera. For the remainder

of the video, the individuals seen continue to smoke what is suspected of being marijuana, drinking from individual cups and dancing to music. The subject in orange is seen holding up an open bottle of Remy Martin. During this video, multiple customers are seen coming and going, some of whom appear to be juveniles. A CD containing this publicly viewable video was inventoried as evidence under MPD Inventory #22043765. End of video summary.

On 11/29/22, at 4:00 PM, PO Keith GARLAND and I in Squad 5266, conducted a licensed premise check at 200 E Chambers St. We approached the location travelling eastbound on E Chambers St. As PO GARLAND parked our squad car on the 200 block of E Chambers St, a black Chrysler Town and Country Minivan bearing Wisconsin license plate AKG-2308 blew its car horn in three long and distinct honks. Shortly after this vehicle blew its horn, multiple subjects who were loitering outside the store, as well as some individuals inside the store began walk away from the entrance. PO GARLAND and I then entered the corner store and observed approximately 6-7 male subjects standing inside. I immediately recognized the interior of this store to be the same location I observed in the Facebook video. PO GARLAND and I both detected the odor of freshly burnt marijuana. One male subject was observed smoking a "black and mild" style cigar with a white mouth piece inside the store. Inside the cashier area, enclosed by bullet proof glass, were three subjects. One of these subjects inside the enclosed employee area was the male subject seen in the video wearing an orange t-shirt and black durag who was seen waving a gun. After this subject observed me in the customer area of the store, he very quickly exited the employee area and exited the front door and was not seen again. Several other subjects who were still inside the store when we entered quickly exited shortly after we arrived.

I then knocked on the door to the enclosed employee area and spoke to a male subject who identified himself to PO GARLAND as "Mineu Singh" with a date of birth 2/18/1985. "Mineu Singh" denied having any identification. "Mineu Singh" was later identified as Kulwinder SINGH (W/M, 1/19/1982, Bofl: 403329). I immediately recognized KULWINDER as the store employee I observed in the video throwing up "W" hand signs. KULWINDER appeared very anxious while I was speaking with him. KULWINDER stated he was the manager of the store but he did not own the property and he was not the licensing agent. I asked KULWINDER for contact numbers for the owner and licensing agent. I showed KULWINDER an image of the City of Milwaukee Property Tax Key for the location, which listed a "Kulwinder Singh, 1047 W Rosewood Trail, Oak Creek, WI 53154" as the legal owner. "Minue Singh" stated the property owner, Kulwinder Singh, was his cousin who lives in the unit above the store and provided me with a phone number of (414)263-1847 for the owner. KULWINDER stated the licensing agent, Davinderjit KAUR, was his sister and provided me a phone number of (414)306-0369 for her.

PO GARLAND asked KULWINDER who else was employed at the store. KULWINDER stated there was one other employee working and he directed PO GARLAND to the rear of the store where he made contact with a male subject behind a meat counter. This subject stated he was employed as a short line cook and identified himself as Sylvester NOLDEN (B/M, 5/20/1979), however this subjects name was later discovered to be Sylvester NICKELSON (B/M, 5/20/1979). NICKELSON was later discovered to have a Suspect Alert with the City of Milwaukee for a 2021 misdemeanor theft offense. I asked KULWINDER if the unknown black male subject who was in the employee area with him when we arrived was an employee of the store and he replied that this subject was not an employee. I asked KULWINDER why this subject was with him in the enclosed cashier area and he replied this subject was a friend of his and

he was just saying hello. During this licensed premise investigation I observed an unidentified black male subject, thin build, approximately 25 years old, who was behind the food counter with NICKELSON and appeared to be assisting with operations. I recognized this unknown subject as one of the individuals from the Facebook video.

I advised KULWINDER officers had reason to believe people had been smoking marijuana in his store and displaying guns. I advised KULWINDER these activities are not allowed to take place in the establishment and these activities may become relevant in regards to future regarding license renewal and he stated he understood. KULWINDER did not admit to these incidents occurring but also did not deny they occurred. PO GARLAND and I inspected the meat department of the store and located several clear plastic bags of chicken for display to the public with no type of labeling or expiration date. Through the display window of the meat department, I located multiple vacuum sealed hog head cheese which had expired in June of 2022. Officers also observed spring loaded mouse/rat traps in the grocery area of the store. I did locate several City of Milwaukee issued licenses displayed on the wall above the door of the enclosed cashier area.

PO GARLAND and I remained on scene for several minutes discussing our observations. PO GARLAND and I then reentered our squad car and began to return to District Five. As we were traveling westbound on E Chambers St, we passed the south window of the food market, where I observed that several subjects had reentered the store. I observed one of the patrons inside the store exhale a large plume of light colored smoke. PO GARLAND parked our squad car again and we entered the corner store where we again advised that individuals are not able to smoke inside.

After arriving back at District Five, I began to complete this licensed premise report. While authoring this report, I discovered no one by the name of Mineu Singh with a date of birth of 2/18/1985 could be located in the RMS system. I then conducted an RMS search of the phone number provided to me by Mineu Singh and I received a result of Kulwinder SINGH (W/M, 1/19/1982), which is the same name as the property owner. I immediately recognized Kulwinder Singh as the subject who identified himself to officers "Mineu Singh". I called KULWINDER at the phone number he provided me and he did answer. I informed KULWINDER I was the officer he had just spoken with and he stated he understood. I asked KULWINDER to spell his first name for me again, and he again spelled out MINEU. I again asked who the store owner was and he replied his cousin KULWINDER was the owner. I advised KULWINDER I located a photograph of him and I knew his name was not "Mineu" and that he had provided officers with an incorrect date of birth. KULWINDER then stated MINEU was his nickname and his cousin has a similar name to him "spelled with a P and not a D". I asked KULWINDER why he would provide officers conducting an investigation his nickname and he could not provide an answer. I asked KULWINDER why when I showed him the property tax key summary with his name on it, he repeatedly stated it was his cousin, and he again could not provide an answer. I called the phone number I was provided on scene for "KULWINDER" and it went directly to voicemail.

On Wednesday, November 30th, 2022, I conducted additional follow up at Chambers Food Market. (CAD: 223340728) I made contact with the clerk who identified himself as "Frank". I informed Frank I was attempting to observe surveillance video. Frank did not know the log in password for the surveillance systems and he contacted another employee who lives above the store. This other employee met me in

the cashier area and logged into the surveillance system. I viewed footage from an interior camera captured on 11/26/22 at 8:10 PM, which depicted all the subjects seen in the Facebook live video. All subjects, including KULWINDER, were seen on surveillance video wearing the same cloths as they were in the Facebook video. The surveillance video depicts the same activities observed in the Facebook live video. These subjects are observed from 8:10 PM until approximately 9:00 PM, which is when the store closes.

While attempting to view surveillance video, there was significant delays and complications when forwarding and reversing video. I attempted to recover this video to a jump drive but was unsuccessful.

While on scene, a customer, approximately 16 years, wearing a ski mask showing only eyes, approached the counter area and I observed Frank very subtlety shake his head left to right, as one would do to indicate "no". This customer then quickly walked away from the window and began to look at other items in the store before leaving without making a purchase. There were also multiple adults inside the store who wandered around but did not appear to be shopping.

KULWINDER was issued a citation (06823DG276) for allowing smoking in and enclosed place without a qualifying exception. (MCO 105-48-1) KULWINDER was also issued a citation (06823DG277) for Resist Obstruct. (MCO 105-138-2). I delivered these citations to KULWINDER in person on 11/30/22, along with PO Christopher SCHLEI in Squad 5264. When we first arrived, KULWINDER was not yet on scene. While we were waiting for KULWINDER, PO SCHLEI observed a large rat run across the floor of the store where grocery items are displayed. After KULWINDER arrived on scene, I explained the reason for him receiving citations. KULWINDER did admit to providing officers with false information and he provided me with his Wisconsin driver's license. KULWINDER stated he has been hesitant to call for police when he observes illegal behavior because he is fearful of the people who frequent his store. I did obtain a right index fingerprint from KULWINDER to be forwarded to digital imaging.

Chambers Food Market currently holds four licenses issued by the City of Milwaukee. (FOOD 12918, CIG 1030953, AMALT 199483, W&M 7214) The store hours are posted as 8:00 AM - 9:00 PM, seven days a week.

I also made a referral to the City of Milwaukee Health Department who stated they would be conducting a health inspection at the location in the very near future.

On Wednesday, January 11th, 2023, at 5:44 PM, PO Jocelyn Kalmanson, Squad 5264, and I conducted a Business Check at Chambers Food Market located at 200 E Chambers St, which is located within the City and County of Milwaukee.

Upon arrival we observed several subjects standing near vehicles which were parked on the public roadway near the store. As we arrived, one or more vehicles began to sound the horns of their vehicles. It should be noted, vehicles sounding their horns upon police arrival has been observed when conducting previous business checks at this location as well.

PO KALMANSON and I entered the store and made contact with the manager of Chamber Food Market, who is known to officers as Kulwinder SINGH (W/M, 1/19/1982). SINGH stated he has been more vigilant in calling for police when he observes subject loitering of using drugs. I was later able to locate three calls for service placed by SINGH. These calls were for Drug Dealing (CAD# 230012169), Trouble with Subject (CAD# 230021566), and Shoplifting (CAD# 230130903).

Unlike previous business checks at this location, I did not observed numerous subjects loitering inside the store. I also did not detect the odor of cigarette smoke or marijuana. The area inside and outside the store was relatively clean and free of garbage. The camera surveillance system appeared to be functioning.

I had learned from previous conversations with SINGH that the licensing agent for Chambers Food Market, Davinderjit KAUR (W/F, 1/28/1981), was not available to speak with officers because she was in India. SINGH confirmed that KAUR was still in India and not easily reached.

SINGH also informed me that he was in the process of purchasing a new store. SINGH stated this store was located at 1301 W Atkinson Ave (Stark Foods). SINGH stated he would be taking ownership of this store within the next month or two.

SINGH was complaint with the business check and was very willing to speak with officers.

On Monday, January 30th, 2023, at 6:08 PM, I conducted a Business Check at Chambers Food Market, located at 200 E Chambers St, City and County of Milwaukee.

Upon my arrival, I made contact with the manager, Kulwinder SINGH (W/M, 1/19/1982), who was inside the secured cashier area with another employee, Navgot SINGH (W/M, 1/12/1998). As I was speaking with KULWINDER, one of the customers exited the store and walked to a vehicle parked on the 3000 block of N Palmer St and opened the rear passenger door. KULWINDER then explained to me that this subject, later identified as Sharod A DOLL (B/M, 10/3/1979), is the subject who has been selling marijuana from his store. KULWINDER stated he has called the police multiple times to report this subject selling drugs but when police arrive, the subject leaves the store. I was later able to locate two calls for service where KULWINDER reported drug dealing at the store. (CAD's: 230012169, 230241367) The squads dispatched to these two assignments were unable to locate the subject when they arrived.

While I was speaking with KULWINDER in the cashier area, DOLL reentered the store and appeared to wander around. DOLL exited and entered the store approximately six times while I was on scene. I asked KULWINDER if he wanted this subject to leave the store and he replied that he did, but he was fearful this would upset DOLL. Eventually, KULWINDER requested I speak to DOLL about him loitering in the store. When I asked DOLL if he worked at the store he replied, "I use to work here". I then explained to DOLL the operator of the business did not want him remaining inside the store unless he was making a purchase. DOLL then stated he was ordering a pizza and relocated to the rear of the store. A short time later, KULWINDER exited the cashier area at which point DOLL began to repeatedly call KULWINDER a "bitch" and other profanities. KULWINDER then reentered the cashier area and eventually stated he

wanted DOLL trespassed from the location.

DOLL approached the counter and inquired whether it would be considered loitering if he remained in the store but continuously made purchases. I informed DOLL he had been trespassed by the business and requested he leave. DOLL remained agitated at which point, I requested an additional squad. DOLL exited the store and paced on the sidewalk in front of the store. I exited the store to obtain the license plate of the vehicle I observed DOLL in when I arrived. This vehicle was a white GMC Acadia bearing WI plate ARC-7430. This vehicle was later found to be registered to DOLL DOLL informed me he had "information" about the store and wanted to know how to report a complaint about the business. I informed DOLL he could call 286-CITY if he wanted to submit a complaint about the business operations. DOLL would ask me for this number a total of 5 to 6 times.

PO Deangelo REEL and PO Adrianna LAMACK in Squad 5220 arrived on scene to assist. DOLL entered his vehicle and left the location only to return less than a minute later. DOLL drove away from the location and immediately returned twice while we were on scene. DOLL began walking towards the store entrance again when PO REEL and I began to approach him. DOLL then stated he was walking to a friend's house and that he was not going back to the store.

A check later revealed DOLL to be on active supervision as a result of a drug dealing conviction in 2018. I spoke to DOLL's supervising agent (DOC Agent #32221) to inform her of my contact with him.

With the exception of DOLL, I did not observe any other subjects loitering inside the store at the time of this business check. I did not detect the odor of marijuana or cigarettes. The interior and exterior of the business were clean and free of garbage or other debris. KULWINDER was cooperative throughout my contact with him. I encouraged KULWINDER to continue calling police when he observes illegal activity or subjects who continuously loiter.

On Wednesday, February 1st, 2023, at approximately 7:45 PM, PO Nicholas SANDOVAL and I, while assigned to squad 5463, conducted a business check of the East Chambers Food Market, located at 200 East Chambers Street. This is in the City and County of Milwaukee. We were operating car #535, which is a marked black and white Ford Explorer, equipped with 360-degree emergency lighting, audible siren, and audio/video recording equipment. We were wearing standard Milwaukee Police Department uniforms with badges and name tags visible on our outer most garments, and utilizing our department issued Body Worn Cameras (BWC).

Upon arrival at the location, PO SANDOVAL and I observed numerous running and occupied vehicle parked on both North Palmer Street and East Chambers Street, in close proximity to the East Chambers Food Market. Prior to entering the business, PO SANDOVAL patrolled up and down the 3000 block of North Palmer Street two times in our marked City of Milwaukee squad car. During this brief patrol, PO SANDOVAL and I observed that a majority of the vehicles parked outside of the business left the location upon police arrival.
