2. <u>041157</u> A substitute ordinance relating to policy for acceptance of grants for additional law enforcement services.

Whereas, Large facilities open to the public owned or operated by tax-exempt public or quasi-public entities ("public venues") often require additional law enforcement services in order to meet the needs of public safety and convenience; and

Whereas, The entities operating those public venues are often exempt from general property taxation and therefore, absent voluntary agreements, would not have to pay for the provision of such law enforcement services; and

Whereas, Grants from entities that operate facilities which present unique security needs occasioning the need for additional police services will enable the police department to address the security needs of these entities, thereby enhancing the safety and security not only of the entities, but also that of the surrounding areas and the Milwaukee community in general; and

Whereas, Grants from alcohol beverage establishments licensed by the city will also enable the police department to address the security needs of these establishments, thereby enhancing the safety and security not only of the establishments, but also that of surrounding areas; and

Whereas, These grants from entities qualifying under these criteria will be in the public interest because the grants will enable the police department to assign additional personnel to those public venues and areas and thereby enhance public safety and convenience as well as relieve the general city property tax- payers from funding the cost of the additional law enforcement services provided to entities operating the public venues; and

Whereas, The Common Council believes that criteria for acceptance of grants from public or quasi-public entities and other entities that seek to enhance public safety and convenience, to fund law enforcement services currently provided in Resolutions File Number 011573, 021317 and 040746, as well as the other criteria that are added by this ordinance need to be codified; now, therefore

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 304-83 of the code is created to read:

304-83. Additional Grants for Law Enforcement Services.

- 1. ACCEPTANCE. The police department may receive grant funds for additional law enforcement services from entities that meet the criteria specified in sub. 2.
- 2. CRITERIA. a. The entity providing the grant to the police department for additional police services must receive the approval of the police chief for the nature and amount of police services to be funded by the grant and meet all of the following criteria:
- a-1. The entity is a tax-exempt public or quasi-public entity.
- a-2. The entity owns or operates a large public venue open to the public.
- a-3. The operations of the entity occasion the need for additional police services in areas adjacent to a public venue that the entity owns or operates.
- b. In lieu of the criteria specified in par. a, grants may also be received from entities that meet either one of the following criteria:
- b-1. The entity owns or operates facilities that present unique security needs occasioning the need for additional police services.
- b-2. The entity is an alcohol beverage establishment licensed by the city and seeks to enhance public safety.
- c. Officers shall be assigned to alcohol beverage establishments pursuant to par. b-2 on a voluntary basls.
- 3. COMMON COUNCIL APPROVAL. The common council may by resolution approve any law enforcement grant agreement that has been approved by the police chief and that meets the criteria specified in sub. 2.

5. <u>070875</u> Resolution authorizing the acceptance and expenditure of up to \$650,000 in private contributions for the purpose of training members of the Milwaukee Fire Department and purchasing various supplies for the Safe Schools/Healthy Students Initiative, Project Staying Alive program.

Whereas, Section 304-24 of the Milwaukee Code of Ordinances regulates the receipt, appropriation and expenditures of contributions received by the City; and

Whereas, On November 6, 2001, the Common Council adopted Resolution 010844 amending Resolution 970233 and further amending Resolution 941142 to allow the Fire Department to increase the amount of private contributions to \$250,000 from the \$75,000 authorized initially for the purpose of maintaining the special teams training programs; and

Whereas, On June 23, 2003, the Common Council adopted Resolution 030267, authorizing the Milwaukee Fire Department to accept up to \$400,000 in private contributions for fire safety education; and

Whereas, The Milwaukee Fire Department frequently receives inquiries from citizens, foundations or other entities regarding donating funds for the purchase of fire suppression, emergency medical services or other equipment and training; and

Whereas, Children's Hospital of Wisconsin wishes to contribute up to \$3,148.00 to the Milwaukee Fire Department for firefighter training and supplies related to the Safe Schools/Healthy Students Initiative, Project Survive Alive program; and

Whereas, Milwaukee Public Schools wishes to contribute up to \$175,000 to the

Milwaukee Fire Department for firefighter training and supplies related to the Safe Schools/Healthy Students Initiative, Project Staying Alive program; now, therefore be it

Resolved, By the Common Council of the City of Milwaukee, that the Milwaukee Fire Department is authorized to accept up to \$650,000 in private contributions for firefighter training programs and supplies for the Safe Schools/Healthy Students Initiative, Project Staying Alive program, but no more than the amount actually received, in accordance with established City policies; and, be it

Further Resolved, That upon receipt and deposit of these funds, the City Comptroller is directed to establish a special account within the Milwaukee Fire Department budget for the expenditure of the funds; and, be it

Further Resolved, That the City Comptroller is authorized and directed to transfer appropriations and estimated revenue from the Special Purpose Account-Contributions, account number 0001-2110-0001-0001-006300, and the Estimated Revenue Account for Contributions, account number 0001-9990-0001-009850 to the Fire Department special account 001-3280-0001-Dxxx-006800, and the Fire Department estimated revenue account 0001-3280-0001-009850, up to the amount of \$650,000.

Whereas, To implement the Annex 2001 agreements, on December 13, 2005, the governors and premiers of these jurisdictions signed the Great Lakes - St. Lawrence River Basin Sustainable Water Resources Agreement and endorsed the Great Lakes - St. Lawrence River Basin Water Resources Compact, collectively known as the Great Lakes Charter Annex Implementing Agreements; and

Whereas, The agreements recognize that the waters of the River Basin are a shared public treasure and that the states and provinces as stewards have a shared duty to protect, conserve, manage and maintain the integrity of the River Basin and its ecosystem, and set a common standard for decisions about proposed water uses; and

Whereas, The agreements are not binding on states or provinces, but rather provide a framework for each state and province to pass laws that will protect the Great Lakes' St. Lawrence River Basin; and in the U.S., each of the 8 states will enact into law and enforce the agreements through an interstate compact, and the United States Congress will be asked to ratify the compact; and

Whereas, There have been discussions between the City of Milwaukee and neighboring jurisdictions relating to selling water to areas outside the Great Lakes basin, and City of Milwaukee policies relative to these discussions should be consistent with standards adopted by the Council of Great Lakes Governors that will ensure a uniform policy throughout the Great Lakes region; and

Whereas, Consistent and uniform standards will ensure the least amount of impact on the City's environmental and economic health, and ensure that the Great Lakes region and its ecosystems are not irreparably damaged; and

Whereas, The City of Milwaukee's current position concerning the sale of water to areas outside the Great Lakes basin should be to take no action until the state of Wisconsin enacts into law and enforces the agreements with an interstate compact; and

Whereas, Once the state of Wisconsin ratifies the compact, the City of Milwaukee may enter into agreements for the sale of water to neighboring communities outside the Great Lakes basin with confidence that its agreements are consistent with the health and economic vitality of the Great Lakes ecosystem, the intentions of the Council of Great Lakes Governors and the Great Lakes Charter Annex Implementing Agreements; now, therefore, be it
