***Re: Renewal Application of Steven P. Zolman, as Agent for a
Private Alarm System Business renewal application for
Pinnacle Security, LLC ("Pinnacle")***

The members of the Milwaukee Common Council have asked Pinnacle to address the concerns outlined by the City's Public Safety Committee (the "Committee") in its memorandum to the Council dated January 3, 2008 (the "Report"). Council members have also requested that Pinnacle offer a Corrective Plan of Action that will resolve these concerns. This memorandum seeks to offer a positive, productive response to the Council's concerns, and desires that the Committee renew Pinnacle's application. Please note that this Memorandum addresses these issues as follows:

I. Background.

Pinnacle is a nationwide reseller of alarm services and equipment. Pinnacle commenced operations in 2002 and is based in Orem, Utah. Pinnacle has served tens of thousands of satisfied customers across the country. Sometimes Pinnacle retains ownership of its customer contracts and sometimes such contracts are sold to monitoring companies, such as ADT or SAI (as defined below) as permitted in the customer contract. Pinnacle contracts with Security Associates International, Inc., a Delaware corporation ("SAI") located at 2101 South Arlington Heights Road, Arlington Heights, Illinois 60005, to provide monitoring services to Pinnacle's customers. SAI is a nationally recognized provider of monitoring services and commenced operations in 1986. Additionally, in Milwaukee, SAI causes first-response patrol services to contact Pinnacle's customers as required by law ("Patrol").

When Pinnacle's alarm equipment is activated, an SAI dispatcher immediately responds by calling the location and verifying whether an actual or attempted crime is taking place. If the SAI dispatcher cannot verify that an actual or attempted crime is taking place, then the dispatcher notifies Patrol. Then, Patrol physically visits the location to verify that an actual or attempted crime is taking place. Upon verification, if any, Patrol will alert the City's Police Department. However, in the event that SAI verifies that an actual or attempted crime is taking place upon the initial communication to SAI, then SAI may contact the City's Police Department regarding such communication as verified. Lastly, in cases of fire, the SAI dispatcher will immediately alert the City's Fire Department without Patrol's participation in the process.

Pinnacle has approximately 954 customers in the City of Milwaukee. From June 8, 2007, to January 5, 2008, SAI dispatched Patrol personnel approximately 639 times to respond to incidents at Milwaukee locations. During these instances, Patrol personnel physically visited the location and verified that further assistance from the City's Police Department was unnecessary. Pinnacle and SAI have worked closely to bring a high level of service to Pinnacle's Milwaukee customers.

II. Corrective Plan of Action.

a. *Unverified Alarm Calls:*

i. Issue: As the Committee described in Section 5(B) of the Report's Findings of Facts, Pinnacle received fifteen citations between May 2, 2007, and August 9, 2007, for unverified alarm calls to the City's Police Department. Copies of such citations and evidence of full payment by Pinnacle of such citations are attached hereto as Tab 1. Section 5(C) of the Report's Findings of Facts also accurately describes that 125 unverified calls were made from Pinnacle's equipment between May 2, 2007, and December 22, 2007, however certain of these were from the same residence. Unfortunately, after reviewing customer records, Pinnacle has discovered that its database incorrectly listed the Police Department as the first-response phone number for ninety-eight of its customers (the "98 Customers"). The 140 unverified alarm calls

originated from these 98 Customers. Pinnacle believes that these calls were the result of human error.

ii. Response: Pinnacle endeavors to provide the best possible service to its customers and understands that this requires non-wasteful communications and coordination with the City's Police Department. The number of these unverified alarm calls is unacceptable to Pinnacle. Unfortunately, Pinnacle believes that miscommunication and confusion caused these calls.

Pinnacle's service database includes a first-response phone number for each of Pinnacle's customers. Once Patrol verifies that an actual or attempted crime has taken place at the location, Patrol should alert the City's Police Department. The Police Department should therefore be listed as the second-response phone number for each of Pinnacle's Milwaukee customers.

In early 2007, Pinnacle terminated its initial monitoring relationship with ADT Security Systems, Inc., a Delaware corporation ("ADT"), and began working with SAI. During Pinnacle's relationship with ADT, ADT took responsibility for entering in the first- and second-response phone numbers in our service database. When Pinnacle began working with SAI, however, Pinnacle and SAI jointly took on this responsibility. This transition and change in operating procedures caused some confusion and miscommunication among Pinnacle's staff members. As a result of this confusion, Pinnacle's service database incorrectly listed the City's Police Department as the first-response phone number for ninety-eight of its customers. These mistakes resulted in a high number of wasteful calls to the Police Department.

iii. Plan: After discovering the cause of the problem, Pinnacle has corrected these incorrect entries in its service database and properly listed SAI and its Patrol as the first-response phone number for Pinnacle's Milwaukee customers. Pinnacle's staff members have received additional training with respect to this issue and have received a memorandum describing the proper database entry procedures for Pinnacle's Milwaukee customers. A copy of this memorandum is attached hereto as Tab 2.

Importantly, Pinnacle and SAI have implemented weekly audit procedures whereby each of Pinnacle and SAI will independently review and audit Pinnacle's service database to ensure that the City's Police Department is properly listed as the second-response phone number for each of Pinnacle's Milwaukee customers. Pinnacle believes that this weekly audit by each of Pinnacle and SAI should help significantly in preventing the recurrence of this type of human error.

b. Compensation to 98 Customers

In order to compensate the 98 Customers who were affected by these unverified alarm calls and thus received poor service, Pinnacle will offer each of these customers a one-month credit (usually \$39.99) for each month during which an unverified alarm call

originated from such customer's location. Pinnacle believes that this solution reflects Pinnacle's commitment to providing the highest quality service to its customers. Such compensation will be offered prior to February 1, 2008.

Finally, Pinnacle has paid the fifteen citations, and according to Officer Ann McCarthy ("McCarthy") of the City's Police Department, Pinnacle has no unpaid outstanding citations as of January 8, 2008.

c. Panic Alarms.

i. Issue: Section 5(E) of the Report's Findings of Facts accurately states that Pinnacle has installed "panic alarms" in some of our customer's homes. These panic alarms are illegal in the City of Milwaukee.

ii. Response: Because Pinnacle is a nationwide company, it is sometimes difficult for Pinnacle to keep apprised of each statute and regulation enacted by the many states and municipalities Pinnacle serves. Unfortunately, Pinnacle was unaware of the City's prohibition against panic alarms when it sold and installed such alarms. Neither Pinnacle nor its sales representatives knowingly violated this prohibition.

iii. Plan: Pinnacle has rerouted these panic alarms to alert SAI, who will then contact Patrol if necessary. Because of these changes, none of the panic alarms presently installed in Pinnacle's Milwaukee customers' locations will directly alert the City's Police Department when activated. In cases of fire, the panic alarms will notify SAI, who will then alert the City's Fire Department.

Additionally, Pinnacle has instructed its Milwaukee-based sales representatives to inform customers that these panic alarms will not directly alert the Police Department. Sales representatives should instead advise customers that the activation of these panic alarms will commence Pinnacle's normal response procedures.

d. Department of Agriculture Trade and Consumer Protection Division Warnings.

i. Issue: Section 5(E) of the Report's Findings of Facts accurately describes three warnings Pinnacle received from the Wisconsin Department of Agriculture in connection with alleged deceptive marketing and advertising practices. Section 5(C) also describes certain inaccurate and aggressive marketing tactics allegedly employed by Pinnacle's sales representatives.

ii. Response: Pinnacle resolved each of the three complaints to the customer's satisfaction. Importantly, Pinnacle resolved these complaints prior to receiving the Division's warnings, which is consistent with Pinnacle's commitment to excellent service and fair business dealings. None of these three complaints are currently open or active to Pinnacle's knowledge; there is no current or pending litigation concerning such three complaints to Pinnacle's knowledge.

1. Nicole Mueller: After the installation of alarm equipment, Pinnacle offers its customers the option of a one or two-week "test period" during which the equipment will not be operational. Pinnacle has discovered that some of its customers prefer this test period option, as some customers will inadvertently activate the alarm equipment several times as they become acquainted with the equipment. Ms. Mueller selected this test period option. Unfortunately, an actual burglary took place at Ms. Mueller's home during this test period. Because the equipment was not operational during the test period, the equipment did not alert authorities with respect to the burglary.

Ms. Mueller was upset about this turn of events. Although Pinnacle believes it notified Ms. Mueller and she accepted such test option, in order to resolve this situation, Pinnacle offered a three-part solution in September 2007: (i) Pinnacle compensated Ms. Mueller for the personal property that was stolen during the burglary (approximately \$675.00); (ii) Pinnacle allowed Ms. Mueller to terminate her three-year service contract with Pinnacle; and (iii) Pinnacle permitted Ms. Mueller to keep the alarm equipment installed by Pinnacle free of charge.

2. Constance Janikowski: Ms. Janikowski was dissatisfied with Pinnacle's service because she preferred to be billed on a quarterly basis rather than on a monthly basis. She was also dissatisfied with Pinnacle's first-responder service to verify alarms. To resolve Ms. Janikowski's concerns, in October 2007 Pinnacle refunded to her the approximate amount of \$123.00. Pinnacle also allowed Ms. Janikowski to terminate her three-year service contract with Pinnacle and permitted her to keep the alarm equipment installed by Pinnacle free of charge.

3. Andrew Pendleton: Mr. Pendleton was dissatisfied with Pinnacle's service. To resolve Mr. Pendleton's concerns, in April 2007 Pinnacle allowed him to terminate his three-year service contract with Pinnacle.

iii. Plan: Pinnacle provides extensive training to its sales representatives about proper and improper sales tactics. Specifically, Pinnacle has trained its Milwaukee sales representatives that they should not represent that the City's Police Department will immediately respond to an alarm call. Instead, Pinnacle's sales representatives must represent that SAI and Patrol will respond first to verify that an actual or attempted crime has taken place. Pinnacle has distributed a memorandum outlining these policies to its Milwaukee-based sales representative, a copy of which is attached hereto as Tab 3.

Pinnacle also employs a strict punishment system for violations of its policies. If Pinnacle learns that one of its sales representatives has committed a conduct violation, Pinnacle may levy a fine of \$500.00 or \$1,000.00. In serious cases, sales representatives are terminated.

Finally, if a Pinnacle customer complains of being subjected to improper sales tactics, Pinnacle strives to satisfactorily resolve that customer's concerns as Pinnacle did in the three cases described above.

e. *Lines of Communication.*

i. Issue: The Council has informed Pinnacle McCarthy has been dissatisfied in trying to communicate with both Pinnacle and SAI and trying to resolve her concerns.

ii. Response: Pinnacle seeks to maintain positive communication and coordination with the police in each of the areas that Pinnacle serves. This breakdown in communication is unacceptable to Pinnacle.

iii. Plan: Pinnacle suggests that rather than contacting SAI, McCarthy contact Pinnacle's General Counsel, John R. Barlow, directly to resolve issues arising from unverified alarm calls and related incidents. Mr. Barlow will seek to resolve McCarthy's concerns in an expeditious and positive manner. In addition, Clint Cushing, Pinnacle's local regional manager in Milwaukee will regularly contact McCarthy, especially during the summer months, to confirm that any outstanding issues concerning Pinnacle have been resolved to McCarthy's satisfaction.

III. Conclusion.

Pinnacle is committed to providing its customers with excellent service. Pinnacle has diligently and sincerely sought to respond to the concerns of the Council and Pinnacle's Milwaukee customers. Pinnacle looks forward to implementing the Corrective Plan of Action outlined in this memorandum. Pinnacle appreciates the Council's consideration of Pinnacle's license renewal application and respectfully requests that this application be granted.

SALES TACTICS MEMORANDUM

TO: All Milwaukee-Area Sales Representatives

Re: Sales Tactics

This memorandum serves as a reminder of Pinnacle's policies. Pinnacle has recently been informed by Milwaukee authorities that several of Pinnacle's sales representatives have engaged in misleading and deceptive sales practices with area residents. This is unacceptable to Pinnacle.

I. Fair and Honest Sales Practices.

As more fully set forth in the Employee Handbook you have received, and as I and other Pinnacle representatives have explained in previous training sessions, Pinnacle requires that each of its sales representatives engage in fair and honest sales practices. Sales representatives should never mislead consumers, misrepresent Pinnacle's products or services, or engage in aggressive or intimidating sales practices. Pinnacle is committed to providing its customers with the highest level of service. The service provided by sales representatives should reflect this commitment.

II. Products and Services.

When presenting Pinnacle's products and services to consumers, sales representatives should be careful not to make misleading or deceptive representations. It is important that sales representatives accurately describe how Pinnacle's equipment helps to protect customers. When Pinnacle's alarm equipment is activated, an SAI dispatcher immediately responds by calling the location and verifying whether an actual or attempted crime is taking place. If the SAI dispatcher cannot verify that an actual or attempted crime is taking place, then the dispatcher notifies Patrol. Then, Patrol physically visits the location to verify that an actual or attempted crime is taking place. Upon verification, if any, Patrol will alert the City's Police Department. However, in the event that SAI verifies that an actual or attempted crime is taking place upon the initial communication to SAI, then SAI may contact the City's Police Department regarding such communication as verified. Lastly, in cases of fire, the SAI dispatcher will immediately alert the City's Fire Department without Patrol's participation in the process.

Sales representatives should not represent that Pinnacle's alarm equipment will immediately alert police or fire authorities. Instead, police and fire authorities will be

alerted after a verification process has been completed. Sales representatives should make no representations to the contrary.

III. Panic Alarms.

Pinnacle offers several "panic alarm" options to its customers at no extra cost. Milwaukee has prohibited the sale and use of panic alarms that directly alert police and fire authorities. As a result, the panic alarm options sold in Milwaukee will not offer this function. Instead, when customers activate the panic alarm, the verification and response process described above will commence. Sales representatives should inform customers of this fact and should not make any misrepresentations about the features of the panic alarms.

IV. Consequences.

Pinnacle employs a strict punishment system for policy violations. As described to you previously, if Pinnacle learns that a sales representative has committed a conduct violation, then Pinnacle reserves the right to terminate you and/or levy a fine of \$500.00, \$1,000.00, or greater. Pinnacle is committed to serving its customers fairly and honestly, and will not tolerate sales practices that violate this commitment.

V. Conclusion.

You will continue to receive regular training on Pinnacle's policies from me and other Pinnacle representatives. Please contact me if you have any questions or concerns about Pinnacle's policies.
