We return the enclosed document which has been filed with the City Clerk and ask that it be introduced and referred to the Committee on Judiciary & Legislation with the following recommendation.

Claimants, John and Amy L. Sanheim, 3319 South 75th Street, Milwaukee, WI 53219 allege on their own and also through their former attorney, Habush, Habush & Rottier, S.C, Firstar Center Suite 2300, 777 East Wisconsin Avenue, Milwaukee, WI 53202-5381 that on July 28, 2005 she sustained injuries when she tripped and fell at a location where level sidewalk adjoins a sloping ramp in the vicinity of Water Street and Mason Street. They claim damages in the amount of \$59,573.28.

Decisions concerning the adoption, design, and implementation of a public works system are discretionary, legislative decisions for which municipalities enjoy immunity. MMSD v. City of Milwaukee 2005 WI 8, ¶ 9. As such, the City of Milwaukee is not liable. Therefore, we recommend that this claim be denied.
