## Replace the existing roof with new slate roof for house and garage.

Set Scaffold for the full perimeter of the house and garage. Remove and dispose of the existing slate roof. Install new Sharkskin Ultra SA ice and water shield underlayment at the bottom 6' and in the valleys. Install Sharkskin Ultra underlayment for the rest of the roof areas. Install new 18" x random semi-weathering gray green slate. Slate shall be standard smooth thickness. Slate will have saddle ridges and hips. Slate shall be installed at all dormer sides. New copper flashings will be installed at the valleys, chimneys, dormer sides, and flat roof walls and perimeter edges. New copper gutters and downspouts shall be installed at the garage. All seams in copper will be soldered. New EPDM rubber shall be installed at the flat roof at the front porch and at the W. side porch. Existing gutters and downspouts on the house shall remain. Dismantle scaffold.
