There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCQ 85-2.7-4, probative evidence concerning whether or not a new license should be granted may be presented on the following subjects: whether or not the applicant meets the municipal requirements, the appropriateness of the location and premises where the licensed premises is to be located and whether use of the premises for the purposes or activities permitted by the license would tend to facilitate a public or private nuisance or create undesirable neighborhood problems such as disorderly patrons, unreasonably loud noise, litter, and excessive traffic and parking congestion. Probative evidence relating to these matters may be taken from the plan of operation submitted with the license application, if any, but shall not include the content of any music. Evidence regarding the fitness of the location of the premises to be maintained as the principal place of business, including but not limited to whether there is an overconcentration of businesses of the type for which the license is sought; whether the proposal is consistent with any pertinent neighborhood business or development plans, or the location's proximity to areas where children are typically present. The applicant's record in operating similarly licensed premises; and whether or not the applicant has been charged with or convicted of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the activity to be permitted by the license being applied for or any other factor which reasonably relates to the public health, safety or welfare may also be considered. See attached police report or correspondence.

Notice for applicants with warrants or unpaid fines:

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

Limited parking for persons attending meetings during normal business hours is available at reduced rates (5 hour limit) at the Milwaukee Center on the southwest corner of Kilbourn Avenue and Water Street. You must present a copy of the meeting notice to the parking cashier.

I am objecting to the license for Parrilla Mixe Mexican Restaurant located at 4952 w forest home avenue Milwaukee wi 53219.

They are what it seems to be, doing some inside construction work to the business. They have been using loud heavy machinery outside after 9pm for almost a week. The works have been asked to stop, but don't understand the English language.

They have been having music blasting with heavy base, coming from a truck stereo system that vibrates in my house across the street that goes on all day long.

I can't even (and let the in because the music is so loud.

They don't seem to have any concern or care for the noise they are creating for the neighbors and people in this community who live here. It's disrespectful to the community

Please do something about this, it would be much appreciated if they were just a little quieter.

Is my timeline correct? **No**

3/27 Applicant schedules an appointment with the LI to submit a new application

LI notified 4/15 Faviola is asked if there are new owners or an application on file. She responds that nothing is filed. She is then asked to refer the business the Health Department. A referral should have been made at that. That did not happen.

4/28 LI receives new Class B, Food Dealer and Public Entertainment Premises applications listing an opening date of June 1, 2025. The application claims the current licensee is operating

Assigned to MHD 4/24 **New Application for Taqueria Parilla Mixe, LLC. entered into Licensing's LIRA database 4/28 and queued to MHD for internal application entry into our inspection system. MHD received and added a hold for preinspection and assigned to the Coordinator for preinspection 4/28-same day. At this point we wait for the operator to reach out and schedule their inspections which they are directed to do so from licensing. We are queued new applications essentially daily to be entered into MHD's system. It is not uncommon for a new application to come in for a place with an existing license. We have not received any communication at this time that they are ready to schedule their preinspection.**

MHD and LI meeting to approve 7 day intent 4/30. **MHD and Licensing have reoccurring interdepartmental meetings. Our most recent meeting was on 4/30. We discussed some previous scenarios where there is a change of hand in business occurring and how to seek clarification on who is the current responsible agent. There was no connection to this establishment in that conversation at all.**

Alder site visit 5/3- open, no licensee on premises, operator advised to contact the licensing division ASAP on Monday morning

MHD DNS visit closed 5/5 **MHD was made aware of the concern that the business was operating without a current license 5/5 after receiving a call from DNS Supervisor Jumanne Cheatham. Our inspector went out within 30 minutes of receiving the call only to find the business was closed and had a sign posted apologizing for the inconvenience but they were closed until further notice. Further notes on this below**

5/5 Unknown LI employee tells them they can reopen **She spoke to Carmen. Additionally, Maricela said Carmen told her to go speak with President Perez and let him know how she was being treated and what was going on with her licenses.** LI does not advise applicants to speak with alders regarding license matters in another alder's district. I questioned Carmen about the conversation. She said that Maricela Antunez Jiminez and another person, Maritza?, who was at the bar during the alder visit but is not on the application was adamant about speaking to an alder's supervisor and provided the contact info for the president's office. Maricela Antunez Jimenez and her partner Jorge Vasquez Ruiz are residents of the 12th district.

5/6 Applicant / operator lies to inspector Hertzog that previous owner is staying on currently to help run the business

5/6 MHD reports that the previous owner is overseas and unavailable. **This is correct however please note the agent does not need to be present at the business in order for the business to be open. We have many agents that rarely set foot inside the business.**

5/6 MHD allows the business to reopen pending 7 day notice of intent (that was decided on 4/30?)

MHD issued an Intent to Cease operations on 5/6 when we were able to make contact with the business and gave them 7 days to demonstrate via confirmation from the listed agent George T that Brass Key is still the business in operation and he is still the responsible party.

As standard practice, when do you notify the Alders office that their complaint is being acted upon?

**We did not receive a complaint from the alders office directly. We received a call from DNS Supervisor Cheathum at 9:58am on 5/5. He then forwarded the email string that we were not previously on at 10:02am to CEH Manager Castillo. As noted above our inspector went out within 30 minutes to find the facility closed. On 5/5 at 11:38am DNS Supervisor Cheathum responded to the email thread updating you on both DNS and MHD's current findings and that we would continue to monitor to find out who the responsible party was. Had the facility been open we would have issued the intent that day.

What is an inspectors timeframe to issue a 7 day intent notice and when does that get communicated to the Alders office?

As noted above- we would have issued the intent on 5/5 had the facility been open. We issued the intent 5/6. It is not departmental practice to notify alders of Intents or Orders to Cease. We notify MPD, licensing, DATCP and our internal program team.

MHD has been more than responsive from the moment they were made aware of your complaint.

As you can see in this email chain, a message from Jim Cooney from 5/6 at 4:26 PM, states the following:

"I got out over my skis a bit. Past practice is for the health department to issue an intent to close rather than an order to close and provide a week for the business to provide documentation of ownership. Cc-ing Sgt. Velasquez as it very possible that this business is operating under someone else's license."

The 7-day intent-to-close was agreed upon in a collaborative meeting on April 30th, which included MHD, Jim Cooney, and others. For added context, this enforcement process is specifically for these scenarios where the business is in transition and it is unclear who is the responsible party. This can happen when we are going by word-of-mouth and not directly from the agent on file. This 7-day intent-to-close process needs to be applied universally, not selectively.

Additionally, it isn't the responsibility of MHD to verify the agent on file is the current responsible party. This documentation is submitted to the licensing division, which has the responsibility to vet it. MHD acts as boots on the ground to deliver the intent-to-cease and order-to-cease.

Ultimately, MHD's order-to-cessate will be based on final determination from licensing and the paperwork received or not from the agent on file.

TSAOUSIS (collectively, "Seller"), MARICELA ANTUNEZ JIMENEZ ("Jimenez") and JORGE VAZQUEZ RUIZ ("Ruiz") (Jimenez and Ruiz each a "Buyer" and collectively, the "Buyers"), and T.C.K. OF MILWAUKEE, INC., Wisconsin corporation ("Company").

RECITALS:

A. Seller is the record owner of twenty (20) shares of stock ("Purchased Stock") in the Company.

B. The Company is in the business of owning and operating a restaurant known as "Brass Key Restaurant" ("Business").

C. Seller sold the real estate located at 4952 W Forest Home Ave, Milwaukee, WI 53219 ("Property") to Buyers effective as of December 16, 2024 pursuant to that certain Offer to Purchase by and between Buyer and Seller dated November 23, 2024 and executed on November 24, 2024 ("Offer to Purchase").

D. Pursuant to that Amendment to Offer to Purchase by and between Seller and Buyer dated December 12, 2024, Seller agreed to sell to Buyers and Buyers agreed to purchase from Seller the Purchased Stock.

E. The parties deem it to be in their best interests for Buyers to purchase from Seller, and Seller to sell to Buyers, the Purchased Stock on the terms and conditions set forth herein.

NOW, THEREFORE, in consideration of the recitals and the mutual promises set forth in this Agreement, the parties hereto agree as follows:

1. Purchase and Sale of Shares. Effective as of December 16, 2024, Seller agrees to sell to the respective Buyer and the respective Buyer agrees to purchase from Seller the Purchased Stock, which constitutes all of the Seller's ownership interests in the Company as follows:

- A. To Jimenez, ten (10) shares of stock of the Company..
- B. To Ruiz, a ten (10) shares of stock in the Company.

2. Allocation of Purchase Price. The Buyers and Seller hereby agree that the aggregate purchase price for the Property and the Purchased Stock of Seven Hundred Thousand and No/100 Dollars (\$700,000.00) shall be allocated as follows:

- A. Property: \$550,000.00
- B. Purchased Stock: 150,000.00

3. Closing. Subject to the terms and conditions set forth in this Agreement, the consummation of the transactions contemplated by this Agreement ("Closing") occurred simultaneously with the Closing of the sale of the Property on December 16, 2024. The parties have agreed to enter into this Agreement in order to memorialize the purchase and transfer of the Purchased Stock. Seller acknowledges and agrees that the purchase price for the Purchased Stock set forth in Section 2, above, was paid to Seller by Buyers on December 16, 2024.

4. Deliveries by Seller. The Seller shall make the following deliveries to the Buyers at Closing, in a form acceptable to Buyers and Seller (each to be properly executed, or certified, as appropriate, dated and completed):

- A. The stock powers in the form attached hereto as Exhibit A and Exhibit B transferring the Purchased Stock to each respective Buyer.
- B. The original stock certificates representing the Purchased Stock.
- C. Seller's resignation as a member, manager and officer of the Company.
- D. The books and records of the Company in Seller's possession.
- E. Any remaining property of the Company in Seller's possession.
- F. Such other documents and showings as shall reasonably be requested by Buyers.

5. Representations and Warranties of Seller. As an inducement to the execution of this Agreement by Buyers and to the fulfillment of the provisions hereof to be performed by Buyers, Seller, covenants, represents and warrants to Buyer, that as of the date of this Agreement and as of the date of Closing, as follows:

A. Authority. Seller has full legal capacity, power and authority to enter into and perform this Agreement and this Agreement constitutes the valid and legally binding obligation of Seller enforceable in accordance with its terms.

B. Title. Seller is the registered holder of, and the owner of good title to, all of the Purchased Stock to be sold by Seller hereunder, free and clear of any liens, claims, charges, encumbrances, equities or options whatsoever and the Purchased Stock represents all of

Seller's ownership interests in Company. All of the Purchased Stock to be sold by Seller hereunder may be validly assigned, transferred and delivered by Seller as herein provided. The Purchased Stock represents Seller's entire interest in the Company.

C. No Conflicts; Consents. The consummation of the transactions contemplated by this Agreement by Seller do not and will not: (i) result in a violation or breach of any provision of the organizational documents of the Company; (ii) result in a violation or breach of any provisions of any law or governmental order applicable to Seller or Company; or (iii) require the consent, notice or other action by any person or entity under, conflict with, result in a violation or breach of, or constitute a default under any agreement to which Seller is a party, except in the cases of clause (ii) and (iii), where the violation, breach, conflict, default or failure to give notice or obtain consent would not have a material adverse effect on the Seller's ability to consummate the transactions contemplated hereby.

D. Disclosure. The Seller does not have knowledge of any fact or circumstance that has specific application to the Seller (other than general economic or industry conditions) that may adversely affect the assets, business, prospects or financial condition or results of operation of the Company.

6. Representations, Warranties and Covenants of Buyers. As an inducement to the execution of this Agreement by Seller and to the fulfillment of the provisions hereof to be performed by Seller, Buyers, covenant, represent and warrant to Seller, that as of the date of this Agreement and as of the date of Closing, as follows:

A. Authority. Buyers have full legal capacity, power and authority to enter into and perform this Agreement and this constitutes the valid and legally binding obligation of Buyers enforceable in accordance with its terms.

B. No Conflicts; Consents. The consummation of the transactions contemplated by this Agreement by Buyers does not and will not: (i) result in a violation or breach of any provision of the organizational documents of the Company; (ii) result in a violation or breach of any provisions of any law or governmental order applicable to Buyers; or (iii) require the consent, notice or other action by any person or entity under, conflict with, result in a violation or breach of, or constitute a default under any agreement to which Buyers are a party, except in the cases of clause (ii) and (iii), where the violation, breach, conflict, default or failure to give notice or obtain consent would not have a material adverse effect on the Buyers' ability to consummate the transactions contemplated hereby.

7. Release of Personal Guaranty. Buyers and Other Member shall promptly use their best efforts to secure the release ("Release") of Seller from Seller's obligations under all personal guaranties executed by Seller for any debts of the Company, if any. The parties shall

cooperate and perform such further acts and execute such documents as may be reasonably necessary with the Company's lenders to secure the Release. EXCEPT AS OTHERWISE SPECIFICALLY PROVIDED HEREIN, BUYER AGREES TO INDEMNIFY, DEFEND AND HOLD SELLER HARMLESS FROM AND AGAINST ANY AND ALL CLAIMS, DEMANDS, LOSSES, DAMAGES, PUNITIVE DAMAGES, COSTS, EXPENSES, CAUSES OF ACTION OR JUDGMENTS OF ANY KIND OR CHARACTER INCLUDING, WITHOUT LIMITATION, ANY INTEREST, PENALTY, REASONABLE ATTORNEY'S FEES AND OTHER COSTS AND EXPENSES INCURRED IN CONNECTION THEREWITH OR WITH THE DEFENSE THEREOF (COLLECTIVELY, THE "CLAIMS"), WITH RESPECT TO ALL LIABILITIES AND OBLIGATIONS OR ALLEGED OR THREATENED LIABILITIES AND OBLIGATIONS CAUSED BY, RELATED TO, ATTRIBUTABLE TO OR ARISING OUT OF ANY PERSONAL GUARANTY OF SELLER FOR A COMPANY OBLIGATION AFTER THE CLOSING DATE.

8. Confidentiality. From and after the Closing, Seller shall hold in confidence, and shall not disclose to any person or entity, any and all information, whether written or oral, concerning the Business, except to the extent that the Seller can show that such information: (i) is generally available to and known by the public through no fault of Seller; or (ii) is lawfully acquired by Seller from and after the Closing from sources which are not prohibited from disclosing such information by a legal, contractual or fiduciary obligation. If Seller is compelled to disclose any information by judicial or administrative process or by other requirements of law, Seller shall promptly notify Buyer in writing thereof and shall disclose only that portion of such information which Seller is advised by its counsel in writing is legally required to be disclosed; provided that Seller shall use reasonable best efforts to obtain an appropriate protective order or other reasonable assurance that confidential treatment will be accorded such information.

9. Indemnification. Each party ("Indemnifying Party") agrees to indemnify, defend and hold harmless the other party ("Indemnified Party") from and against and shall pay to the Indemnified Party the full amount of any loss, claim, damage, liability or expense (including without limitation reasonable attorneys' fees) resulting to the Indemnified Party arising out of or related to: (i) any breach of this Agreement by the Indemnified Party; or (ii) any inaccuracy in any of the representations or warranties made by the Indemnified Party hereunder. Notwithstanding anything in this Agreement to the contrary, the provisions of this Section 9 will survive for the full period of all applicable statutes of limitations (giving effect to any waiver, mitigation or extension thereof).

10. Company Records and Documents. After the Closing, and upon reasonable prior notice thereof, Buyers shall grant Seller, access, during normal business hours, to such information (including the records and documents related the Company and/or the Business) as necessary for any reasonable business purpose. Buyers shall not dispose of or destroy any such records or documents related to the Company or the Business without giving the Seller at least

fourteen (14) days' prior notice and granting the Company a reasonable opportunity to take possession of any such documents or ones which Seller plans to dispose of or destroy.

11. Miscellaneous Provisions.

A. Benefits and Obligations. This Agreement shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors, personal representatives and assigns.

B. Survival. The respective representations, warranties, covenants, indemnities and agreements of the parties hereto, including, without limitation, those made in or resulting from any certificates, instruments or documents delivered pursuant to this Agreement or in connection herewith, shall survive the Closing under this Agreement and continue in full force and effect without limitation.

C. Entire Agreement. This Agreement contains the entire agreement between the parties hereto with respect to the transactions contemplated herein. No modification or amendment of this Agreement shall be effective unless in writing and signed by the parties hereto.

D. Notices. All notices under this Agreement shall be in writing and shall be considered delivered in all respects when deposited in the U.S. mail, registered or certified mail, postage prepaid, addressed to the recipient's then current address or to such other address as a party may from time to time designate by notice duly given.

E. Further Assurances. Each party to this Agreement shall from time to time hereafter, and upon request, execute acknowledge and deliver such other instruments and documents as may be reasonably required to carry out the terms and conditions of this Agreement.

F. Governing Law. This Agreement shall be governed by and construed in accordance with the internal laws of the State of Wisconsin (regardless of such State's conflict of laws principles), and without reference to any rules of construction regarding the party responsible for the drafting hereof.

G. Attorney Fees. In any action, proceeding or dispute in connection with this Agreement, the losing party as to all claims being decided shall pay all reasonable attorney fees and costs of the prevailing party. If there is no party that is a losing party with respect to all claims being decided, the court resolving such dispute shall determine whether any party shall pay any of the reasonable attorneys fees and costs of any other party.

H. Counterparts; Electronic Signatures. This Agreement may be executed in one or more counterparts, each of which shall be deemed an original and all of which taken together shall constitute a single agreement. Photocopies, scanned images, facsimiles and/or "PDF" electronic and/or digital signature pages of this Agreement shall have the same force and effect as an executed original.

I. Representation. This Agreement was drafted by Cramer Multhauf LLP ("CM") as attorney for Brandon Viliunas, who brokered the sale of the Property, as a courtesy to the parties to memorialize the transfer of the Purchased Stock. Buyers and Seller acknowledge and agree that: (i) CM has not represented either Buyers or Seller in connection with this Agreement; and (ii) Seller and Buyers have had the opportunity and have been advised to seek the advice of independent legal counsel regarding the Agreement and the transactions contemplated herein.






Maricela said she is specifically not being paid but is managing the space as a means to learn how to operate in this business setting. All staff onsite are Brass Key staff who she said are being paid as Brass Key employees.

Understanding we cannot get ahold of George we asked if there was a recent pay stub or other paid invoice that could help us substantiate that employees are paid through Brass Key. Maricela then had her accountant call me. The accountant said the most recent pay stub she can provide is from April 13th and that because they were closed the last three weeks for painting she did not receive time cards to pay out for this next pay period. She then said she would send us a copy of the sale of the Brass Key Corporation to Maricela and her husband as well as most recent pay stubs. See email communication attached. Maricela said she will send pay stubs of the next pay out once they get submitted which would be about 2 weeks since staff are only just back online.

Also attached are invoices and a check Maricela sent on behalf of Brass Key hoping to add to support that this is still the operating business.

Jim- can you translate how licensing would view this? She is adamant as well as the accountant that they are still Brass Key. We obviously cannot get ahold of George. I am not sure how to read the stock agreement or what that means.

Any guidance here would be appreciated. If this is not sufficient our next step (which we would have done today based on the below) would need to be issuing an Intent to Cease prompting George as the listed agent to define his responsibility or be closed. At this time we are told they have no way of getting ahold of him.





A discussion was had regarding the standing complainant form, who stated if they do have issues in the future regarding loitering they will fill out the form and return it to District 6. Maricela stated that she would add the non-emergency and emergency numbers near their business phone and speak with their employees on which numbers to call. A District 6 community contact guide was provided to Maricela.




Concentration Map 4952 W Forest Home Ave


