

AND ON WEPCO POLES THAT RUN N-S ALONG THE WEST SIDE OF THE ALLEY BETWEEN HUMBOLDT AND DOUSMAN STREETS. THE E-W POLE LINE ON CLARKE ST DOES NOT EXTEND ACROSS HUMBOLDT ST. TO INTERSECT THE N-S POLE LINE. THEREFORE, IT IS NECESSARY TO INSTALL ONE NEW POLE AS SHOWN ABOVE AND EXTEND THE FIRER OFTIC CABLE ACROSS HUMBOLDT ST. TO MEET THE N-S POLE LINE.
