

It was brought to my attention that a client under our supervision, Jimmie Williamson, has applied for an Operator's D License from the City of Milwaukee. Client Jimmie Williamson is currently on a parole and extended supervision term that is scheduled to discharge on 01/24/2027 for the offense of 98CF6076- 1st Degree Reckless Injury and 1st-Degree Recklessly Endangering Safety (2cts)/ 02CF4225- CONTR SUB-INT TO DEL.

This letter is to inform you that such a licensure would not be in violation of their rules/conditions of supervision. If circumstances change, we will take measures appropriately, including action that may affect such licensure. We made this decision based in part, on the following information:

- A Residence Stability: Client has maintained residence stability Yes.
- B Reporting History: Client has maintained required contacts with agent Yes.
- C Police Contact: Client has had police contact while on supervision Yes.

  Mr. Williamson reported police contact in February of 2014. He reported his girlfriend's daughter was in an altercation with another woman and the police were called. He also reported police contact in March of 2014. Mr. Williamson was involved in a minor traffic accident and received a ticket for following to closely.
