Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. This report is written by Police Officer Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 02/01/2019 officers conducted a licensed premise check at Capitol Mini Mart, 2329 W. Capitol Dr. The officer identified the clerk as the applicant and requested to see the licenses. All licenses were up to date and the store was clean and in good order. The officer observed several knives behind the counter and asked if there was a gun. The applicant stated he had a gun on his person and showed the officer his Carrying Concealed Weapon permit. The officer advised the applicant to notify officers that he was armed in the future.

2. On 12/27/23 at 11:53a.m., Milwaukee Police conducted a License Premise Check at 2329 W. Capitol Dr. This was an attempt to recover video surveillance from the business for an incident that occurred at 2401 W. Capitol, in which the employee on several attempts, advised officers they could not access the system. However, the agent stated the employee does have access and they would contact them and advise them to allow officers access. On arrival officers confronted the employee about the conflicting story, however, the employee did not provide an answer. The employee then proceeded to manipulate the camera settings in an attempt to select a playback video that would not have been helpful. The officer asked if they could make an attempt, and were able to immediately video that would have been helpful in their investigation, however, due to the delay in accessing it, it was no longer available.

The following items pertain to 2329 W Capitol Dr.

3. On 04/14/25 at 12:00a.m., Milwaukee Police were dispatched to an Entry. Investigation revealed this was a Property Damage. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.
4. On 07/13/25 at 8:35p.m., Milwaukee Police were dispatched to a Shots Fired at 2329 W. Capitol Dr. Investigation revealed a suspect fired one shot, striking the bullet proof glass, after an argument over a charge. The suspect was no longer on scene.

This report is written by PO O'MALIA assigned to District Five, Day Shift as Squad 5190.

On Monday 4-14-25 I was dispatched to an Entry complaint at 2329 W Capitol Dr (Capitol Mini Mart). The caller who was in a vehicle driving past the location noticed that the glass for the door to the location had been smashed and feared someone was inside of the store.

Upon my arrival I did observe the glass on the door to be smashed however the Chicago security gate was still in place and locked making an entry at this location impossible. I walked around the building looking for other possible points of entry and found none. I looked up the license information on this property as it had not yet opened to inform the licensee of the situation. I called Mohammed NAZER (W/M 1-1-65) by phone and he stated he was on his way into open his store. NAZER stated over the phone that his son had made him aware of the damage as he had received a notification of this over night. NAZER stated that he did not believe this was an attempted entry and would not likely need Police but he would meet with me so we could review the security video together.

When NAZER arrived he showed me the security video which shows the sidewalk and part of the street in front of his store. In the video nobody is present but after some cars drove eastbound on W Capitol Dr in front of his store the glass smashes and lands on the sidewalk. NAZER speculated that a car may have thrown a loose rock when passing and stated there was no further damage to the store. A short time later while cleaning NAZER did locate a rock inside of his store. NAZER stated he did not need a report for this incident but that he would call back if things changed.

Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the above license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
 - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.
Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.


