**Re: Sister City Relationship between the City of Milwaukee and Irpin, Ukraine**

Dear Father Savchyn, Mr. Spolowicz, and Irpin City Council:

Congratulations! This is notification that the sister city relationship between the City of Milwaukee and the City of Irpin, Ukraine is now official as a result of a sister city relationship agreement being signed on March 15, 2018 during a signing ceremony at Milwaukee City Hall. **The sister city relationship is valid for five years from the date of the signed agreement and will expire on March 15, 2023.**

Please note that an annual report must be submitted every year by the local sponsoring organization, St. Michael's Ukrainian Catholic Church in Milwaukee, to the City of Milwaukee Sister City Committee within 30 days following the anniversary of the date on which the mayor signed the resolution establishing a sister city relationship. The anniversary date of the sister city relationship with the City of Irpin is January 2<sup>nd</sup>. **Therefore, the first and subsequent annual reports to our office regarding the sister city relationship are due every February 1<sup>st</sup>.**

We look forward to maintaining this sister city relationship with you through the local sponsoring organization, St. Michael's Ukrainian Catholic Church in Milwaukee. The City of Milwaukee is a member of Sister Cities International and adheres to its policies and procedures in reviewing and maintaining relationships. We believe a limited number of such relationships are beneficial to cultural, economic, and educational growth and development for all involved.
