We, the undersigned, support the application for the Climate Pollution Reduction Grant (CPRG) program planning grant submitted by the Southeastern Wisconsin Regional Planning Commission (SEWRPC) for the Milwaukee-Waukesha, WI MSA. SEWRPC is the official areawide planning agency for the southeastern region of the State of Wisconsin, which includes the four counties that constitute the Milwaukee-Waukesha MSA: Milwaukee, Ozaukee, Washington, and Waukesha Counties. This planning effort is focused on the four-county MSA and the City and County, and oversight of the project will rest with the City of Milwaukee and County of Milwaukee and a workgroup established expressly for this project.

My jurisdiction will endeavor to work with SEWRPC, the City of Milwaukee, and other collaborating jurisdictions to build upon Milwaukee's Climate and Equity Plan as the climate pollution reduction plan for the Milwaukee Metropolitan Area. As local governments, we reserve the right to tailor some of the strategies in Milwaukee's Climate and Equity Plan to our specific communities while using this grant opportunity to collaborate regionally to reduce climate pollution.
