This report is written by Police Officer David Novak, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- On 12/26/2019 officers conducted a licensed premise check at Buffalo Wild Wings, 1123 N. Water St. The officers spoke with the bartender and asked to see her bartender's license. She stated she had one but did not have it with her. The officer checked LIRA and found the bartender has not been issued a license. The officer then spoke with the manager and advised that all alcohol sales must end until there is a licensed bartender on scene.
- 2. On 01/02/2020 officers were dispatched to Buffalo Wild Wings, 1123 N. Water St, for a sick and injured complaint. The bartender pointed out a subject at the bar with his head down. The bartender stated that when she asked him to leave he became unreasonably loud and profane so she called the police. The officers asked the subject to leave and he began swearing at the officers. The subject was cited for Disorderly Conduct and conveyed home. The staff on scene was cooperative with the police.
- 3. On 02/25/2021 at 7:33pm officers conducted a license premise check at Buffalo Wild Wings, 1123 N. Water St. The officers spoke with the applicant, who was cooperative and abiding by all rules.
