Hope Ave., N. 62nd St., N. 63rd St. (ST212240109) File Number 240145: Concrete alley pavement reconstruction, replace some abutting walk or driveway approaches, grading, storm drainage facilities, and permeable pavement as necessary. (Assessable Alley Paving Fund - \$67,085; Nonassessable Alley Paving Fund -- \$97,915). The total estimated cost for this project including the requested amount is \$293,600. This project is anticipated to be completed during the 2026 construction season.

Alley between W. Hopkins St., W. Townsend St., N. 22nd St., N. 23rd St. (ST212220116) File Number 220870: Concrete alley pavement reconstruction, replace some abutting walk or driveway approaches, grading, storm drainage facilities, and permeable pavement as necessary. Further Resolved, That the City Comptroller is authorized to transfer such funds which are available for this purpose to the appropriate capital Project/Grant accounts; and, be it

Further Resolved, That the projects do not involve any parcels of agricultural land which are eligible for deferred special assessments under the provisions of Section 14.30 of the Milwaukee City Charter; and, be it

Further Resolved, That the Department of Public Works is authorized to use the funding as specified in the above description of work; and, be it

Further Resolved, That projects Alley between W. Fiebrantz Ave. (ST212240109); Alley between W. Hopkins St. (ST212220116); Alley between W. Greenfield Ave. (ST212220107); W. Michigan St. (ST211240153); Alley between W. Fond du Lac Ave. (ST212220118) will be billed after January 1, 2028, but not before 12 months after the project contract has been completed
