
Dear Mr. Lepping:


This is to notify you that on Tuesday, October 1, 2013, the City's Licenses Committee voted to recommend to the City's Common Council renewal with a forty five (45) day suspension of the Class "B" Tavern and Public Entertainment Premises licenses for the premises located at 4001 W. Fond du Lac Ave. ("All Star Sports Bar") based on items 23-36 in the police report.

On October 4, 2013, you were mailed a true and correct copy of the findings of fact, conclusions of law, and recommendations of the Licenses Committee with respect to the renewal applications for the Class "B" Tavern and Public Entertainment Premises licenses in which the Committee recommended that the licenses be renewed with a forty five (45) day suspension. The Committee also recommended denial of your request to remove the 25 and older age restriction. You were further notified that the Milwaukee Common Council would consider the matter at its meeting of Tuesday, October 15, 2013, commencing at 9:00 a.m. in the Common Council Chambers on the third floor of City Hall, 200 East Wells Street, Milwaukee, Wisconsin. You were advised of the right to file written objections and to appear personally or by counsel to address the Common Council. At that date, time, and place, you did not appear, and you did not file written objections to the report of the Licenses Committee. You were not represented by counsel.

Following consideration of the report of the Licenses Committee, the Common Council voted to renew with a forty five (45) day suspension the Class "B" Tavern and Public Entertainment Premises licenses based on items 23-36 of the police report and to deny your request to remove the 25 and older age restriction.

Said suspensions of the Class "B" Tavern and Public Entertainment Premises licenses are to be in effect between 12:01 a.m., October 23, 2013 through 11:59 p.m., December 6, 2013.
