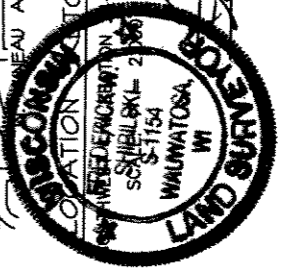
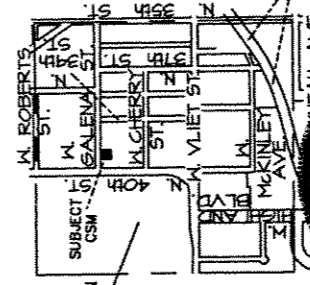
GRAPHIC SCALE

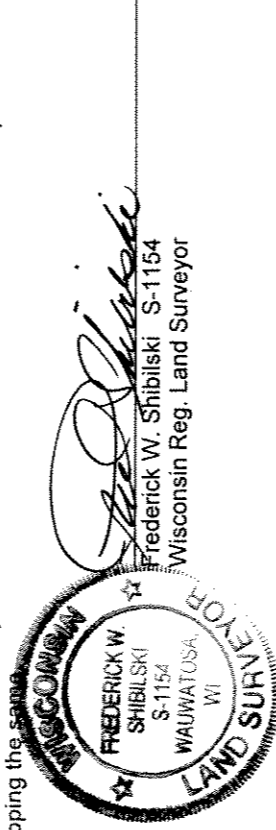
