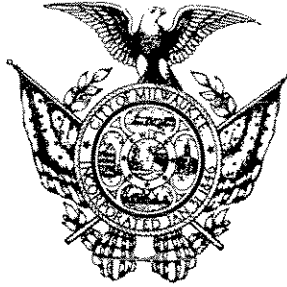

Dear Council Members:


Returned herewith is a document filed by Attorney Laurie Eggert for attorney's fees for representing Police Officers Andrew Gebhardt and Tom Dineen. The claim is in the amount of \$555.81 including \$5.81 in disbursements for 5.00 hours of service billed at the rate of \$110.00 per hour. We ask that this matter be introduced and referred to the Committee on Judiciary & Legislation.

We have reviewed this claim and advise that in our opinion, the time spent was reasonable. Legal representation was occasioned by a criminal investigation. No criminal charges were brought against the police officers on whose behalf this claim was filed.

As we have advised you under similar circumstances in the past, the Common Council has discretion to reject this claim or to pay it in whole or in part. Wis. Stat. § 895.35, *Bablitch and Bablitch v. Lincoln County*, 82 Wis. 2d 574 (1978).

The above-named police officers have retained us to represent them in connection with the above-referenced matter. Consistent with its policy, the City Attorney's Office has refused to represent them, and as they were performing the duties of their office at the time of the events giving rise to the incident, the claim is hereby made on their behalf for the indicated legal fees. This incident involved a field interview.

The MPD initiated a criminal investigation in which the officers initially declined to give a statement without counsel. When they requested counsel, IAD compelled POs Gebhardt and Dineen to give statements concerning the incident after issuing PI-21s. Later, the MPD did not bring criminal charges against the officers. Attached is a copy of the clearance report and an itemization of the time and services rendered.

This report was dictated by Detective Charles SHEPARD, Jr., of the Criminal Investigation Unit/Internal Affairs Division (CIU/IAD), Day Shift.

On Wednesday, October 2, 2002, at approximately 11:00 A.M., I, Detective SHEPARD, had telephone contact with the complainant in this matter. The complainant is Rickey D. BEARD, B/M, Date of Birth 08-13-76, last known address of 1553 North 32nd Street. Telephone contact was made by a neighbor of the complainant after I had arrived at his home on this date to arrange for him to come in and have a DNA sample collected. Upon arrival at the complainant's home at 1553 North 32nd Street, it was soon learned that the home was vacant. A neighbor to the south of this location was able to make contact with Mr. BEARD via telephone, during which time he was advised to meet me at the office at 6680 North Teutonia Avenue to have a DNA sample collected. The reason for the DNA sample was to try and determine if his DNA was on the barrel of the suspect's (officer's) gun which was allegedly placed in his mouth during his arrest. Mr. BEARD did not give me his telephone number where he could be reached, nor did he give me his current address, only stating that he was in the process of moving. During my telephone conversation with Mr. BEARD, he assured me that he would meet me at my office at the Police Training Bureau at 12:00 noon to have the sample collected. Mr. BEARD was supposed to meet me on Thursday, October 3, 2002, at 12:00 noon, however, at 8:00 A.M. that date he was supposed to call me first.

As of Tuesday, October 8, 2002, at 11:00 A.M., I have not yet heard from Mr. BEARD regarding this complaint. It should be noted that Mr. BEARD was advised of the importance of cooperation at this time if he wished this complaint to proceed. At that time Mr. BEARD indicated to me that he was quite clear on the importance of cooperation, and would do so. Due to the fact that Mr. BEARD has failed to cooperate during this investigation by declining to appear on a predetermined date, time, and location, it is believed that Mr. BEARD is no longer interested in pursuing this matter. Due to the fact that Mr. BEARD has failed to cooperate in this investigation, it is believed at this time that this matter should be determined unfounded.

It should be noted that Lieutenant of Detectives Raynard E. RICHARDS was advised on the facts concerning Mr. BEARD's lack of cooperation in this matter, at which time Lieutenant RICHARDS was in agreement with this disposition. This criminal investigation is closed.
