There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-2.7-4, probative evidence concerning whether or not a new license should be granted may be presented on the following subjects: whether or not the applicant meets the municipal requirements, the appropriateness of the location and premises where the licensed premises is to be located and whether use of the premises for the purposes or activities permitted by the license would tend to facilitate a public or private nuisance or create undesirable neighborhood problems such as disorderly patrons, unreasonably loud noise, litter, and excessive traffic and parking congestion. Probative evidence relating to these matters may be taken from the plan of operation submitted with the license application, if any, but shall not include the content of any music. Evidence regarding the fitness of the location of the premises to be maintained as the principal place of business, including but not limited to whether there is an overconcentration of businesses of the type for which the license is sought; whether the proposal is consistent with any pertinent neighborhood business or development plans, or the location's proximity to areas where children are typically present. The applicant's record in operating similarly licensed premises; and whether or not the applicant has been charged with or convicted of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the activity to be permitted by the license being applied for or any other factor which reasonably relates to the public health, safety or welfare may also be considered. See attached police report or correspondence.

Notice for applicants with
warrants or unpaid fines:Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the
above date and time. Failure to comply with this requirement may result in a delay of the
granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

I respectfully object to the city of Milwaukee granting a license to Michae Eitel, agt. Banderas 408, LLC

is first and foremost an apartment building, comprising about 100 units. The proposed business, "Banderas" is completely unsuitable for this location. The decision made by Hovde Properties to allow such a proposed restaurant and bar is at the detriment to the peaceful existence for all residents who have made their home. This space Banderas is taking over was not made to accommodate a restaurant as no kitchen is available. No allowance has been made for trash removal that I can see. The trash produced by a restaurant is going to be mostly food at the building is already at capacity in dealing with the current trash situation.

The disruptive noise coming from a soccer bar, complete with DJ will inevitably spill out onto the street and this is unacceptable to the 'residents quality of life. I predict that there are many daily calls to the city about this establishment for disturbing the peace and also being open past posted hours. The capacity of such a small space will

inevitably end up having many patrons on the street in front of the building. This was already a great annoyance to the residents when the previous bar, Lost Valley, was still in business.

Also very concerning is that in the way the building is set up, Banderas patrons will have access to the secure space of the apartment building to use the restrooms, etc. This is already an annoyance from the other two spaces in the building who have a liquor license, Brew City Fitness and Greige Bakery. The security of residents is at risk with unvetted people having access to the residents secure common space.

I personally feel that the last thing this neighborhood needs is another bar. Especially in an apartment building where so many people live. I would expect if this goes through, that there will be a mass exodus of residents from the building. We pay far too much to have our peace disturbed by the capricious decision of Hovde Properties to allow a tequila, soccer and "food" bar to move into this building.

Please do not grant this license. It's not a good fit for any residential building. Many, many of the residents are quite upset at the prospect of Banderas opening. I do hope you hear from them too. Sincerely,

I respectfully object to the city of Milwaukee granting a license to Michael Eitel, agt. BANDERAS 408, LLC.

Brix is an apartment building comprising over 100 units. The proposed establishment, "Banderas", is unsuitable for this location. This space was not designed to accommodate a restaurant or bar establishment, particularly as there is no kitchen available. As evidenced in the photograph, all residents would be adversely affected by the excessive and disruptive noise generated and emanating from this venue.

The Milwaukee Journal Sentinel states:

April 24, 2025

"Banderas will have a weekly Latin night with a DJ playing Latin jazz, cumbia, and bachata. They also will air soccer games with Spanish announcers."

This plan is not acceptable. A weekly DJ playing music at night as well as music playing other nights is not only disruptive, residents will be unable to open their windows during the summer due to the persistent loud music and the continuous airing of soccer games. The situation will worsen when the establishment keeps its doors open so patrons can hear the broadcast of the soccer games outdoors.

"The space, formerly home to Lost Valley Cider Co., <u>does not have a kitchen.</u> Food for Banderas will be prepared in Caravan Hospitality's commercial kitchen and heated up onsite. The menu will feature South and Central street food like arepas, tortas, empanadas, rice bowls and Tex-Mex inspired pizzas."

Not only are there concerns about the quality of food when it is reheated instead of freshly prepared, the city needs to take into consideration the health risks to customers eating this "stored and reheated" food when there is no kitchen available. What guarantee will the city have that the food will be delivered everyday from their commercial kitchen?

Additionally, parking availability in this area is extremely limited. This creates a danger when people must walk numerous blocks to their car late at night.

Despite the understaffing of our police force here in Walkers Point, they do an excellent job addressing complaints and ensuring the safety of all residents. The increase in noise complaints due to the approval of this license will pose further challenges for our 8th district police.

While I wish Mr. Eitel success in his venture, this neighborhood is definitely not the right one for opening this type of establishment as it will lead to various issues for everyone involved.

I have recently received notice of an application for a business named BANDERAS that would enable them to obtain a class B tavern public entertainment premises and sidewalk dining facility license. As a resident <u>in the second structure of the second structure</u> of this application due to several factors listed below.

Welfare Objection -concerns of noise pollution (our building has strict quiet hours) particularly in busy Summers and Street overcrowding as there is very little space for the proposed outside dining.

Safety Objection -increase in criminal activity (which the neighborhood already struggles with) and drawing attention in a negative way to the residential area, Especially with late evening dining and raucous patrons.

Health Objection - sanitation concerns regarding vermin and pest control for the building as there are no formal dining area spaces in the building as it is now, and restaurants are prone to attract such things.

Safety objection- there are many frequenters of the "Iron Horse" hotel nearby, and the traffic is already extremely congested -it would be very dangerous to permit this venue to allow alcohol consumption on the street, so close to pedestrian walkways and the coming and going of hotel and resident traffic... not to mention the hassle of the on-street parking that is already exceedingly crowded and dangerous.
