7 Mrs. Herndon, could you, again, just provide your
8 name and address for the record?
9 THE WITNESS: Marva Herndon, 5651 North
10 86th Place, 53225, Milwaukee.
11 CHAIRMAN BOHL: I'm going to guess that
12 this was also another item of discussion at the
13 Bright Heights Neighborhood meeting.
14 THE WITNESS: Exactly.
15 CHAIRMAN BOHL: And sentiments?
16 THE WITNESS: I'm saying yes. They
17 explained that - - Mr. Sajan did explain to us
18 that he would not be in attendance today, and
19 that's the reason why we took the vote and made
20 sure that we wanted to get on record that we were
21 in approval. The vote was approximately 23 to
22 three, if you can believe that, in favor. I know
23 it's surprising, but - - but they gave good
24 explanations.
25 CHAIRMAN BOHL: And that neighborhood

19 Council.

22 notice that that would happen, and I will reach
23 out to the applicant.
24 CHAIRMAN BOHL: I'm sure - - we'll have
25 Mr. Lee do that, and then Ms. Grill can work to
