Dear Council Members:

Enclosed please find a proposed resolution. We ask that it be introduced and referred to the Committee on Judiciary & Legislation, with the following recommendation.

Mr. Weathersby alleges that the City failed to maintain and/or block the roads while conducting repairs to a water pipe, after which he subsequently drove into a large sinkhole at the intersection of N. Weil Street and E. Wright Street. Mr. Weathersby submitted a damage claim for \$8,324.29, for damages regarding his 2005 GMC Yukon. On May 12, 2025, Custard Appraisers completed an inspection of the vehicle and the estimated cost of repairs is \$6,818.68, plus tow.

We have completed our investigation into this matter with Milwaukee Water Works (MWW). Our investigation determined that on December 23, 2024, MWW responded to a leak in the street in the 2500 block of N. Weil Street. During the course of repair work, the claimant failed to yield to a Water Works crew member in the roadway, wearing a construction vest, and went around a MWW Fleet vehicle with flashers on parked adjacent to the excavation. Mr. Weathersby subsequently drove into the sinkhole.
