Dear Mr. Mantes:

We recently talked to Gerry Froh to discuss the Wisconsin Center District's (WCD, owners and operators of the Midwest Airlines Center, U.S. Cellular Arena and the Milwaukee Theatre) desire to have a fiber optic connection between Milwaukee Public Television (MPTV) and our facilities. After discussing this with the President & CEO of WCD, Richard A. Goyer, we would hope to develop a working relationship between MPTV and WCD that will provide as with the ability to offer Satellite services in our Video Production area. This will give us a customized service that most Convention and Entertainment facilities do not have. With the fierce competition for convention business, this would be a service that would help bring in more conventions and other events to our facilities.

This would also benefit the City of Milwaukee by bringing more visitors to the city, which will bring in more business to its establishments (restaurants, hotels, etc.) and also help with the ever-growing image of Milwaukee as a first-class city. In the past, we've had the Mayor and other city officials in our facilities for town hall meetings and other events, and this would allow them to use this new and exciting service also. They would have the capability of sending a video feed of their event to other locations throughout the city.

MPTV will also benefit by adding to their fiber network, having the ability to send satellite feeds to various locations throughout the city. So it is a win-win situation for all.

In talking to Gerry Froh, it seemed as if this connection might not be overly complicated to achieve, since we already have fiber established with the City of Milwaukee in our facility, as does MPTV. The thought is that the different fiber runs going into these two facilities. most likely cross paths in a City of Milwaukee building, probably the fire station on 7th & Wells or one of the Police stations near by. The two separate paths could then be connected in that building to create a new path between MPTV and WCD.

If this were possible, would you be able to give me some type of a general timeline on what the next steps would be and when they might take place, so we can plan accordingly?
