Dear Ms. Sanders:


Our office has received your claim relating to the towing of your 1982 Chrysler. You indicate that your vehicle was towed and destroyed and you are asking for \$1,000.00.

Our investigation reveals that your car was towed as abandoned on March 22, 2001. On March 22, 2001 a letter was sent to you at 5920 West North Avenue, Apartment #1, advising you that the car had been towed, that you had 22 days from the day it was towed to pick it up, and indicating where you could pick it up. The car was not retrieved and a second letter was sent to you on March 29, 2001, indicating that if the car was not retrieved by April 13, 2001, it would be recycled. You did not retrieve your vehicle on April 13, 2001 and it was recycled on April 14, 2001. Notice was properly given and therefore we are denying your claim.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of receipt of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202.
