The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 08/04/2018 a 17 year old working in conjunction with the Milwaukee Police Department and WI WINS Tobacco initiative, was able to purchase a Swisher Sweet cigar from the clerk at 2672 N. 35th St. The clerk did not ask for an ID card. The clerk was identified as Ali FARHUD and he admitted the sale. The applicant was mailed a MARTS enrollment package.

2. On 01/14/21 at 8:20pm, Milwaukee Police were dispatched to 2672 N. 35th Street for a trouble with subject complaint. During the initial investigation an employee told officers that a subject was panhandling outside the store all day, eventually entered the establishment, and became argumentative with the store staff. With the help of other employees, the subject was physically removed after knocking over items inside the store. The employee said the video was not working so the subject was issued a citation. On a later date, Facebook had two videos show up of the incident filmed by two customers inside the store. That videos showed the subject knocking items off the store shelf and a customer hitting the subject with a garbage can, knocking him to the floor. An employee started kicking him in the head numerous times and threw store items at the subject.. The customer and the employees then dragged the subject outside the store. As a result of the new information, the employee who was kicking the subject was arrested. Police also, again tried to retrieve video surveillance of the incident but it appeared to be erased.

3. On 02/09/2021 a meeting was held at District 3 regarding the incident from 01/14/2021. At the meeting were Attorney Michael MAISTLEMAN, the business manager, and the building owner. The business was asked if the camera system was operational because during the last incident the officers were advised the system was not working. Attorney MAISTLEMAN was answering the question when the Captain stated he wanted the applicant to answer. The manger stated the applicant was not here because he was an absentee owner and he ran the day to day operations. He admitted he did not have a manager's license. The meeting was ended because the Captain stated it was not worth having a meeting with the agent not being there.

Notes from the meeting

During the meeting, Alliance foods was informed that the video that surfaced via social media of an employee battering a civilian is unacceptable. The business was asked if the video system was currently working because the police report stated it wasn't working at the time of the incident. Attorney Maistleman attempted to answer the question when Captain Johnson stated he wanted to hear it directly from the agent . Khaled A Farhud stated that he was the manager of the business and that he was not the owner of the business . Farhud stated he runs the day to day operation but doesn't have a managers license. Nimer Musaitif stated he was the property owner not the agent. When asked where the agent was, Farhud stated he was an absentee owner. Captain Johnson informed Attorney Maistleman that the meeting was to stop, because he couldn't have a conversation with someone who is not the owner of the business due to him not being able to make any decisions regarding alliance foods.

This report is written by PO Devin WHITFIELD, assigned to District Three, Late Power Shift.

On Thursday, January 14, 2021 at 8:43 PM, PO Jeremie GAINER and I (squad 3451) responded to Alliance Food Market, located at 2672 N 35th St in the City and County of Milwaukee, Wisconsin for a Subject with Gun call for service, which was later amended to a Trouble with Subject. Upon arrival, PO GAINER spoke to the owner, identified as Khaled A FARHUD (w/m, 02-07-65), who stated that Rafeal D SANDERS (b/m, 09-22-85) was causing a disturbance at the store.

Initial Interview of Khaled A FARHUD (w/m, 02-07-65)

PO GAINER interviewed K FARHUD inside the store. K FARHUD stated that SANDERS was outside of the location panhandling since 5:00 PM on 01-14-21. K FARHUD stated that he and his employees went outside and asked SANDERS to leave, but SANDERS refused. K FARHUD stated that SANDERS then entered the store and became argumentative with him and made threats to harm him and shoot him. K FARHUD stated that he then asked SANDERS to leave the store, and SANDERS became agitated and started cursing at him. K FARHUD stated that SANDERS then started knocking over items inside of the store. K FARHUD stated that him, his nephew identified as Ali M FARHUD (w/m, 02-25-89), and a customer physically removed SANDERS from the store and then called for police.

Initial Interview of Rafeal D SANDERS (b/m, 09-22-85)

I interviewed SANDERS outside of the location. SANDERS stated that he was panhandling at the location all day. SANDERS stated that he entered the store, and the employees became argumentative with him and told him to leave the store. SANDERS stated that the employees then all physically assaulted him, stomping him on his head and kicking him in the chest. It should be noted that PO GAINER attempted to view in-store video of the incident, but K FARHUD stated that the cameras inside of the store were not working at the time and that only the cameras on the outside of the building were working.

SANDERS stated that he is diagnosed with PTSD and bipolar schizophrenia. SANDERS stated that he took his medication that day.

SANDERS declined medical on scene and stated that he would walk to the hospital on his own for treatment. SANDERS was issued a citation for Disorderly Conduct (*Citation #0681SHS29W*).

On Friday, January 15, 2021 at 7:11 PM, I received an email from Milwaukee Police Department Crime Analyst Ryan RASMUSSEN containing video of the incident at Alliance Food Market on 1-14-21. The email contained 3 video clips of the incident that were posted on Facebook by two citizens, identified as Kewon L WHITMORE (b/m, 01-20-95) and Deseree M AYERS (b/f, 06-19-98), who both appeared to have been at the store and recorded the incident when it occurred. The videos depict the following:

Video #1 posted by Kewon L WHITMORE (b/m, 01-20-95)

SANDERS is observed standing in the store, surrounded by K FARHUD, A FARHUD, Alfonso WALLACE (b/m, 01-21-66) who is also an employee at the store, and an unidentified customer. It should be noted that all of the employees at the store stated that they have never seen the unidentified customer before and do not know who he is. The unidentified customer is seen striking SANDERS with a plastic garbage can, knocking SANDERS to the floor. A FARHUD is then seen kicking and stomping SANDERS approximately 13 times in his head and back while he is on the ground, as K FARHUD, WALLACE, and the unidentified customer stand by. SANDERS is seen laying on the ground with his arms wrapped around his head, appearing to protect himself from being kicked by A FARHUD.

Video #2 posted by Kewon L WHITMORE (b/m, 01-20-95)

A FARHUD is observed striking SANDERS one time with a garbage can while SANDERS is on the ground. WALLACE and the unidentified customer then drag SANDERS out of the store by his arms and legs.

Video posted by Deseree M AYERS (b/f, 06-19-98)

SANDERS is observed knocking items off of a shelf inside of the store. The unidentified customer is seen striking SANDERS with a plastic garbage can, knocking SANDERS to the floor. A FARHUD is then seen kicking and stomping SANDERS approximately 32 times in his head and back while he is on the ground, as K FARHUD, WALLACE, and the unidentified customer stand by. A FARHUD is then observed picking up store items off the floor and throwing them at SANDERS. A FARHUD then strikes SANDERS two times with a garbage can. WALLACE and the unidentified customer then drag SANDERS out of the store by his arms and legs.

Second Interview of Rafeal D SANDERS (b/m, 09-22-85)

I re-interviewed SANDERS, who was in custody for an unrelated offense at the Milwaukee County Criminal Justice Facility (CJF). SANDERS stated that he remembered being "jumped" and assaulted at the Alliance Food Market (2672 N 35th St) on 1-14-21. SANDERS stated that he wanted to press charges against those who assaulted him. SANDERS stated that on 1-14-21, he was inside of the store arguing with an employee who he knows as "Little Charlie." SANDERS stated that "Little Charlie" pointed a gun at him during the argument, so he started knocking over items inside of the store. SANDERS stated that the employees inside of the store then all physically assaulted him. SANDERS stated that he was being kicked while he was on the ground, but he could not see who was kicking him because he was covering his head to protect himself from the kicks. SANDERS stated that this was done intentionally and without his consent, and that it caused him pain to his head and chest, minor swelling to his head, dizziness, and blurry vision.

SANDERS walked to St. Joseph's Hospital for medical treatment on 1-14-21. SANDERS was admitted to St. Joseph's Hospital at 9:37 PM and was treated by Dr. M. MOKROHISKY. SANDERS stated that the hospital treated him for the pain to his head, the dizziness, and blurred vision, and that there were no serious or further injuries to report.

Follow-up at Alliance Food Market - 2672 N 35th St

PO GAINER and I returned to the Alliance Food Market on 1-18-21 to re-interview the employees and to attempt to obtain video. We were unable to obtain any video as the video for that date appeared to be erased.

I interviewed WALLACE at the store. WALLACE stated that he has been working at the location for the past 8 years. WALLACE stated that on the day of the incident, he started work at 5:00 PM and observed SANDERS coming in and out of the store constantly that day. WALLACE stated that SANDERS had been loitering outside of the location for the past 3 days. WALLACE stated that at one point SANDERS came into the store and randomly started knocking things over in the store. WALLACE stated that he and other employees went over to try to remove SANDERS from the store, and SANDERS became combative. WALLACE stated that SANDERS ended up on the floor, at which point he observed employee Ali M FARHUD (w/m, 02-25-89) kicking SANDERS multiple times. WALLACE stated that he told FARHUD to stop and that that was enough. WALLACE stated that he believed FARHUD's actions were unnecessary and racially motivated.

I also re-interviewed the store's owner, Khaled A FARHUD (w/m, 02-07-65). K FARHUD stated that SANDERS had been at the location for days, loitering outside, panhandling, and bothering customers despite being asked constantly to leave. K FARHUD stated that on 1-14-21, SANDERS came in to the store and got into an argument with his nephew, A FARHUD. K FARHUD stated that SANDERS and A FARHUD were both pushing each other, and then SANDERS kicked over a garbage can and knocked over a rack of lottery tickets. K FARHUD stated that SANDERS then knocked another shelf of items to the floor. K FARHUD stated that a customer in the store who he has never seen before and does not know struck SANDERS with a garbage can, knocking him to the floor. K FARHUD stated that while on the floor, A FARHUD kicked SANDERS multiple times. K FARHUD stated that he believes A FARHUD was kicking SANDERS out of frustration due to him arguing back and forth with SANDERS all week.

Arrest of Ali M FARHUD (w/m, 02-25-89)

PO GAINER and I went to A FARHUD's residence at 4042 S 5th St and arrested A FARHUD for misdemeanor Battery. A FARHUD was extremely uncooperative and refused to answer any questions or cooperate with the booking process. A FARHUD was conveyed to St. Francis Hospital for medical clearance and to District Three for processing.

The hearing before the Licenses Committee will take place virtually on 3/30/2021 at 1:20 PM. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at <http://city.milwaukee.gov/citychannel>. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Molly Kuether-Steele at (414) 286-2775 or molly.kuether-steele@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the above license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
 - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
