AGREEMENT BETWEEN

THE WISCONSIN DEPARTMENT OF TRANSPORTATION

AND

THE CITY OF MILEWAUKEE POLICE DEPARTMENT

State Project I.D. 1060-05-92 CONTRACT NO. 3 2005 Traffic Mitigation Marquette Interchange Reconstruction

This agreement, is a one-time grant made and entered into by and between the Wisconsin Department of Transportation (DEPARTMENT) and the City of Milwaukee Police Department (CITY), provides for services as described herein.

The DEPARTMENT advises implementation of a comprehensive and cost effective traffic mitigation program that will help insure the safety, accessibility, and mobility for users of the Marquette interchange while minimizing unsafe conditions. To mitigate traffic impacts caused by the reconstruction of the Marquette Interchange, the DEPARTMENT will provide funding to the CITY for providing local law enforcement enhancements services as specified in Attachment A: City of Milwaukee Police Department - Cost Estimate. The agreement duration for the services described herein is for October 1, 2004 to December 31, 2005. It is anticipated that this project will help provide safer and quicker responses to crashes and other incidents on the city's arterial street network adjacent to the project area and help improve travel and reduce delays.

ENFORCEMENT ENHANCEMENTS

The CITY shall provide additional enforcement patrols on key alternate routes related to North Leg construction to keep the alternate route open and traffic moving. These routes shall include, but not be limited to 27th Street, 17th Street, 12th Street, 10th Street, James Lovell Street, Halyard Street, 6th Street, National Avenue, St. Paul Avenue, Clybourn Street, Highland Avenue, McKinley Avenue, Walnut Street, etc. These enhancement services will allow for quicker first responses to crashes on key alternate routes, quicker incident removals, and added presence at sensitive facilities (schools, boy and girls clubs, etc.). The CITY shall also assist in securing incident/crisis scenes on city streets and attend Marquette Interchange related construction progress meetings and coordinating closure schedules when necessary.

The CITY shall provide local law enforcement enhancements services from January 1, 2005 to December 31, 2005. The CITY shall provide two police officers for three hours per day at an overtime hourly rate \$37.92 for 259 weekdays and one sergeant for three hours per day at an overtime hourly rate \$41.84 for 250 weekdays. The remaining money shall be used for enhancement services during holiday weekends, special events, or other closure assistance required by the DEPARTMENT and its contractor.

Basis of Payment

The CITY shall charge actual costs incurred and attributable to the work performed and described above under this agreement to the DEPARTMENT. Total reimbursement to the CITY for traffic mitigation measures under this agreement will not exceed \$114,000 as detailed in Attachment B: City of Milwaukee Police Department - Cost Estimate.
