Officer WILSON conducted a preliminary investigation during which he determined that a battery cutting (substantial battery / stabbing) had occurred. Officer WILSON then obtained the description of the suspect and broadcast that description via the Milwaukee Police KSA radio. Officer WILSON then notified his Lieutenant of this incident who in turn notified the Criminal Investigation Bureau.

P.S.#014171): and Squad 2X (Police Sergeant Dwayne PRATCHET, P.S.#009207). Officer WILSON stated that Officer BURGOS remained outside the tavern, across the street in an Aldi's parking lot securing evidence that was located there. Officer BURGOS remained with the evidence until it was recovered by myself.

This incident occurred at the Camelot Club, which is a gentleman's club located at 2714 South 13th Street. The Camelot Club is located on the east side of South 13th Street facing to the west. Immediately upon entering the club is a short hallway that veers off to the right (south). Upon making one's way through the small hallway, the club itself stretches out to the east. The main stage is located on the northwest corner of the club and is connected to the bar that runs from the west to the east. There is a secondary stage located in the far east end of the club, and it is attached to the southern wall. The Camelot Club is not equipped with video surveillance cameras.

This incident stemmed from an argument from some of the dancers who are listed as follows:

The victim of this incident was identified as Lasha M. JOHNSON, B/F, DOB 12/21/85. JOHNSON's stage name is "Paris."

The suspect in this incident was identified as Raeshonda S. MONTREY, B/F, DOB 04/27/86. MONTREY's stage name is "Red." Although the dancers at the club knew her only as "Red", MONTREY's true name was determined by viewing her application.

Carolyn L. WILLIAMS, B/F, DOB 03/02/79 (AKA Baby Doll) was a witness to this incident and is a close friend of JOHNSON's.

Janie M. REED, B/F, DOB 04/11/77 (AKA Candie) was also a witness.

Temeka S. WHITE, B/F, DOB 07/11/79 (AKA Extacy) was a witness as well.

Niko M. MINER, B/F, DOB 06/16/81 (AKA Heaven) was a witness to this incident.

Alexis E. HERNANDEZ-BAKULA, W/F, DOB 11/13/82 was the bartender and night manager.

The doorman was identified as Tyrone A. DENTON, B/M, DOB 07/31/79.

Additionally, another dancer returned to the scene who was identified as Marcella (nmi) HILLARD, B/F, DOB 01/02/79 (AKA Eve).

#### INTERVIEWOF JANIEM. REED

I first spoke to REED who stated that she resides at 2868 North 21st Street, Milwaukee, Wisconsin 53206 and who has a home telephone number of 419-2209. REED stated that she has been employed at the Camelot for approximately five years, and her hours working today were from 2:00 p.m. until 8:00 p.m. She stated that those hours are the "Day Shift"; however, she remained over into the night shift to make some more money.

REED stated that she was on the rear stage giving a lap dance to "Greg." REED stated that

"Greg" was facing the stage (southbound), and she was on the edge of the stage facing him (northbound). There is a column located on the northwest corner of the stage and prevented REED from seeing exactly what the goings on were.

REED stated that she looked, however, in a mirror located on the far eastern wall of the establishment. She stated that she saw "Red" chasing WILLIAMS while holding a fifth of Remmy in her right hand over her head. She stated that "Red" was shouting, "Bitch, you don't know me! Whoever come out the club getting their ass whipped!"

REED stated that as WILLIAMS ran past her, DENTON was able to capture and tackle "Red" (MONTREY).

REED stated that she continued giving "Greg" the lap dance, and a short time later, she heard many screams, and somebody shouted, "Paris got stabbed!"

REED stated that she looked over and saw DENTON pushing MONTREY outside. REED stated that she then went to the front and saw that JOHNSON was bleeding from the back and asked what had happened and was told that MONTREY had stabbed JOHNSON.

REED described "Red" (MONTREY) as being a 20-year-old B/F who is between 5'6" and 5'7" inches tall and weigh 160 lbs. with a medium build and a light complexion. She stated that MONTREY wore her hair in microbraids that were in a ponytail and could not provide a clothing description.

I next spoke to WILLIAMS who stated that she resides at 1534 West Wright Street, Milwaukee, Wisconsin 53206 and has a home telephone number of 562-3698. WILLIAMS stated that she has been employed at the Camelot for approximately two-and-one-half years, and her hours today were from 8:00 p.m. until 2:00 a.m.

WILLIAMS explained that when there are no customers in the tavern or there are only one or two customers in the tavern, it is policy to turn off the house music and turn on the radio. She stated that when the radio is on, the volume is kept low. WILLIAMS stated that because there was only one customer inside of the club, she asked "Red" (MONTREY) to turn on the radio. She stated that MONTREY did turn on the radio, however, turned the volume up very loud. WILLIAMS stated that she then asked MONTREY to turn down the radio and that MONTREY replied, "If you want it turned down, you can turn it down."

WILLIAMS stated that the bar suddenly became quiet at the unexpected outburst from MONTREY.

WILLIAMS stated that she then asked MONTREY who she was talking to, to which she (MONTREY) stated, "You."

WILLIAMS stated that MONTREY then climbed onto the stage in front of the club and grabbed a mostly full bottle of Remy Martin. She stated that MONTREY then ran across the bar, jumping off the bar, then chasing her eastbound through the club. She stated that she ran

around the front of the small stage and then back over the rear stage. WILLIAMS stated that at that point, MONTREY was caught by DENTON who forced her down onto the floor. She stated that DENTON was attempting to calm MONTREY down, however, was unsuccessful. WILLIAMS stated that DENTON then dragged MONTREY outside.

WILLIAMS stated that MONTREY remained outside for approximately one hour. She stated that she and JOHNSON were afraid to leave because MONTREY remained outside shouting, "Any bitch come out that door, I'm gonna whip their ass."

WILLIAMS stated that MONTREY remained outside shouting until a customer came into the club. She stated that when the customer entered the club, MONTREY did as well. WILLIAMS stated that MONTREY then ran directly up to JOHNSON who was standing near the center of the bar near the dart board. WILLIAMS stated that MONTREY then stabbed JOHNSON in the back with a knife. She stated that she saw JOHNSON flinch and shout "Bitch stabbed me!" and grabbed the knife that was still in MONTREY's hand.

WILLIAMS stated that she then jumped into the fight and began punching MONTREY. She stated that as she was doing so, DENTON arrived and dragged her back out of the club again.

WILLIAMS stated that prior to the stabbing, two strippers whom she knows as "Chocolate" and "Eve" (HILLARD) came into the club. WILLIAMS stated that she knows that "Eve" works at Tommy's, which is located on North 76th Street and West Hampton.

WILLIAMS described "Chocolate" as being a 21-year-old to 25-year-old B/F who is 5'7 inches tall weighing 120 lbs. with a slender build and a dark complexion. She stated that she wore her hair in a weave that was in a ponytail and a white hat.

WILLIAMS described "Eve" (HILLARD) as being a 28-year-old to 30-year-old B/F that is 6' weighing 160 lbs. with a medium build and a medium complexion. She stated that "Eve" was wearing a light brown, curly wig.

WILLIAMS stated that MONTREY started shouting, "You let my girlfriend in, now let me in!" after "Eve" and "Chocolate" had entered the tavern.

WILLIAMS stated that someone asked "Chocolate" and "Eve" if MONTREY was with them to which they were told no. WILLIAMS stated that at one point, MONTREY entered a four-door, brown car that was parked across the street in the Aldi's lot. She stated that one of the other dancers then asked "Chocolate" and HILLARD, "Yall don't know that girl." "How come she's in your car?"

WILLIAMS stated at that, "Chocolate" and "Eve" then exited the tavern. She stated that it was moments after they exited the tavern that MONTREY ran into the tavern stabbing JOHNSON.

### INTERVIEWOF TYRONEA. DENTON

I next spoke to DENTON who stated that he resides at 4215 North 33rd Street, Milwaukee, Wisconsin 53216 and has a home telephone number of 873-1727. DENTON stated that he has

worked at Tommy's (which is owned by the same people) since July '04. He stated that it has only been since last summer that he has worked at the Camelot. He stated that his hours on this date were from 8:00 p.m. until close. DENTON stated that he is employed at the tavern as the doorman.

DENTON stated that he was at the front of the club near the door when he heard MONTREY and WILLIAMS shouting back and forth. DENTON stated that he then told MONTREY to go downstairs and that she did; however, she came up shortly later asking to use the phone. DENTON stated that he allowed her to use the phone, which is located at the east end of the bar near the opening to the bar. He stated that he walked her to the phone and that she was using the phone when a customer came in. DENTON stated that at this time, he left MONTREY on the phone and went to service a customer. He stated that the customers are searched prior to their entering; however, he never did search this customer because he (the customer) then changed his mind and left.

DENTON stated that he then returned to the telephone where MONTREY was still talking on the phone. DENTON stated that MONTREY then walked behind the bar climbing the steps onto the stage where she grabbed a bottle of Remmy Martin, which was located on a shelf behind the bar. He stated that MONTREY then ran across the bar, jumping down and chased WILLIAMS with the bottle of Remmy Martin held in her right hand over her head.

DENTON stated that WILLIAMS then fled from MONTREY, running around the east stage and then over the stage jumping off. He stated that when MONTREY jumped off the stage, he was able to capture her, tackling her onto the ground near the dart board. He stated that he then picked her up, took her to the front of the store, and instructed the other girls to begin collecting her belongings, which they did.

DENTON stated that MONTREY was getting dressed while still near the front of the bar saying, "I'm gonna come back." "I'm not gonna leave until I whip somebody's ass." DENTON stated that MONTREY then accused him of breaking her thumb. He stated that he does not know which thumb she said that he broke.

DENTON stated that MONTREY then left and then he followed her back outside. He stated that he remained outside for a short time and then went back into the club locking the door behind him to prevent MONTREY from reentering.

DENTON stated that he eventually had to unlock the door, so the other dancers could get their rides home.

DENTON stated that MONTREY was outside across the street in the Aldi's parking lot seated in a light gray Cadillac, four-door, possibly an Eldorado. He stated that there was a large B/M driver in the car and that he (DENTON) walked over to the car handing MONTREY's jacket to her, as she was seated in the right, front passenger seat.

DENTON described the driver as being a B/M between the ages of 28 and 32 with a stocky build, a dark complexion and as being bald headed. He stated that the driver was wearing a red and blue striped shirt.

DENTON stated that MONTREY then exited the car walking back to the entrance door to the Camelot and shouted, "I'm gonna kick somebody's ass!"

DENTON stated that he then went back in closing and locking the door behind him. He stated that he then realized that he had a small scratch on his left hand and went into the bathroom to clean it up. He stated that when he went back to the front, all of the dancers were running back into the club and that JOHNSON was holding her back or shoulder and that one of the girls was shouting, "She got stabbed!"

DENTON stated that he did not see the actual stabbing and was only told that it was MONTREY that did it.

DENTON described MONTREY ("Red") as being a B/F, 20 years of age and as being 5'5 inches tall weighing 170 lbs. with a heavy build and a light complexion. He stated that she was wearing a wig with some color in it that was pulled back into a ponytail. DENTON stated that MONTREY was wearing a white "Baby Phat" shirt, blue jeans and a tan, waist-length jacket with a fur trimmed hood.

DENTON stated that a customer must have called 911, and the police and an ambulance arrived shortly.

### INTERVIEWOF JEROMEG, LANGE

I next spoke to Jerome G. LANGE, W/M, DOB 10/07/68, who resides at 3312 South Indiana, Milwaukee, Wisconsin 53207 and who has a home telephone number of 486-1958 and a cellular telephone number of 559-2922. LANGE stated that he is employed as an engineer for MPS at Bradley Tech.

LANGE stated that he arrived at the Camelot parking across the street in the Aldi's lot. He stated that when he arrived, there was a large, white SUV with large, bright, shiny rims on it that was driving forward and then backing up over and over again in the Aldi's lot. He stated that there were three, young, black females standing on the passenger side of the truck. He stated that shortly after his arrival, the truck left driving southbound on South 13th Street.

LANGE stated that he was walking towards the Camelot when a police car arrived, and the officer asked him, "Where's the fight?"

LANGE stated that he told the officer that he did not know where the fight was and continued walking into the club. He stated that as he was walking to the club, he passed a W/M who was walking out of the club. He stated that the W/M talked to the police officer and that he went into the bar. He stated that the bartender told him that the bar was closed and that he immediately exited the bar. He stated that he was then stopped again by the police who asked him to remain and speak with Detectives.

HERNANDEZ-BAKULA informed me that JOHNSON's blood covered shirt had been left behind at the scene and that she (HERNANDEZ-BAKULA) had thrown it into a garbage can. HERNANDEZ-BAKULA indicated a garbage can located on the southwest corner of the store, and I looked in the garbage can and saw a light-colored button down shirt.

Located in the Aldi's parking lot was a black wig and a black sock. Additionally, there was some hair braids that were located slightly north of the wig and another hair braid/extension located next to the sock.

There was a black slip-on shoe on the top of the steps leading up to the bar on the far north portion of the steps. Additionally, there was a broken part of a hair clip on the first step down and a second broken hair clip found next to the curb. Lastly, a bottle of Remmy Martin Cognac was recovered from a shelf on the west end of the bar within arms reach of the stage.

I recovered all of these items and placed them on Milwaukee Police Department inventory #364625 marked as evidence.

The black wig found in the Aldi's lot was item #6. The black sock was item #7. The hair extension located slightly north of the wig was item #8. The hair extension located directly next to the sock was item #9. The hair clip located on the step of the bar was item #10. The shoe was item #11. The shirt was item #12. The hair clip found on the curb was item #13. The bottle of Remmy Martin Cognac was item #14.

At 1:12 a.m., Detective LOUGH and myself then responded to 2534 North 34th Street, so he (Detective LOUGH) could re-interview HILLARD.

At 1:43 a.m., Detective LOUGH and myself then responded to MONTREY's residence, 3610 West Custer Avenue, #3. Once there, I spoke to MONTREY's brother, Roy T. LEWIS, B/M, DOB 04/08/88, who also resides at 3610 West Custer Avenue, Apartment #3. LEWIS informed us that his sister was not home and that she should be dancing at the club. LEWIS stated that he did not know where she could be found.

LEWIS informed us that his parents' address was 1736 West Congress. Squad 70 (Police Officer Edmund FITTING, P.S.#015292 and Police Officer Thomas SLOWINSKI, P.S.#017114) then responded to 1736 West Congress Street and spoke to MONTREY's mother, Sabrina R. LEWIS, B/F, DOB 08/17/70.

As Officers FITTING and SLOWINSKI were speaking with Sabrina LEWIS, Detective LOUGH and myself learned from Roy LEWIS that MONTREY has a girlfriend, Toccara T. BRELOVE, B/F, DOB 09/25/85 that resides at 4813 West Medford. At 2:22 a.m., Detective LOUGH and myself then responded to that location.

Detective LOUGH then spoke to BRELOVE who stated that she had heard from MONTREY earlier in the evening; however, she (MONTREY) was not at the residence on Medford.

Detective LOUGH and myself then began to return to the Criminal Investigation Bureau; however, we were contacted by Squad 70 who informed us that while they were at the 1736 West Congress address, MONTREY called from her cellular telephone telling her mother (Sabrina LEWIS) that she (MONTREY) was home at 3610 West Custer Avenue, #3.

Squad 70, Detective LOUGH and myself, then responded back to 3610 West Custer Avenue, Apartment #3. Once again, we spoke to Roy LEWIS who again informed us that his sister

This report is dictated by Detective Sebastian RACLAW, assigned to the Criminal Investigation Bureau, Early Shift.

On Tuesday, February 20, 2007, Squad 118 Early, Detective RACLAW, was sent to Froedtert Hospital to meet Squad 282, Police Officer Todd CLAUSER, regarding a Battery/Cutting investigation.

Upon arrival I spoke to Squad 282 Early, Police Officer CLAUSER, who related that he was sent to a Battery Cutting at 10:16 p. m., at 2714 S. 13th St., along with Squad 24 Early, Police Officer Arturo BURGOS, and Squad 25 Early, Police Officer Tommy WILSON, SR.

Preliminary investigation by Squad 282, Police Officer CLAUSER, revealed that a Substantial Battery had, indeed, occurred at 9:50 p. m., at 2714 S. 13th St. Squad 121 Early, Detective Mattew GOLDBERG and Detective Paul LOUGH, were sent to 2714 S. 13th St. and will be filing a Supplementary report regarding the scene of their investigation.

Squad 282, P.O. CLAUSER, related that MFD Engine 31 was on scene at 2714 S. 13th St. The Commanding Officer was Lieutenant GILISH, Red Shift. P.O. CLAUSER further related that he followed MFD Med Unit #15, who conveyed the victim to Froedtert Hospital.

#### **INTERVIEWOF LASHAM. JOHNSON**

I then conducted an interview of Lasha M. JOHNSON, B/F, DOB: 12/21/85, of 6405 N. 56th St., phone no. 737-8729, employed by the Camelot Strip Club, located at 2714 S. 13th St., and Quad Graphics through Staff Works Temporary Service, located in Hartford, Wisconsin.

JOHNSON states that on today's date, she was working at the Camelot Strip Club located at 2714 S. 13th St. JOHNSON stated that she has been employed with the Camelot Strip Club as a dancer for approximately 6-7 months.

JOHNSON stated that on today's date, a new dancer was working tonight identified as "Red". It should be noted "Red" was later identified to be Raeshonda S. MONTREY, B/F, DOB: 4/27/86, of 3610 W. Custer.

JOHNSON stated that at approximately 8:45 p. m., another one of the dancers in the club identified as "Baby Doll" told MONTREY, "Can somebody cut the radio on". JOHNSON stated this meant the radio needed to be turned on for the music. JOHNSON stated that "Red" did turn on the music. "Baby Doll" then stated, "Can you cut it down a little bit, but not all the way". "Red" then replied, "You want the radio cut down, then you cut it down yourself". "Baby Doll" was seated at the end of the bar, by the Men's room along with "Miss Lexus" and the victim JOHNSON. "Baby Doll" was later identified as Carolyn L. WILLIAMS, B/F, DOB: 3/2/79, of 1534 W. Wright and "Miss Lexus" was later identified as Alexis E. HERNANDEZ-EAKULA, W/F, DOB: 11/13/82, of 2830 W. Wisconsin Ave.

WILLIAMS states to MONTREY, "Who you talking to?" and MONTREY responds back, "You are disrespecting me". At this time an argument ensues between the two of them and the bouncer who is identified as Tyrone, and HERNANDEZ who is the bartender, step in to break the fight up between WILLIAMS and MONTREY. MONTREY was told by the bouncer that she needed to leave and MONTREY then went downstairs and put on her shoes. JOHNSON went downstairs and followed and told MONTREY that she should just go home and it was not worth losing her job over. MONTREY responded back, "I know it's not, bitch". At this time JOHNSON responded back, "Don't be calling me out of my name," and continue to exchange words, and it was at this time that MONTREY went upstairs to the bar area.

MONTREY jumped up by the bar and grabbed a bottle of Remy Green (phonetic) and began to chase WILLIAMS with the bottle swinging at her. WILLIAMS was not struck by the bottle. The bouncer Tyrone and the bartender HERNANDEZ again stepped in and broke the fight up. MONTREY then left the bar. An unknown female customer stated that MONTREY was then sitting in her car in the parking lot. At this time JOHNSON stated that she observed MONTREY outside of the car yelling and screaming outside of the club. JOHNSON stated that she was standing with the bouncer Tyrone in the front entrance area. JOHNSON stated that there is two entrance doors to the establishment and she was standing in between these two doors on the building. The entrance door to the establishment is on the west wall of the building facing S. 13th St.

JOHNSON stated that a newer model Cadillac, tan in color, tan interior, then pulled up in front of the night club. MONTREY approached the car and opened up the passenger door and entered the vehicle. JOHNSON stated that she observed MONTREY open up the visor looking for something. JOHNSON staled someone screamed to MONTREY, "Just go ahead and go with your pimp". JOHNSON stated that MONTREY replied back, "There's a difference between a pimp and a daddy". JOHNSON stated that she continued to see MONTREY and the unidentified driver talking to each other. JOHNSON stated that MONTREY then exited the auto and entered the strip club. JOHNSON stated that MONTREY then states something to the affect, "I can't have my job back, I can't have my job back".

JOHNSON stated as MONTREY is entering back into the club, she's swinging an unknown object in one of her hands. JOHNSON states that she doesn't know what the object is and it is at this time JOHNSON is now facing the exit door. JOHNSON said her back was to the exit door and that MONTREY was in front of her facing the establishment. JOHNSON stated that the two are now in the club between the two entrance doors.

JOHNSON stated that they are looking at each other and it is at this time that MONTREY then intentionally stabs JOHNSON to the back twice. JOHNSON stated that she reaches towards her back and is able to struggle and gain the knife from MONTREY. This causes a cut on JOHNSON'S right hand between her thumb and index finger. JOHNSON stated that at this time, MONTREY begins to struggle with her in an attempt to regain control of the knife. JOHNSON stated that she refused to let go of the knife and that MONTREY was grabbing her hand causing the knife to go up and down. This caused JOHNSON to obtain an abrasion to her left breast area from the knife. JOHNSON stated that she believed the knife was approximately 6"-8" long and could not provide any further details to the weapon. JOHNSON stated that during

this struggle, she stated to MONTREY, "You're cutting me, you're stabbing me". JOHNSON stated that MONTREY then lets go of the knife and the knife possibly falls to the ground and MONTREY then leaves.

JOHNSON stated that the driver of the auto then states to JOHNSON, "She stabbed you, are you okay?" JOHNSON describes this subject as being a B/M, unknown age, 5'11", 300 lbs., heavy set, wearing a striped shirt, short sleeve, with red, blue and white, and blue jeans. JOHNSON stated that this subject then also disappears. JOHNSON says that the employees of the strip club then bring her into the club and it is at this time that she begins to feel dizziness and numbness to her leg. JOHNSON stated that the employees then called 9-1-1.

Milwaukee Fire Department Engine 31 responded to the scene, Lieutenant GILISH, Red Shift. MFD Med Unit #15 conveyed JOHNSON to Froedtert Hospital for treatment. admitted at 10:51 p. m., and was treated by Dr. Tomer BEGAZ. JOHNSON sustained a 3" laceration to the small of the back causing pain and requiring seven stitches and one long stitch, for a total of eight stitches to close the wound. Squad 386, Identification Technician Scott KEMPINSKI, responded to the scene and took photographs of the injuries.

JOHNSON stated this is the first time that she had met MONTREY. JOHNSON stated that MONTREY has been working at the club for approximately one week, but this is the first time in which they were scheduled for the same night. JOHNSON stated that she could identify both the driver of the auto and MONTREY if she were to see these persons again. JOHNSON stated that she wished prosecution. JOHNSON stated that she fears retaliation if she were to cooperate in this investigation. JOHNSON feared for her 1 1/2 year old daughter regarding this incident.

This report was dictated by Detective Paul LOUGH, assigned to the Criminal Investigation Bureau, Early Shift, Squad 121. On this date, my partner was Detective Matthew GOLDBERG.

On Tuesday, 2/20/07, at 10:52 PM, Squad 121 was dispatched to a stabbing at 2714 South 13th Street. Upon arrival, I did interview several witnesses.

#### INTERVIEWWITH WITNESS, ALEXIS E. HERNANDEZ-BAKULA

I then proceeded to interview a witness to this offense who identified herself as Alexis E. HERNANDEZ-BUKULA, H/F, dob 11/13/82, address of 2830 West Wisconsin Avenue, phone number 322-5769. HERNANDEZ-BUKULA is a bartender at the Camelot Exotic Dance Club located at 2714 South 13th Street. Alexis states that her alias is "LEXIS." HERNANDEZ-BAKULA has been employed at the Camelot since November.

Regarding this incident, she allowed a dancer name Red, who normally works day shift, to do a double shift. She stated the day shift is usually from 2:00 PM to 8:00 PM, however, she let her work until close on this date. She stated that Red was just hired last Friday. HERNANDEZ-BAKULA identified Red by her work application form as Raeshonda S. MONTREY, B/F, dob 4/27/86, address 3610 West Custer, apartment 3, phone number 202-4158.

She stated that Red walked behind the bar and turned up V100 very loud. She stated another dancer, who works at the bar, who she knows as "Baby Doll," asked Red to turn it down. Red then stated to Baby Doll, "You can turn it down yourself." Baby Doll asked her why she's being disrespectful and stated, "It's to loud while there is no customers in here." Red then called Baby Doll a "bitch." She stated they started arguing then the bouncer came and broke it up. HERNANDEZ-BAKULA stated that the bouncer then took Red downstairs to calm her down.

Red then came back upstairs and turned the radio back up. She stated she grabbed a bottle of Ramy Cognac and chased Baby Doll around the bar and tried to hit her with it. She stated the bouncer then kicked Red outside of the bar. Red was now outside yelling profanities and making threats to the girls inside the bar. HERNANDEZ-BAKULA stated that she called the daytime manager that she identified as Amy, and Amy told her to tell Red that she was fired. HERNANDEZ-BAKULA yelled outside to Red several times that she was fired.

The bouncer then began letting other customers in, which included some dancers from Tommies that HERNANDEZ-BAKULA recognized as Eva and Chocolate. HERNANDEZ-BAKULA was now behind the bar cleaning. She stated that the victim of this incident, who she identified as a girl named Paris, now came running back inside saying that she had been stabbed. Paris was bleeding profusely and HERNANDEZ-BAKULA, who is also a nurse, grabbed a bar rag on the end, attending to her wound. HERNANDEZ-BAKULA stated she did not know why Paris was stabbed, as Paris was helping the bouncer in his attempt to try to calm Red down and separate Red from fighting Baby Doll. Paris was bleeding in her back to her lower left spine, approximately three inches away from her spine. Paris was stating that she could not feel her legs. HERNANDEZ-BAKULA stated she did not see the stabbing, and she did not see Paris and Red involved in a physical altercation.

#### INTERVIEWWITH WITNESS, MIKO M. MINER

I then proceeded to interview another witness to this offense who identified herself as Miko M. MINER, B/F, dob 8/16/81, address of 2419 North 23rd Street, phone number 763-8565. MINER's alias is Heaven, and she has worked as a dancer at the Camelot Inn since November. Regarding this incident, MINER stated that she knows a dancer named Red, that she met her last Friday at the Camelot Dance Club. That was the first time she saw Red; the second time was tonight. She described Red as a black female, 22-23 years old, 5'5", chubby build, light skin, with micro braids in her hair. Regarding this incident, MINER heard a commotion in front of the bar. She said she was in the back changing. She stated she observed the bouncer pushing Red towards the bar telling her to calm down. Red was yelling threats back and saying, "I'm not leaving; I'm calling somebody else to help me kick you bitches' ass. She stated that Red was now outside the bar and that she, MINER, was in the back doing a lap dance for a customer. She stated that Red ran right into the bar, as the bouncer was not guarding the door anymore, and immediately attacked an exotic dancer that she knows as Paris. She stated that Paris and Red were now in a physical altercation, which they were hitting each other, and she observed Paris move as if she were hit in the back. She then heard Paris yell, "This bitch just stab me." She stated that Alexis was behind the bar when this happened and ran over and began tending to Paris' wound. She stated that she grabbed her stuff and was getting ready to leave. She stated in the commotion she did not see where Red went, that she observed the other girls tend to Paris' wound.

MINER stated that she could identify Red either through a line-up or a photo array.

#### INTERVIEWWITH WITNESS, TEMEKA S. WHITE:

I then proceeded to interview another witness to this offense who identified herself as Temeka S. WHITE, B/F, dob 7/11/79, address 1700 South 4th Street, phone number 384-5835. WHITE is also known by her stage name of Ecstasy.

WHITE stated she's been an exotic dancer at the Camelot for approximately three years, that she first saw the suspect in this offense, Red, approximately two weeks ago at the Camelot. She stated she has seen Red twice. She described Red as a black female, 20 years old, 5'5", chubby build, light skin with micro braids. She stated that Red was up on the stage dancing. and that when she exited the stage, she turned the radio up very loud. One of the other dancers, who she identified as Baby Doll, stated, "Can you turn that down." Red then stated back (disrespectfully) to Baby Doll, "Turn it down yourself." WHITE stated she was up by the bar, and she didn't really want to be involved; she just got herself a drink, which was a glass of grey goose. She stated that Red went behind the bar and grabbed a bottle of Ramy Cognac and began chasing Baby Doll around the bar with the Ramy. She stated that bouncer then threw Red up against the wall and that she went and grabbed the Ramy bottle from her. She said the bouncer then put Red outside the bar. Red was outside the bar yelling threats to the girls inside.

WHITE then went to the back of the bar where she began giving a customer a lap dance. Then heard a commotion towards the front of the bar, and she heard one of the bouncers that she knows as Paris yelling, "That mother fucker stabbed me." She observed Paris bleeding.

and that Alexis came out from behind the bar and put pressure to the wound. She believed that Paris was possibly stabbed with an eyebrow roller or a box cutter, because of the way the wound was. WHITE further stated she did not see the stabbing occur, and that she only heard Paris say that Red was the person who stabbed her. She stated she could identify Red through a line-up or a photo array.

#### INTERVIEWWITH WITNESS, MARCELLA HILLARD

I then proceeded to interview another witness to this offense, who identified herself as Marcella HILLARD, B/F, dob 1/2/79, address of 2534 North 41st Street, phone number 759-7655. HILLARD is a dancer at the Camelot Strip Bar, and she is known as Eve.

Regarding this incident, Eve stated she arrived at the bar with another dancer that she knows as Chocolate. As they walked in the front, they observed a female standing in front of the bar crying and yelling profanities. She stated a girl they know as Alexis was also by the front door. They briefly talked to the girl who was yelling and then they went inside the bar. She denied knowing this girl that was standing out there, and she only thought to see what was wrong with her. She was standing by the front door. HILLARD stated that she observed the victim who had stabbed Paris then go outside and fight Red in the parking lot across from Aldi's. She stated she observed them in a physical altercation in which they were swinging their hands at each. She then observed the girl, who was outside crying, stab Paris and Paris was bleeding all over. HILLARD stated that she could identify the suspect in this offense either through a photo array or line-up. She stated it all happened very fast and that Paris ran back into the bar where Alexis cared for her.

I was then approached by Police Officer Tommy WILSON, who informed me that he heard HILLARD state that the only reason that she came down here was because one of the owners of the bar called her and told her to come down here, and she stated she saw the stabbing outside. Detective GOLDBERG and I then relocated to HILLARD's address at 2534 North 41st Street where we re-interviewed her regarding this offense. HILLARD stated that the stabbing and fight did take place outside in the Aldi's parking lot, and the only thing she neglected to do was to tell us that the suspect stabbed Paris, and that Paris, Baby Doll, and one other girl approached the girl who had ultimately stabbed Paris outside in Aldi's lot. She stated they proceeded to jump her, and she sustained several injuries during this altercation. She stated that the right side of her face was swollen, and she was limping as she fell to the ground. She stated this girl then got up to her feet and wrapped her arms around Paris and stabbed her in the back. She stated there were several other girls standing in the front door of the bar watching with her. She stated the girl, suspect in this offense, then got inside of a Cadillac truck, which she believed to be the truck belonging to her pimp. She then fled the scene. HILLARD apologized for not being completely truthful from the beginning regarding this offense, but she was worried about speaking to me regarding the girls jumping the suspect in this offense. She did not want them to know that she was snitching. She stated she possibly would have to dance at the same bar they work at, and she does not want any drama between them. HILLARD stated that she could identify the suspect in this offense through a photo array or line-up.

#### INTERVIEWWITH BARMANAGER, DONN J. BARK

I then proceeded to interview the manager of the Camelot Inn, Donn J. BARK, W/M. dob

3/25/57, address 2064 South 56th Street, West Allis, WI, phone number 510-7101. BARK was not present during this incident. I explained to Mr. BARK that a stabbing had occurred, but we are getting conflicting stories as to the location of the stabbing. I told him some witnesses stated the stabbing occurred inside the bar, and some stated that it occurred outside in Aldi's parking lot. BARK did not have any comments, but asked if he could know what's going on. stating, "Is there going to be a tavern report issued?" I explained to him since the altercation did start inside the tavern, a tavern report would be filed. BARK then asked if I would talk to the license holder, and I stated I would. BARK then called the license owner on a cell phone, and I then spoke to the license owner on BARK's cell phone. The license owner identified himself to me as Terry J. CULLEN, W/M, dob 9/29/49, address of 3401 South 16th Street, cell phone number 406-9997. I explained to CULLEN what happened, and that we had received some conflicting stories as to what happened in the bar tonight. CULLEN stated to me that he got a hold of a dancer named Eve, and she told him that she observed everything. He stated that she said to him that she observed the stabbing occur outside the bar and that he paid for her to take a cab down to tell us exactly what happened. CULLEN was then wondering if a tavern report would be filed. I told him that a tavern report was going to be filed. CULLEN stated he is the license's holder and that the owner of the bar is out of state. I asked CULLEN how he heard about what happened, and he stated that one of the girls called him from the bar. I asked him what time, and he stated he couldn't check on his cell phone as to what time he received the call, as he has received more than ten calls since then. He stated that he is to excited about what had happened to be able to recall the exact time he received the phone call.

I then showed JOHNSON the photo line-up using the "folder method," one folder at a time. I did this after reading her the instructions on the supplemental report on Photo Array Identification Form.

JOHNSON then view each folder, circling the "No" on the bottom of the corresponding number for folders no. 1 through 5. JOHNSON that circled the "Yes" underneath the corresponding number for folder no. 6, stating that was the person who had stabbed her.

JOHNSON stated that she was positive that this was the person who stabbed her, saying that she recognized her face from yesterday.

JOHNSON then changed what she had told Detective Sebastian RACLAW. the previous evening. She stated that she and the person in folder no. 6, had begun to fight while standing on the porch, leading up to the Camelot. She stated that she (JOHNSON) then faked saying, "Go ahead and hit her!"

JOHNSON stated that when the person in folder no. 6, then looked over in that direction, she (JOHNSON) punched her in the face. She stated that the person in folder no. 6 then grabbed her by the hair and that she grabbed her by the hair. She state the fight spilled across South 13th Street in to the Aldi's parking lot. JOHNSON stated that it was actually in the Aldi's parking lot, where she was stabbed by the suspect.

JOHNSON stated that the wig that was recovered by myself, in the Aldi's parking lot, actually belongs to her.

JOHNSON was then ordered into the District Attorney's Office on Friday, February 23, 2007 at 1:30 P.M.

I later returned to the Criminal Investigation Bureau, where I had the opportunity to inspect the folders. I then learned that the following photos were located in the following folders:

Folder no. 1, Marianna C. DIXON, (B/F<dob-11/2/90) booking photo no. 110703773.

This report is dictated by Detective Randall CHICKS, assigned to the Criminal Investigation Bureau, Late Shift.

On Friday, 2/23/07, at 8:10 AM, I conducted an interview with Raeshonda S. MONTREY, B/F, dob 4/27/86, in room 414 of the Criminal Investigation Bureau. Raeshonda MONTREY was in custody as the suspect for this offense. I read her the Miranda Warning. She stated that she understood her rights and agreed to make a statement at this time without a lawyer present. This interview was recorded using a digital audio recording device and transferred to CDR. Ms. MONTREY stated that she was employed as a dancer at the Camelot Gentlemen's Club at 2714 South 13th Street, and that she was working as a dancer at that location on 2/20/07. Regarding the incident that occurred there, she stated that she had just finished dancing and was walking off the stage when another dancer asked her to turn the radio on, so she did. The same dancer then asked if somebody would turn the radio down. Ms. MONTREY states that she told that dancer that she should do it herself and that response angered the other dancer, who said Ms. MONTREY was disrespecting her. That other dancer also threw an ashtray at Ms. MONTREY starting a fight between the two of them. A large bouncer told both of them to stop and pushed both of them. The bouncer also told both of the dancers to go home. MONTREY states that she believed this to mean she was fired, and she started to question the bouncer as to why she was fired. She did go downstairs to the dressing room to change clothes. While she was in the dressing room, another dancer known to her as Paris said something to the effect of "no one can hit my cousin." Ms. MONTREY states that she believes the girl she was fighting with upstairs is Paris' cousin. MONTREY states she went upstairs without getting dressed, and once she was upstairs, the girl she originally argued and fought with threw a shoe at her and a drinking glass. Ms. MONTREY states that she then pick up a bottle of Remy and started chasing that girl around the club with it. The girl whom she had originally argued and fought with then threw a bottle at her hitting her in the head. At that time, the security guard grabbed Ms. MONTREY and pushed her down injuring her right thumb. The security guard then held her down while the girl whom she had originally fought with continued trying to hit her. Ms. MONTREY states that at this time, she was still in her stage clothes, which consisted of a negligee. The bouncer pushed her outside onto sidewalk. She walked back inside of the club and asked the bouncer if she could go downstairs and get dressed and use a phone. She reminded him that it is a violation of the law for her to be outside the strip club in her stage clothes. The bouncer refused and locked her outside. At that time, a stranger walking by allowed Ms. MONTREY to use his cell phone. She called one of her friends and asked her for a ride. She noticed another dancer, known as "Exotic," who was trying to "turn a trick," in the Aldi's parking lot. For reasons unknown, the man that Exotic was with drove away without her. Exotic then approached Ms. MONTREY and accused her of "running off the trick." Ms. MONTREY and Exotic had a fight in the Aldi's parking lot. Another girl came and broke it up, and Exotic went back inside of the club. A girl wearing a curly blonde wig, who's name Ms. MONTREY does not know, came outside and warned her that the other girls inside the clubs were putting eight-balls in socks, presumably to be used as weapons. Ms. MONTREY states

that she did not know what the girl meant by eight balls because there is no pool table in the Camelot. Four to five girls then came out of the Camelot and confronted Ms. MONTREY in the Aldi's parking lot. The girl, whom she had originally fought with, was armed with a knife. That girl's cousin, Paris, and two other girls were armed with stockings that had heavy objects placed inside. The girls all began to beat Ms. MONTREY with the stockings and during the struggle the girl with the knife dropped her knife. Ms. MONTREY states that she picked up that knife and started waving it to defend herself. One of the girls said that she was cut. At that time, all of the other girls went back inside of the club. Ms. MONTREY states that a stranger then offered her a ride home. She got into that man's silver Cadillac, and he drove her to his home, which is the lower unit of a duplex somewhere on the eastside. She remained at that man's house overnight. On 2/22/07, she went to Columbia Hospital and was treated for the injury to her thumb. She stated that she was diagnosed with a fracture to her thumb and was advised that she needed to see a specialist. The hospital did provide her with the x-rays taken during that visit. Regarding the man who gave her a ride and provided her with a place to stay that night, she states that she only knows him by his nickname, "Heavy." He is a black male, in late 40's. She states that she does have his telephone number programmed into her cell phone, however, her brother, Roy LEWIS, had her cell phone in his possession when he was arrested last night on arrest warrants by Milwaukee police officers.

I observed that Raeshonda MONTREY had what appeared to be a splint on her left hand and wrist. There was also visible bruising to her head near the right temple and an abrasion to her chin. She stated that these are injuries, which she received during this incident.

This report was written by Detective Daniel WILCOX, assigned to the Vice Control Division -Anti Prostitution Unit (Plain Clothes).

On Fri. 06-15-07 at 8:50 p.m., Det. John KUSPA and I investigated complaints of dancers/strippers at the Camelot Lounge, located at 2714 S. 13th Street engaging in prostitution. The Camelot Lounge offers live entertainment consisting of "topless" female dancers/strippers.

At this time Det. KUSPA and I entered the tavern in an undercover capacity. After being searched and frisked by the doorman/bouncer and paying the non-posted \$7.00 "cover charge". both Det. KUSPA and I sat at a table near the bar. We observed a dancer/stripper, later identified as Janie M. REED (B/F 04-11-77) dancing topless on a small stage behind the bar and walking across the top of the bar soliciting "tips" from male patrons, as music played on the jukebox. After completing her "dance set", REED began moving throughout the public area of the tavern soliciting "tips" from male patrons, by performing body gyrations close to the patron until he offered her money. REED was wearing a sheer pink and blue top with matching string thong underpants and 6" high-heel shoes.

REED approached Det. KUSPA and performed body gyrations close to him. We observed that REED had nothing covering the nipple and areola of her breasts and her "thong" underpants did not cover the cleavage of her buttocks. REED then opened the front of her top, exposed both of her breasts to our view and began caressing her breasts with her hands. REED then turned away from Det. KUSPA and sat down on his lap and began rubbing her buttocks against the groin area of his pants for in excess of three minutes. Det. KUSPA offered REED a tip, which she accepted then moved around the table and approached me. REED began dancing and performing body gyrations close to me then sat on my lap and began rubbing her buttocks against the groin area of my pants, with her breasts exposed, for in excess of two minutes. I offered REED a tip, which she accepted then moved on to another patron and repeated the "lap dance" she performed on both Det. KUSPA and I. After this, REED sat alone at the bar.

I approached REED and offered to buy her a drink, which I did. REED introduced herself as "Candy" and I asked her if there was a private area inside the tavern where she could perform a "private dance" for me. REED told me "I'll dance for you right here." I handed REED a \$20.00 bill, which is the usual and customary charge for a "private dance". REED opened the front of her top and began dancing and performing body gyrations close to me, as I remained seated on a barstool at the bar. REED groped the groin area of my pants, using both of her hands, as she

stuck out her pierced tongue and wiggled it at me. REED then pulled down the front of her underpants, exposed her vagina to my view and began stroking it with her hand while continuing to dance and wiggle her tongue at me. REED then turned away from me, bent forward at the waist then pulled her underpants down and exposed both her anus and vagina to my view while continuing her body gyrations. REED then backed up and began rubbing her buttocks against the groin area of my pants.

As the song from jukebox ended, REED concluded her dance and sat down next to me at the bar. I asked REED, "Do you get into any one on one action outside the club?" REED responded, "If you want to party with me, I don't come cheap?" Based upon my training and experience, I know the term "party" to mean engaging in an act of prostitution. I asked REED, "I'm willing to pay but what do I get?" REED responded "Pussy" then began rubbing her vagina over her underpants. Based upon my training and experience, I know the term "pussy" to mean non-marital sexual intercourse. REED stated "I'll write down my cell phone number and you give me a call." REED went to the bathroom and upon returning, surreptitiously handed me a cocktail napkin bearing the handwritten name "Candy" and the telephone # 414-419-7209. REED told me that she didn't work on Monday's and encouraged me to call her.

At this time another dancer/stripper "Ecstasy", later identified as Lachisa M. BRIDGES (B/F 09-12-77) approached Det. KUSPA wearing a sheer red top and matching string thong underpants and 6" high-heel shoes. We observed that BRIDGES had nothing covering the nipple and areola of her breasts and her "thong" underpants did not cover the cleavage of her buttocks. BRIDGES began performing body gyrations close to Det. KUSPA and opened the front of her top exposing both of her breasts to our view then began caressing her breasts with her hands. BRIDGES then turned away from Det. KUSPA and sat down on his lap and began rubbing her buttocks against the groin area of his pants for in excess of two minutes. BRIDGES then asked Det. KUSPA if he was interested in a "private dance" from her. Det. KUSPA agreed and BRIDGES led him to a chair located in the rear of the tavern.

As the music played on the jukebox BRIDGES again began performing body gyrations close to Det. KUSPA and opened the front of her top exposing both of her breasts to his view then began caressing her breasts with her hands. BRIDGES then turned away from Det. KUSPA and sat down on his lap and began rubbing her buttocks against the groin area of his pants. BRIDGES then turned and faced Det. KUSPA and pulled the front of her underpants aside, exposing her vagina to his view. BRIDGES then spread her vagina apart, pulling her labia apart with her fingers, and masturbated her vagina with her fingers in front of Det. KUSPA. BRIDGES continued this activity for the duration of one song (approximately 3 minutes). Upon completion of this "private dance", Det. KUSPA paid BRIDGES \$20.00 then asked her if she performed "private shows" outside of her employment at the Camelot Lounge. BRIDGES indicated she did then retrieved a pen and paper and wrote down Det. KUSPA'S telephone number and told him she would call him when she was available.

While inside the tavern, we observed five other female dancers/strippers (either performing on stage or moving throughout the common areas of the tavern) none of whom wore costumes that covered either the cleavage of their buttocks or the nipple and areola of their breasts.

At approximately 9:45 p.m., Det. KUSPA and I discontinued our investigation and departed the tavern premises.

On Mon. 06-18-07 at 6:17 p.m., I telephoned REED, using the number she supplied to me. I spoke to REED and she stated that she remembered me and was interested in meeting me to "party". I reminded REED that she told me that she wasn't "cheap" and asked her what she would charge to party with me. REED stated, "I charge \$150.00 and that's all inclusive." Based upon my training and experience, I know the term "all inclusive" to mean that she did not charge extra for additional sexual acts/services. I told REED that I would get a hotel room then call her back with the location of the hotel and the room number.

At 7:42 p.m., after obtaining a hotel room at the Hospitality Inn, located at 4400 S. 27th Street, I telephoned REED and told her I was in room #130. REED agreed to meet me at my room in approximately 30 minutes.

At 8:14 p.m., I received a telephone call from REED, who stated that she was at the hotel. I directed REED to my hotel room and invited her inside. I offered REED a drink, which she accepted, then offered her the \$150.00 that she had requested. REED stated "Just put it down there", pointing to the top of the television in the room. REED began removing her clothing then laid on the bed, wearing only her underpants. I asked REED, "Did you bring any condoms with you?" REED responded, "I thought you had some." REED stated "I'll give you some head without a condom but you will have to go get one if you want sex." Based upon my training and experience, I know the terms "head " and "sex" to mean mouth to penis sexual gratification and non-marital sexual intercourse. REED was arrested for prostitution, with the assistance of Det. KUSPA, and later conveyed to the Prisoner Processing Section. During a custodial search, I recovered REED'S cellular telephone (414-419-7209) which was later placed on Inventory #380687.

Det. KUSPA spoke to REED who admitted to offering to engage in sexual intercourse and sexual gratification, in exchange for \$150.00.
