Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. 2. On 05/03/2014 a 20 year old Milwaukee police aide, working in conjunction with Milwaukee police, attempted to gain entry to Hosed On Brady (1687 North Franklin Place), but was turned away when she could not produce proof she had attained the legal drinking age of 21.
3. On 02/19/2015 a Milwaukee police officer provided the bartender, Zachary Ihlenfeld, at Hosed on Brady (1689 North Franklin Place) with a packet of tavern related ordinances and discussed the business's procedures to ensure these ordinances are not violated.

4. On 03/08/2015 a 18 year old Milwaukee police aide, working in conjunction with Milwaukee police, was able to enter Hosed on Brady (1689 North Franklin Place) without displaying any identification. Once inside, the aide was able to purchase a Miller Lite brand beer from the bartender. The applicant was cited for Underage on Premise and Sale of Alcohol to Underage Person. Neither citation (#61564311 & #61564322) appears in the City of Milwaukee Municipal Court Case Information System.

7. On 03/30/2017 officers conducted underage tavern enforcement in District 1. An underage Police Aid attempted to gain entry to Hosed on Brady, 1689 N. Franklin Pl. The Police Aid was denied entry by security at the door.

8. On 11/29/2017 officers were dispatched to a hold up alarm at Hosed on Brady, 1689 N. Franklin Pl. The officers spoke with the victim who stated he was outside smoking a cigarette when he was approached by a subject asking for a cigarette. The victim stated he did not have anymore because he left them inside. The suspect then lifted his shirt, displaying a gun in his waistband. The victim went inside and told the bartender what happened and the bartender his the holdup alarm. The suspect then came in and hit the victim once to the head with a closed fist. The suspect then fled. The applicant stated the cameras were functioning but not recording. The bar then called bad stating they were able to recover the video.

9. On 11/29/2018 officers conducted underage tavern enforcement in District 1. An underage Police Aide attempted to gain entry to Hosed on Brady, 1689 N. Franklin Pl. The Police Aide was allowed entry and ordered a Miller Lite for \$4.00. The bartender, Zachary IHLENFELD was issued a citation. The manager was informed of the failure.

10. On 01/01/2020 at 7:33pm officers were dispatched to a Trouble with Subject call at Hosed on Brady, 1689 N. Franklin Pl. The officers interviewed the bartender, who stated a female came into the bar acting strangle. She than placed some items on a table and asked to use the restroom. The female attempted to go into the men's room several times, even after being advised to not use that bathroom. The female was disorderly with other patrons causing them to fear for their safety. A customer who is a registered nurse thought the woman was having some type of crisis. The woman grabbed onto the female nurse by her neck and kissed her. The bartender tried intervene and was struck in the face as he pushed the female out the door. The officers located the subject issued he citations and conveyed her to the hospital for medical evaluation.

## Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
  - a. Include only information relating to the above license application.
  - b. Include only information you have personally witnessed or seen.
  - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
  - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.

**Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.**
