## Dear Alderman Brostoff:

This is in response to your request on behalf of Thermo Fisher Scientific located at 2202 North Bartlett Avenue to install the above-captioned parking restriction.

Our traffic engineering staff has investigated this request and found that employees of Thermo Fisher Scientific exiting their employee parking lot on the north side of East Windsor Place have a difficult time seeing traffic traveling on East Windsor Place when vehicles park close to the driveway. Therefore, in the interest of public safety, we recommend installing this restriction to increase cross traffic visibility.

We will prepare the necessary legislation for the next Public Safety and Health Committee meeting, so that you may support it to final passage.
