The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 11/11/2016 officers responded to Tobacco Deals, 8247 W. Brown Deer Rd, to investigate a complaint of the business selling single cigarettes. The officers observed several open boxes of cigarettes and cigars behind the counter. The applicant denied selling single cigarettes but after several customers asked for "a single" the applicant admitted he did sell them for 2 for \$1.00. The applicant was cited for Sell Cigarettes in Package/Container without Stamp.

The customer stated they purchased the single cigarettes from the store but refused to be a witness. The officer entered the store and spoke with the applicant who was working the counter. He denied selling single cigarettes. While on scene the officer observed three customers approach the counter and ask to buy single cigarettes. The applicant stated he knew it was a violation to sell individual cigarettes and requested the officer not write a citation.






This report is written by PO Penny BROWN assigned to the License Investigation Unit. On Friday, 11/11/16 at approximately 1:30p.m., PO Denise RUEDA and I conducted a license premise check at Tobacco Deals, located at 8247 W. Brown Deer Rd.

This was in regards to an anonymous complaint the establishment was selling single cigarettes for 2 for \$1.00. Officers introduced ourselves to the agent, Faisal A. SAMAD, and requested to see the licenses, which were valid and properly posted. I observed an open box of Newport 100's (5 remaining), an open box of Kool True Menthol 100's (7 remaining), an open box of Black and Mild Apple flavored cigars (4 remaining), an open box of Black and Mild Wood Tip Reg Flavor (4 remaining), and an open box of Black and Mild Wine flavored Wood Tip (4 left), all just beneath the cash register.

I asked SAMAD if he was selling single cigarettes, to which he initially denied. As officers were standing there, multiple customers entered the store asking for "a single". I advised SAMAD that he should be honest with officers, since it's pretty obvious he is selling single cigarettes. SAMAD admitted he does sell single cigarettes for 2 for \$1.00 and promised to stop. I advised SAMAD I would be issuing a citation for this violation.





This report is written by P.O. Denise RUEDA, assigned to the License Investigation Unit.

On Thursday, May 4, 2017 at about 1:25pm I conducted follow up at Tobacco Deal, 8247 W. Brown Deer Road, located in the city and county of Milwaukee, regarding an anonymous complaint of the establishment selling individual cigarettes.

On arrival at the location prior to entering the establishment I observed two b/f's wearing Wendy's uniforms (red polo shirt, black pants) enter the "Tobacco Deal" store and moments later exit the store with a single Newport 100 cigarette in their hand. As the two b/f's walked into the parking lot toward me I greeted them with a "hello" and asked them if they (b/f's) had just purchased the single Newport 100 cigarette in their hand from the Tobacco Deal store, they (b/f's) hesitated and subsequently responded with "yes", and further stated to me that they were not willing to be a witness to the individual cigarette sales because they did not want to get the store in trouble.

Thereafter I entered the Tobacco Deal store and introduced myself to the clerk who I recognized as the agent Faisal SAMAD (a/m, 04/27/79). My partner P.O. Penny BROWN and I were here for a complaint regarding the same individual cigarette sales on November 11, 2016. I P.O. RUEDA advised SAMAD of the reason for my visit at which time he denied selling individual cigarettes even after I told him that I had just talked with the two B/F'S that had just left his store who told me that they had purchased a single Newport 100 from him. While I continued with my license premise check I witnessed three different customers came into the store requesting to purchase individual cigarettes. I advised SAMAD that it was a violation to sell individual cigarettes and that I would be again issuing a citation for the violation. SAMAD stated to me that he was aware that it is a violation to sell individual cigarettes and asked me not to cite him this time.

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the above license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
 - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.
Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.

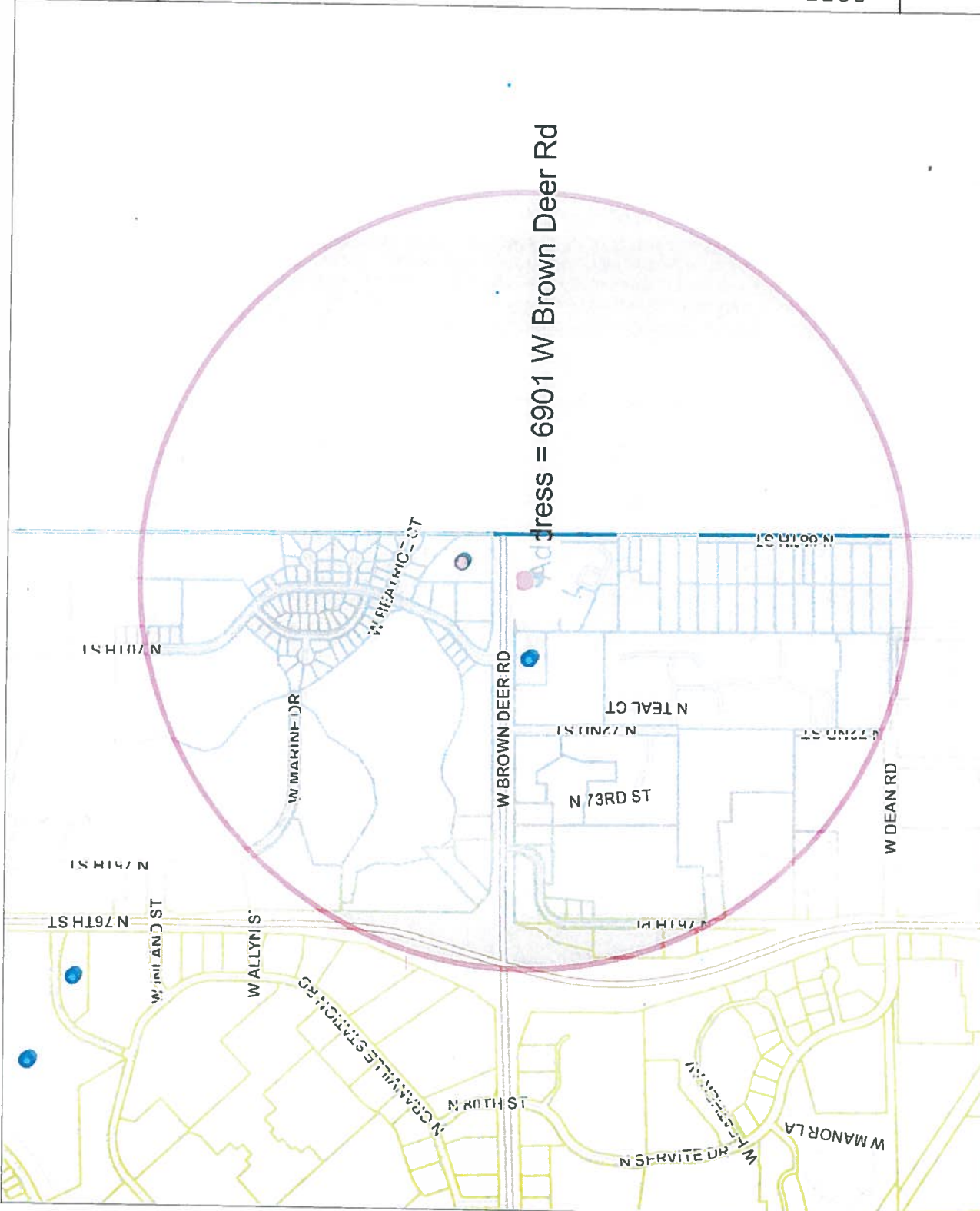
