

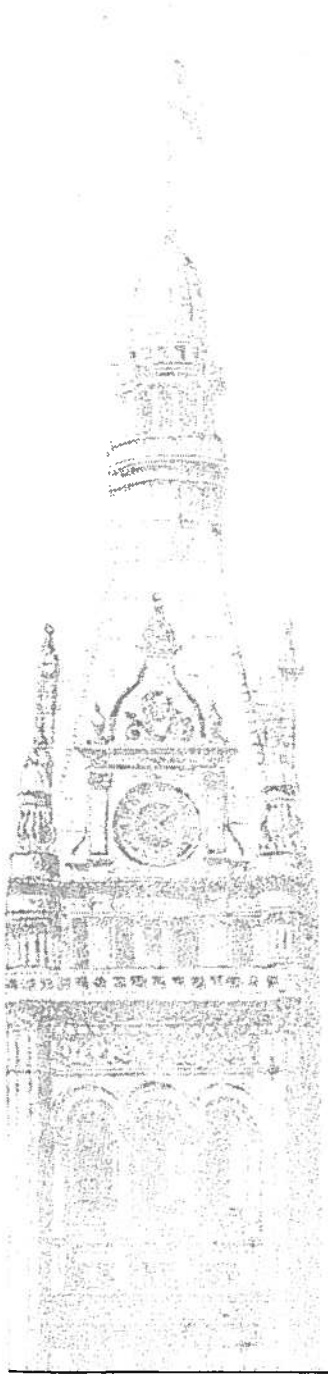

Re: Report of the Renewal Application of Howard J. Tice, Agent for "STP, Inc." for a Class "B" Tavern license for the premises located at 5526 West North Avenue in the City and County of Milwaukee, Wisconsin ("Narrow Lane").

FINDINGS OF FACT

1. Howard J. Tice (hereinafter the "Licensee") is the holder of a Class "B" Tavern license for the premises located at 5526 West North Avenue in the City and County of Milwaukee, Wisconsin ("Narrow Lane"). Said license expires at midnight, January 31, 2012.
2. An application to renew said license was filed with the Office of the City Clerk on October 28, 2011.
3. Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. The Milwaukee Police Department responded with a report that could form the basis of non-renewal or suspension of this license on October 31, 2011.
4. On December 19, 2011, the City Clerk's Office provided notice to the Licensee pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the police report that could form the basis for nonrenewal or suspension and included a copy of the police report. The matter was scheduled for a hearing on the police report on January 4, 2012, at 10:45 a.m. in Room 301B of the third floor of City Hall.



At said date, time and place the licensee did appear and was represented by Attorney Andrew Arena.

5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. On July 3, 2011, Milwaukee police responded to 5526 West North Avenue to investigate a tavern violation and suspicious activity. Police observed numerous cars parked in the area of 5526 West North Avenue and observed six people outside the front door to the Narrow Lane. Officers were aware that the capacity to Narrow Lane was 25 persons and police believed that there were more patrons in the establishment, thereby exceeding the posted occupancy limit. Police spoke with Tyrone Whigham, who is the manager, and Whigham stated that all building permits for the expansion of the tavern have been closed and that the city advised him that a new capacity placard would be sent to him in the mail but that he hadn't received it yet. A count was conducted and 47 patrons were found to be in the business. Further investigation found that the occupancy permit was applied for but had not been approved by the city yet. The licensee, Howard Tice, received a citation for exceeding posted occupancy limit at 5526 West North Avenue.
 - B. On July 9, 2011 at 12:33 a.m., Milwaukee police responded to 5526 West North Avenue for a trouble with subjects complaint. Investigation found a caller was complaining of motorcycles parked out front of the bar were reviving their engines causing a disturbance. The caller asked these subjects to stop but they did not. Officers spoke with Paul Whigham who stated his bar has been closed since 11 p.m., and that there were people outside the tavern on motorcycles attempting to get into the bar, but he told them he was closed. Whigham stated there were others on motorcycles riding up and down North Avenue, but they did not come from the bar.
 - C. On July 23, 2011 at 1:10 a.m., Milwaukee police conducted a License Premise Check at 5526 West North Avenue. The investigation found that the Commissioner of City Development had not yet approved an expansion area for this tavern and therefore no patrons were allowed in the new area. Police observed three patrons sifting at a table with drinks in the newly expanded area. Officers spoke

with Tyrone Whigham who acknowledged the fact that the patrons were in the area that had no occupancy and understood that no patrons should be in that area. The licensee, Howard Tice was cited for Certificate of Occupancy Required at 5526 West North Avenue.

- D. Neighbor Caryle Jinright, 2348 N. 57th St., testified that she is in opposition to the license due to noise from motorcycles, drunk patrons staggering out of the bar, vomiting by patrons, empty and broken beer bottles outside of the establishment, inoperable security cameras.
- E. Neighbor Anne McBride, 2355 N. 56th St., testified that she is in opposition to the license due to increased parking/traffic in the area, noise from the tavern and disorderly patrons.
- F. Neighbor Amy Turim, owner of business at 5601 W. North Ave., testified that she is in opposition to the license due to unruly patrons, loitering, verbal abuse of the staff of her business, noise from the tavern, trash on the sidewalk outside, vomiting by patrons going into the bar and drunk patrons. She says that the area is not an environment that is conducive to conducting business due to the problems at the tavern.
- G. Neighbor Naomi Cayce, 5529 W. North Avenue, testified in support of the license as she has not witnessed any problem activity at the bar.
- H. Neighbor, Elizabeth Gretz, 2441 North 59th Street, testified that she is a bartender at the bar and is in support of the license as she has not witnessed any problem activity at the bar.
- I. Neighbor James Tyler, 2141 North 56th Street, owns a business at 5701 West North Avenue and testified that he does not see any problem activity at the tavern.
- J. Neighbor Steven Koetzer, 5503 West North Avenue, testified that he is in support of the license and he has not witnessed any problem activity at the bar.
- K. Alderman Michael Murphy testified that the licensee failed to respond to two separate mailings from his office, one by certified mail, documenting neighborhood complaints of

nuisance and disorderly activity associated with the Narrow Lane and its patrons. Alderman Murphy further testified that the licensee only recently reached out to the neighbors and his office to discuss their problems shortly before the license renewal hearing.

CONCLUSIONS OF LAW


1. The Committee has jurisdiction to hold hearings and provided Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
2. Based upon the above facts found, the Committee concludes that the licensee, Howard J. Tice, who holds a Class "B" Tavern license for the premises located at 5526 West North Avenue in the City and County of Milwaukee, Wisconsin ("Narrow Lane"), has not met the criteria of Chapter 90, of the Milwaukee Code of Ordinances together with the police report, neighborhood objections and aldermanic objections to allow renewal of his license without undergoing a sixty (60) day suspension. The Committee finds the police report, neighborhood objections and aldermanic objections as stated above to be true.
3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council of the City of Milwaukee should exercise its judgment to renew the Class "B" Tavern license of Howard J. Tice for the premises located at 5526 West North Avenue in the City and County of Milwaukee, Wisconsin ("Narrow Lane") with a sixty (60) day suspension based upon items 3, 4 and 5 on the police report, neighborhood objections and aldermanic objections.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of three (3) ayes and two (2) noes, recommends that the Class "B" Tavern license held by Howard J. Tice for the premises located at 5526 West North Avenue in the City and County of Milwaukee, Wisconsin ("Narrow Lane") be renewed with a sixty (60) day suspension based upon items 3, 4 and 5 on the police report, neighborhood objections and aldermanic objections.

Said suspension is to be in effect between 11:59 a.m., January 31, 2012 through midnight, March 26, 2012.


CONCLUSIONS OF LAW





FINDINGS OF FACT

1. Jessica A. Moehr (hereinafter the "Licensee") is the holder of a Class "D" Bartender License in the City and County of Milwaukee, Wisconsin. Said license expired at midnight, December 31, 2011.
2. An application to renew said license was filed with the Office of the City Clerk on October 28, 2011.
3. Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. On November 1, 2011, the Milwaukee Police Department responded with a police report that could form a basis for nonrenewal or suspension of said license.
4. On December 20, 2011, the City Clerk's Office provided timely notice to the Licensee pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the report of the Milwaukee Police Department and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the police department report on January 4, 2012, commencing at 1:30 p.m. in Room 301B of City Hall. At said date, time and place, the Licensee did not appear and this was her third nonappearance.
5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:

- A. A notice of the hearing as well as a copy of the police report was sent to Jessica A. Moehr at 1036 South 122 Street, West Allis, Wisconsin 53214 on December 20, 2011 by U.S. prepaid first-class mail in an envelope bearing the return address of the License Division. The address of 1036 South 122 Street, West Allis, Wisconsin 53214 is the address given by the Licensee on her application. The envelope was not returned to the License Division by the United States Postal Service. The Licensee failed to appear at the hearing on January 4, 2012.

CONCLUSIONS OF LAW

1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
2. Based on the above facts found, the Committee concludes that the Licensee, Jessica A. Moehr, has not met the criteria of Chapter 125 of the Wisconsin Statutes or Chapter 90 of the Milwaukee Code of Ordinances to allow renewal of the Class "D" Bartender license based upon a third nonappearance.
3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council should exercise its discretion to not renew the Class "D" Bartender license held by Jessica A. Moehr based upon a third nonappearance.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of five (5) ayes and zero (0) noes, recommends that the Class "D" Bartender License not be renewed based upon the licensee's third nonappearance.

Re: Report of the renewal application of Humphrey F. Nangah, agent for Diamonds, Inc., for Class "B" Tavern, Record Spin and Video Game Center Licenses for the premises located at 7607 West Hampton Avenue in the City and County of Milwaukee, Wisconsin ("Diamonds Pub & Grill").

AMENDED FINDINGS OF FACT

1. Humphrey F. Nangah (hereinafter the "Licensee") is the holder of Class "B" Tavern, Record Spin and Video Game Center licenses for the premises located at 7607 West Hampton Avenue in the City and County of Milwaukee, Wisconsin ("Diamonds Pub & Grill"). Said licenses expire at midnight February 4, 2012.
2. An application to renew these licenses was timely filed with the Office of the City Clerk on December 2, 2011.
3. Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. The Milwaukee Police Department responded with a report that could form the basis of non-renewal or suspension of these licenses on December 3, 2011.
4. On December 19, 2011, the City Clerk's Office provided notice to the Licensee pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the police report that could form the basis for nonrenewal or suspension. The matter was scheduled for a hearing on the police report on January 4, 2012 at 8:45 a.m. in Room 301B of the third

floor of City Hall. At said date, time and place the licensee did appear, and was not represented by counsel.

5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. On December 13, 2010 at 2:30 a.m., Milwaukee police were dispatched to 7607 West Hampton Avenue for a shots fired into a bar complaint. Upon arrival, police observed one of the front windows to the bar broken and glass on the ground. Police spoke with security guard Marvin Seals who stated he observed a patron in the corner of the bar acting strangely as if he was casing the bar. Seals stated the patron ordered a few drinks, but when it came time for closing, everyone was leaving except this patron who just stood in the corner. Seals stated he approached the patron and told him he had to leave but the patron refused. Seals stated he and another security guard started to physically escort the patron out the front door and told him not to come back in. Security came back into the bar and the patron began pounding on the front window. Security returned outside and pushed the subject from the window and told him to leave. Seals further stated that about 15-20 minutes he heard shots fired and glass breaking and that he dropped to the floor. Seals stated he was unable to observe the subject who did the shooting. The licensee was on scene and a report was filed regarding this offense.
 - B. On January 29, 2011 at 8:36 p.m., officers of the Milwaukee Police Department were conducting sales of alcohol to underage persons and had a police aide, who was under the age of 21; enter 7607 West Hampton Avenue in an attempt to purchase alcohol. The aide ordered and was served two Miller High Lifes without being asked for ID. The bartender was identified as Chemille Barr who was also found not to have her bartender's license on her person. Police spoke with Humphrey Nangah regarding the violation and Barr was issued a citation for sale to alcohol to underage person and was found guilty on March 24, 2011 and fined \$171.00.
 - C. On April 9, 2011 at 12:50 a.m., officers of the Milwaukee Police Department were conducting sales of alcohol to underage persons and had a police aide, who was under the age of 21, along with an officer in plain clothes, entered 7607 West Hampton in an attempt to purchase alcohol.

Both the aide and undercover officer had to pay a cover charge in order to enter the bar, which they did. Security and the woman who took the cover charge failed to ask them for IDs. The aide and undercover officer proceeded to the bar where the aide was able to purchase a 12-ounce can of Miller Lite from the bartender who was identified as Jasmine Dalton. Dalton was advised that she had sold a beer to an underage patron and was cited for this. A check of the municipal court system was done and the citation could not be found.

CONCLUSIONS OF LAW

1. The Committee has jurisdiction to hold hearings and provided Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
2. Based upon the above facts found, the Committee concludes that the licensee, Humphrey F. Nangah, who holds Class "B" Tavern, Record Spin and Video Game Center licenses for the premises located at 7607 West Hampton Avenue in the City and County of Milwaukee, Wisconsin ("Diamonds Pub & Grill") has not met the criteria of Chapter 90 of the Milwaukee Code of Ordinances or Chapter 125 of the Wisconsin Statutes to allow renewal of his licenses without undergoing a ten (10) day suspension of said licenses based upon the police report.
3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council of the City of Milwaukee should exercise its judgment to renew the Class "B" Tavern, Record Spin and Video Game Center license of Humphrey F. Nangah for the premises located at 7607 West Hampton Avenue in the City and County of Milwaukee, Wisconsin ("Diamonds Pub & Grill") with a ten (10) day suspension of said license based upon the police report. The Committee finds the police report to be true.


RECOMMENDATION



Sinclair based upon the police report with a ten (10) day suspension.


