This case is an action brought pursuant to Wis. Stat. § 74.37 for allegedly excessive real estate taxes imposed for the years 2004 and 2005. The plaintiff and the City have reached a settlement whereby the 2004 and 2005 assessments of the taxpayer's property will be reduced from \$2,614,700 to \$2,418,000. This settlement was reached after a careful review of the taxpayer's property by the Assessor's Office. We recommend the approval of this settlement which will be memorialized by a stipulation and order signed by the court. This stipulation and order would require the City to refund the difference between the assessments for the tax years 2004 and 2005 with interest to the plaintiff within 30 days of the judge's signing the final approval of the settlement. The amount of this settlement will be \$5,086.47 for 2004 and \$4,818.91 for 2005, plus statutory interest as of the date of payment. Plaintiff was originally claiming a refund of \$40,204.00 for 2004 and \$38,090.00 for 2005. Such City funds would come from the Remission of Taxes Account.
