Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 03/07/22 at 12:04pm, Milwaukee Police were dispatched to 2621 N. Downer Avenue for a battery compliant. Investigation revealed that there was a dispute between one of the owners and a repairman who was supposed to fix an appliance from the establishment. The repairman told officers that the owner assaulted him and the owner said that he did not intentionally assault the repairman. A witness to the event could not substantiate an assault so both parties were advised.

This report is being typed by P.O. Jutiki X District #1, Squad 1121. On Monday, March 7, 2022 at 12:04 p.m. I was dispatched to the address of 2621 N. Downer Ave. (Canela Cafe) along with Squad 1120 (P.O. S. Bell) for a complaint of a battery. Upon arriving at the location I spoke to the caller Eddie L. HATCH B/M (09-14-64). HATCH informed me that he owns a repair business. HATCH went on to say that he had done some work for the Canela Cafe located at 2621 N. Downer Ave. HATCH stated about a month ago someone from the business later identified as Reiad Nmi AWADALLAH W/M (06-17-71) contacted him about fixing a toaster. HATCH told me that he informed AWADALLAH how much it would cost to fix the toaster. HATCH stated AWADALLAH agreed to the price and dropped off the toaster for him to fix it. HATCH stated he fixed the toaster and it was returned to AWADALLAH. HATCH stated after he returned the toaster to AWADALLAH he was informed that the toaster still didn't work. HATCH stated he told AWADALLAH to return the toaster to him and he would look at again and check to see what was wrong with it. HATCH stated AWADALLH dropped off a different toaster to him than the original one he had worked on.

HATCH stated he informed AWADALLAH that he had dropped off a different toaster then the one he originally worked on. HATCH stated he asked AWADALLAH if he wanted to pay additional fees for the new toaster he had dropped off. HATCH stated he and AWADALLAH exchanged several text messages about the warranty on the original toaster he had fixed and on the price he charged AWADALLAH. HATCH stated today he brought the toaster back to Canela Cafe because AWADALLAH never came back to his residence to pick it up. HATCH stated he walked into the business to return the toaster and AWADALLAH kept on saying "where's my money," over and over. HATCH stated he didn't owe AWADALLAH any money because he had to be compensated for his time spent looking at and repairing the original toaster. HATCH stated he set the toaster down inside the business and AWADALLAH started cursing at him and walked up to him and got in his face. HATCH stated AWADALLAH was saying "mother fucker I ain't no punk." "I know where you live."

HATCH stated he turned and attempted to leave the store and AWADALLAH started blocking his way as he attempted to leave the business. HATCH stated he turned and AWADALLAH grabbed his left arm and then intentionally spit in his face. HATCH stated after AWADALLAH assaulted him he walked outside and called 911. HATCH stated that there was a female employee standing right there and observed the whole incident. I finished speaking to HATCH and P.O. Bell and I walked into the Canela Cafe and spoke to AWADALLAH. AWADALLAH stated the following.

AWADALLAH stated he had a commercial toaster that went bad and a friend referred HATCH to him

about fixing the broken toaster. AWADALLAH stated he took the toaster to HATCH to fix and HATCH started changing the price of how much it was going to cost to fix. AWADALLAH stated they exchanged a few text messages about the price. AWADALLAH stated he finally just paid HATCH the price he wanted to fix the toaster. AWADALLAH stated a few weeks after HATCH fixed the toaster it stopped working. AWADALLAH stated he contacted HATCH again about fixing the broken toaster he supposedly had fixed. AWADALLAH stated they exchanged some more text messages about him fixing the toaster. AWADALLAH stated HATCH agreed to look at the toaster he had fixed to see what was wrong with it. AWADALLAH stated he dropped off the toaster again to HATCH to look at it. AWADALLAH stated after he dropped the toaster off to HATCH he received a message from HATCH about him dropping off a different toaster to HATCH'S residence than the original one he had fixed.

AWADALLAH stated he had made a mistake and dropped off the wrong toaster to HATCH. AWADALLAH stated he and HATCH started messaging each other about him charging him for looking at the second toaster. AWADALLAH stated they continued to message each other about the fixing of the first toaster and the price of the repair. AWADALLAH stated today HATCH walked into the business with the toaster. AWADALLAH stated after HATCH got inside the business and sat the toaster down he asked him if he had his money. AWADALLAH stated HATCH stated that he didn't have any money for him and started walking towards the exit. AWADALLAH stated as HATCH was walking towards the exit he put his hand out and sat it on top of HATCH'S arm as he was attempting to leave the store. AWADALLAH demonstrated to me how he did it and said it wasn't done with any force. AWADALLAH stated he continued to ask HATCH about his money as HATCH was attempting to leave the store. AWADALLAH stated as he was speaking to HATCH he had some gum in his mouth and it came out his mouth as he was talking to HATCH. AWADALLAH stated he never intentionally tried to spit on HATCH as they were talking about the money he was owed. AWADALLAH stated after his gum came out his mouth HATCH started yelling "you touching on me," "you spitting on me". AWADALLAH stated he told HATCH when your done dancing we can talk. AWADALLAH stated HATCH was trying to put on a show in the store.

P.O. Bell and I finished speaking to AWADALLAH and spoke to Darlene M. SMITH W/F (07-01-89) who stated that she was the manager at the restaurant. SMITH stated that she was there when HATCH and AWADALLAH were talking about the toaster oven. SMITH stated the following.

SMITH stated HATCH came in the store with the toaster and AWADALLAH started asking him about fixing the toaster. SMITH stated they kept going back and forth about the toaster and about AWADALLAH getting his money back. SMITH stated HATCH started backing up towards the door and AWADALLAH walked towards him and continued talking to HATCH about the toaster and the money. SMITH stated as AWADALLAH was walking towards HATCH she told him to just leave it alone and HATCH walked out the store. I asked SMITH if they had any cameras in the front entrance where this incident happened and SMITH stated that they didn't.

P.O. Bell and I finished speaking to SMITH and I checked the front entrance and didn't observe any cameras in the area where this incident happened. P.O. Bell and I walked back outside and spoke to HATCH about AWADALAH and SMITH had stated. HATCH stated that they were lying and insisted that he was spit on and was assaulted by AWADALLAH. I informed HATCH that I didn't have any outside witnesses and couldn't substantiate if he was assaulted or not. HATCH became upset after I stated that

and informed me that he wanted a supervisor to respond to this location. I contacted District #1 dispatcher and informed her that I needed a supervisor to respond to my scene. Squad 1114 (Sgt. J. Lintonen) arrived on scene and I informed him of the complaint I was investigating. After I finished speaking to Sgt. Lintonen he spoke to HATCH and then walked into the Canela Cafe and spoke to AWADALLAH. After Sgt. Lintonen finished speaking to AWADALLAH he came back outside and told HATCH that he couldn't substantiate his claim of a battery. HATCH became further upset and started making comments about race playing a factor in our decision. I tried to inform HATCH several times that race didn't play a factor in our decision. I later gave HATCH a contact card and a business card and I informed him how he could get a copy of this CAD regarding this investigation and how he could possibly obtain the body worn camera footage from this incident.

On Monday, March 21, 2022 at 4:12 p.m. I contacted Dina Nmi BOURAXIS-AWADALLAH W/M (05-30-73) by phone and informed her about the incident between HATCH and AWADALLAH. I told BOURAXIS-AWADALLAH that I would be filling a report regarding this incident.



The above application has been made by the above named applicant(s). This requires approval from the Licenses Committee and the Common Council of the City of Milwaukee. The hearing before the Licenses Committee will take place virtually on 07/18/2022 at 09:55 AM. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
