There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. No petitions can be accepted by the committee, unless the people who signed the petition attend the virtual hearing and are willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 03/25/2020 an officer observed patrons inside eating food at the bar, in violation of the emergency health order issued by the City of Milwaukee Commissioner of Health. The officers spoke with the applicant who stated he thought it was oaky to operate as long as he had less than 10 people in the business. The officers advised him he could not serve food inside and he immediately boxed up the customer's food and had them leave. The applicant was cooperative with the officers.

INITIAL INVESTIGATION

This report is written by P.O. Joel BUNKELMAN, assigned to District 6, Late Power shift, squad 6468.

On Wednesday, March 25th 2020, P.O. Joshua YANG and I were requested to respond to 4252 S Howell AV. by SGT Bradley SCHLEI (squad 6411). This address is for Marsel's Pizzeria restaurant and is located in the city and county of Milwaukee. SGT SCHLEI stated that he observed several people eating inside the restaurant at the bar.

We entered the bar and were in full duty, Milwaukee Police Department issued uniforms and equipped with Axon body worn cameras (BWC). Upon our entrance to the bar we observed 4 people sitting at the bar eating and drinking. An employee who was serving the customers came out from behind the bar and stepped outside to speak with us. The employee identified herself as Anisa FETO (w/f 10-19-95). Anisa stated that she was an employee and that her brother Marsel FETO (w/m 7-25-91) was the owner and had stepped away from the business to run an errand.

Anisa stated that they did serve the four people at the bar. The business had not been open for 1 week and they were under the assumption that they could operate as normal as long as the occupancy of the building remained at 10 or less people. I informed Anisa that serving the people inside the bar was in violation of the order imposed by the City of Milwaukee Commissioner of Health. Anisa stated that she would immediately box up the food and ask them to leave the premise. She also stated that she would call Marsel FETO to come back to the business as soon as possible.

Marsel FETO arrived on scene and we spoke outside the business. I informed him of the order and that he was in violation. Marsel stated that they had been closed for a week and had just opened back up today. They were under the assumption that they could be open as long as they kept the number to 10 or under. That is why they only had seating at the bar and all the chairs were stacked on the tables. Marsel said he was sorry and would immediately comply with the order. I did inform Marsel that he could still sell to go orders while the order was in place.

It should be noted that during the entire encounter both Anisa and Marsel were extremely cooperative and apologetic.

Marsel's Pizzeria has a current Food Dealer - Restaurant license (#13368 exp. 6-12-20) and a valid Class B Tavern license (#207252 exp. 7-29-20).

Marsel was given a copy of the order and issued a PF-6.

This concludes this report.



The above application has been made by the above named applicant(s). This requires approval from the Licenses Committee and the Common Council of the City of Milwaukee. The hearing before the Licenses Committee will take place virtually on 6/23/2020 at 11:40 AM. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Molly Kuether-Steele at (414) 286-2775 or molly.kuether-steele@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
