Remove failing concrete driveway, small dry-stacked limestone retaining wall, failing rear entry stairs and rear concrete paver patio.

Replace driveway with new concrete poured to the edge of the house and extend the pad approximately 10' further into the rear yard in order to accommodate additional concrete pad area - the current driveway configuration accommodates only tandem parking in the driveway.

Widen existing 2'6" wide walkway to 4'. Pour new concrete entry stairs and a new concrete patio.

The retaining wall at the front will be replaced with either a concrete or stacked limestone wall at minimum possible height.
