

- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.


### ADDITIONAL COMMENTS/RECOMMENDATIONS:

The cameras will cover entire interior and exterior of building along with the parking lot. The owner informed us that Marquette is currently installing better lighting in the alley just to the east of the onsite parking lot. The owner stated they will have the wine placed directly in front of the register so it will be in the direct line of site of employees. I recommended employees take the Robbery Prevention Classes and informed owner how to access information (none have yet, but stated he will have them do so). They have two hired security guards who travel between all local locations, but will be hiring a third (he does not believe they are armed). Security will rotate as necessary and

adjust accordingly to problems occurring at the location. There will never be a lot of cash on hand onsite. The have Armored vehicles pick up money (that are locked at all times). They will NOT be selling any tobacco products.




