I am Judicial Court Commissioner Valarie A. Hill and I submit this letter of application for temporary appointment to the forthcoming judicial vacancy in Branch 1 of the Milwaukee Municipal Court.

Currently, I serve in a judicial capacity handling matters in Traffic Court. I have also handled matters in Criminal Intake, Out-of-Custody Intake, Small Claims, Preliminary Hearing, Domestic Violence, and Children's Courts. Serving as a judicial court commissioner has afforded me the opportunity to transition from criminal to juvenile to civil work and from an adversary party to a neutral magistrate. This is a position I am performing well in and have been appointed to annually since July of 1998.

I have installed smoke detectors in homes in conjunction with The American Red Cross; participated in career days, job shadowing, and mentoring for various Milwaukee Public Schools; and volunteered for The American Cancer Society, Girl Scouts of Milwaukee Area, Habitat for Humanity, and other organizations.

The totality of these experiences allow me to bring a solid and diverse background to the position of Municipal Court Judge and will assist me in my strong commitment to the fair administration of justice, thereby allowing me to be a more valuable asset to the citizens of Milwaukee. Thus, I urge your serious consideration of my application for this position. My resume has been included for your review.



Dear Mr. Leonhardt:

I am writing this unsolicited letter on behalf of Milwaukee County Judicial Court Commissioner Valarie Hill, who has submitted an application to replace the Honorable Vincent Bobot as the Branch 1 Municipal Court Judge. This is an incredibly important appointment, as most people's perception of justice in our society is based on what they see in municipal court. It is also incredibly important because of the role municipal judges have within the community while serving, as well as when we leave the municipal bench. For example, one of the former municipal judges currently sits as the Chief Judge for the United States District Court for the Eastern District of Wisconsin, and is a candidate for appointment to the United States Court of Appeals for the Seventh Circuit. One of our former judges serves on the Wisconsin Court of Appeals. Three of us have run for the Wisconsin Supreme Court. One is the presiding judge of Children's Court. All of us wield a great deal of influence in the community, and have stellar reputations. It is vitally important that you have accurate information on the candidates so that you can make the best selection possible. It is for these reasons that I am sending this letter on behalf of Commissioner Hill.

I have known Ms. Hill since she was hired by the State Public Defender's Office. As her immediate supervisor, I had an opportunity to see her work first hand. As a trial lawyer, her reputation was excellent. I believe she still holds the record for consecutive victories as a public defender trial attorney, having won fifteen cases in a row. As a court commissioner, she has done an excellent job on behalf of Milwaukee County. You have already had an opportunity to review her credentials, as she was a finalist for appointment to replace me in Branch 2, the seat that was ultimately awarded to Judge Derek Mosley.

Her appointment would also give the Council an opportunity to address the absence of women on the municipal bench, as one has not held office since the 1970's. Of course, no one should be appointed solely because of gender. However, Commissioner Hill has excellent credentials, a good solid record as a judicial officer, and a great deal of community support. She is president of the Wisconsin Association of African American Lawyers, and the local chapter immediate past-president of a large and prestigious national sorority. I believe that Commissioner Hill is a can't-miss judicial officer, and I strongly support her for consideration by the Council.
