There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. It is the intention of the Common Council to suspend or non-renew the licenses if objectors provide testimony related to the factors enumerated in MCO 85-4-4 that the Common Council finds to be true by a preponderance of the evidence and/or police reports are found to be true by a preponderance of the evidence. The police reports and other attached documents relating to objections to the license are a part of this notice and expressly incorporated in this notice. The licensee should be prepared to address these matters at the hearing.

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

Can you put me in touch directly with the new commercial inspector? Seeing that this complaint is already logged in the system, please re-open the complaint and have the new inspector visit the dumpster.

I found a smooshed rat by their dumpster two weeks ago - photo below - so this is a health issue that needs to be resolved BY THE CITY in a timely matter.

I did have an order that was issued back in the beginning of July that I followed up with weekly for some time. There was no violation found with the garbage for a while and since, the order has been closed out for compliance. I did try reaching out to the business owner today based on this week's new finding. I was not able to get a hold of them and left a voicemail. Unfortunately, I am no longer the district commercial inspector for this property and recommend submitting a formal complaint through our DNS complaint line 414-286-2489, so the correct inspector is assigned and has a record with the complainant's information to work with. Please let me know if you need any more information from my end. If I hear back from the business owner, I will update you as well. Otherwise, thank you for your follow up and hope this can be resolved in a timely manner.

Hi Aaron,

Thanks for the update.

With the heat and humidity this smells really bad and attracts rodents. The commercial dumpster hasn't been picked up since last week, so they'll just pile bags on top of the already-composting restaurant waste- that STINKS!!

Are restaurants allowed to use residential trash and recycle cans for their refuse? If not, can the bins be removed by DNS to prevent this? There is no residential tenant in that building.

My first complaint on this thread started in February 2025 after years of talking with the operator on these issues. I'm a bit dumbfounded that even though the operator has been informed on the rules of regulations, this continues to be a recurring issue.

This needs to be an ongoing compliance check and not a one-and-done.

I don't want to be a nuisance to the city and the guy that always complains, but I feel like I have given plenty of time and patience to the operator over the years. With that said, I will reach out to you or the alder if it happens again, but hopefully the situation has finally resolved!

Hi

If orders are corrected by the time of inspection, traditionally we only enter an establishment for the annual routine and by complaint basis. It looks like the operator is taking the correct steps to get back into compliance, but we will verify at our reinspection for the complaint. During this year's routine we will check if the corrective action is working for the business operation.

Moving forward, we have spoken to the operator and he understands what's required for trash disposal and storage. If there are any future occurrence's, you can reach out to us or Ald. Dimitrijevic's office to discuss long term compliance if it comes to that. In the meantime, the operator has been pretty understanding when it comes to what we expect, if you are able to have a conversation with him I would recommend that route to ensure he understands where you are coming from.

Whether it's garbage, i.e. food waste that never gets picked up (and begins to compost and smell), restaurant/food waste getting put into my tenants garbage bins, and now for the past ~2 months no dumpster for food waste, just piled in the alley until someone picks it up.

This is a public health issue, as leaving garbage bags to pile up in the alley attracts rats and other critters, not to mention the alley has turned into Belli's dump.

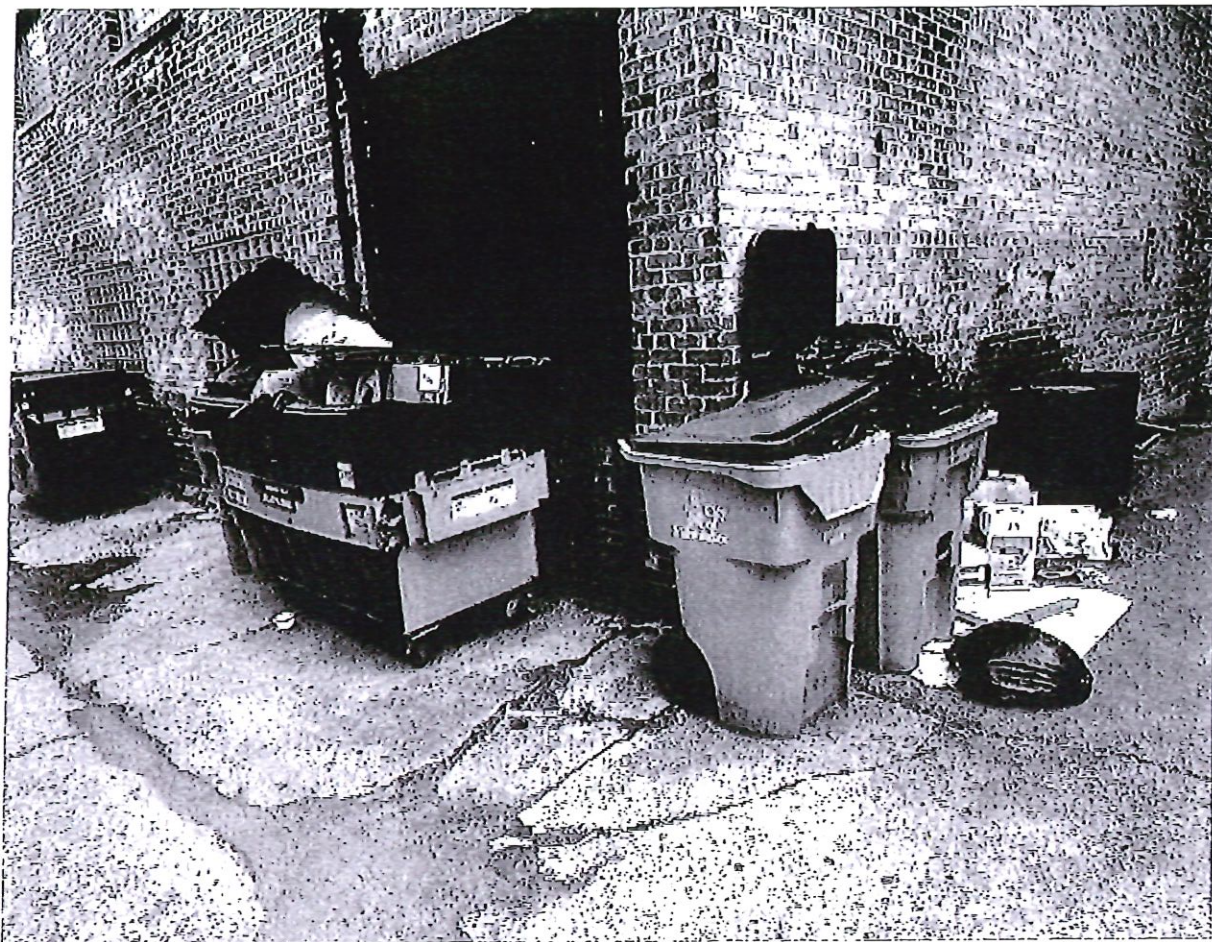

I am the owner of the neighboring property across the alley and this has been an CONSTANT issue since they have moved into the building formerly occupied by Honey Pie. Whether it's garbage, i.e. food waste that never gets picked up (and begins to compost and smell), restaurant/food waste getting put into my tenants garbage bins, and now for the past ~2 months no dumpster for food waste, just piled in the alley until someone picks it up.

This is a public health issue, as leaving garbage bags to pile up in the alley attracts rats and other critters, not to mention the alley has turned into Belli's dump.

Every time I text the owner, he promptly replies "sorry this will never happen again", but I'm tired of being the police officer of their waste. It's a public health issue and disgusting for my tenants to live next to. My taxes keep going up, and the alley keeps getting more disgusting!

If you need ~three years of text exchanges for more history on these recurring problems, let me know.

Please advise.

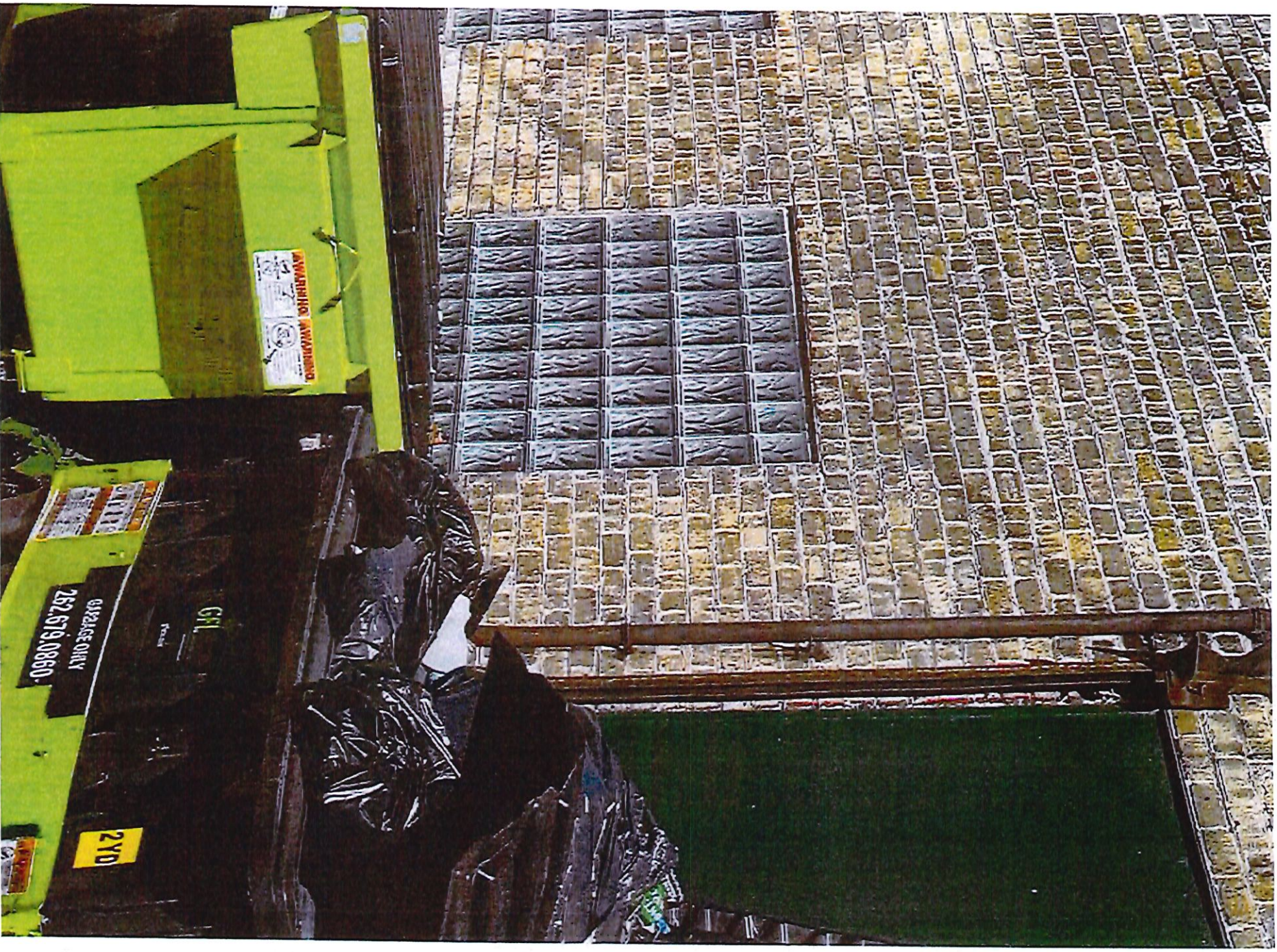


