THE CITY OF MILWAUKEE PROPOSES TO FIND INNOVATIVE WAYS TO UNLOCK THE POTENTIAL FOR CREATING JOBS FOR RESIDENTS WHO LIVE NEAR THE MEMOMONEE VALLEY. THIS PROJECT INCLUDES CONDUCTING ENVIRONMENTAL STUDIES THAT WILL FORM THE BASIS OF AN AQUA-SHED APPROACH FOR REMEDIATION AND REDEVELOPMENT. TARGET POPULATION IS ABOUT 68,000 PEOPLE.

THIS GRANT PROJECT IS AWARDED AN ADDITIONAL \$100,000 TO REIMBURSE THE USEPA FOR THE PERSONNEL COSTS OF AN EXISTING EMPLOYEE, ASSIGNED UNDER THE INTER-GOVERNMENTAL PERSONNEL ACT, TO ASSIST WITH MILWAUKEE'S BROWNFIELD REDEVELOPMENT TEAM AND ALSO ASSIST WITH THE LOCAL, STATE AND FEDERAL PARTNERS IN MILWAUKEE'S BROWNFIELD REDEVELOPMENT FOR APPROXIMATELY AN ADDITIONAL YEAR.
