Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (7' width of tree border area), and grading.

**6th Aldermanic District**

**N. 12th St. – W. Concordia Ave. to W. Keefe Ave. (ST211180222)**

Install traffic calming speed hump(s).

**N. 16th St. – W. Atkinson Ave. to W. Capitol Dr. (ST211160164)**

Install traffic calming speed hump(s).

**N. 21st St. – W. Nash St. to W. Vienna Ave. (ST211180269)**

Install traffic calming speed hump(s).

**S. 25th St. – W. Greenfield Ave. to W. Scott St. (ST211180273)**

**15th Aldermanic District**


**N. 41st St. – W. Meinecke Ave. to W. Wright St. (ST211190114)**
