FIRST AMENDMENT TOLEASE AGREEMENT

- 2. **Rent.** Effective April 1, 2007, the rent shall be increased by \$19,500.00 per annum. The rent is hereby increased from \$0 per annum to \$19,500.00 per annum.
- 3. **Notices.** Section 16 is hereby deleted in its entirety and replaced by the following: **NOTICES.** All notices, requests, demands and communications hereunder will be given by first class certified or registered mail, return receipt requested, or by a nationally recognized overnight courier, postage prepaid, to be effective when properly sent and received, refused or returned undelivered.
