The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 11/26/20 at 11:44am, Milwaukee Police were dispatched to 620 W. Oklahoma Avenue for a theft complaint. Investigation revealed that 2 subjects entered the establishment, took items, and left without paying for those items:
2. On 12/11/20 at 11:50pm, Milwaukee Police were dispatched to 620 W. Oklahoma Avenue for a theft complaint. Investigation revealed that two subjects entered the establishment, filled two laundry bags full of items, and left the store without paying for the items.

3. On 01/11/2021 at 6:58pm officers were dispatched to Walgreen's, 620 W. Oklahoma Av. for a Threat complaint. The officers spoke with the manager, who stated a known subject comes in the store and intimidates employees with aggressive language. The manager stated she has information on a restraining order but the business is hesitant to put one in place.
4. On 01/12/2021 at 7:52pm officers were dispatched to Walgreen's, 620 W. Oklahoma Av. for a Shoplifter. The officers spoke with the clerk who stated a subject was observed leaving with merchandise he did not pay for. The clerk described the subject to the officers. The officer recognized the subject based on the description as a known shoplifter. Officers filed a report and ordered it in to the DA's office.

5. On 01/14/2021 at 8:49pm officers were dispatched to Walgreen's, 620 W. Oklahoma Av. for a Shoplifter. The officers spoke with the manager, who stated a subject came into the store and took merchandise without paying for it. The same subject has been observed stealing the same items from the store in the past. The manager stated they would call if the subject returns.
6. On 01/16/2021 at 7:05pm officers were dispatched to Walgreen's, 620 W. Oklahoma Av. for a Shoplifter. The officers interviewed the clerk, who stated a subject came in the store and loaded up a shopping cart with merchandise. The subject attempted to walk out with the cart without paying for it. The clerk and the manager stopped the subject and he grabbed some items from the cart and fled the store. The clerk provided a list of the items stolen.
7. On 01/27/2021 at 9:02pm officers were dispatched to Walgreen's, 620 W. Oklahoma Av. for a Shoplifter. The officers spoke with the manager, who stated a known shoplifter came in the store and took \$60 worth of shampoo. The manager stated she is normally able to stop the subject before he is able to take anything.

The officer spoke with the manager, who stated a subject was in the store drinking alcohol so she asked him to leave. The subject then fell asleep in the vestibule. The clerk showed the officers the video but there were only 4 cameras working and did not cover the area the subject was in.
12. On 02/25/2021 at 4:07pm officers were dispatched to Walgreen's, 620 W. Oklahoma Av. for a Trouble with Subject. The officers interviewed the clerk, who stated a subject had been in the store since 10am and she wanted her to leave. The officers spoke with the subject who stated she was homeless. The officers attempted to find the subject housing and made arrangements for the subject to wait at the district station until housing was found.
13. On 03/09/2021 at 4:44pm officers were dispatched to Walgreen's, 620 W. Oklahoma Av. for a Property Damage complaint. The officers interviewed the manager, who stated a subject caused a disturbance in the restroom. The subject was cited for Disorderly Conduct and conveyed home.
14. On 03/09/2021 at 5:04pm officers were dispatched to Walgreen's, 620 W. Oklahoma Av. for a Shoplifter. The officer spoke with the manager, who stated a subject stole merchandise and

filed in a car. The officer checked the location the license plate listed to but did not locate the vehicle.

The officers spoke with the manager, who stated a known subject concealed on his person merchandise and left the store without paying for the items. The officers interviewed the manager, who stated 3 subjects came in and filled up a shopping cart with merchandise. The subjects walked out without paying for the items. On Monday, January 11th, 2021 at 6:58PM, I (Squad 6290) was dispatched to a Threat at 620 W Oklahoma Av (Walgreens).

Upon arrival, I located the subject (Jason T SPANTIKOW; w/m, 6-5-77) who was next to the front door inside the business. SPANTIKOW stated he was trying to get a lighter or book of matches to light his cigarette. I told him that he would have to buy one. SPANTIKOW asked if I could buy one for him. SPANTIKOW began to mumble and then left the building on foot walking w/b on W Oklahoma Av.

I interviewed the Manager (Brooke K CONLEY, w/f, 11-14-82) who stated that SPANTIKOW has become violent in the past and hit another employee. CONLEY stated that she is not afraid of him, but that he intimidates others with his aggressive language and she worries what he does when she's not there. CONLEY stated that SPANTIKOW has stolen in the past from the store. He came back after awhile to get in from the cold and use the bathroom which she allowed. CONLEY stated that SPANTIKOW has recently become verbally abusive again. CONLEY stated that Walgreen's has information on a restraining order, but that corporate is hesitant to get those put in place.

This report is written by Police Officer Daniel Drewek assigned to District 6 Early Shift.

On 1/12/21, at 8:35 pm, my partner Police Officer Eric Laux, and I, while on Squad 6231, were dispatched to 620 W. Oklahoma Ave (Walgreens, City and County of Milwaukee) for a theft complaint.

Upon arrival, we spoke with the caller/victim Brooke R. Conley (w/f, 11/14/1982) who stated that a subject had stole from the location. Brooke said she did not witness the incident but was told by her employee (Primavera) that the subject had a tattoo above his eye and she witnesses the incident. Brooke is the manager at the Walgreens.

The subject enters the location at 7:52 pm and walks to the aisle where the paper towels are location. He grabs four packages of Bounty brand paper towels and exits the store at 7:53 pm. Two packages were \$11.99 each and the other two were \$9.99 each. Total value of \$43.96.

I spoke with cashier Primavera T. Jimenez-Rivera (w/f, 10/12/04) who saw the subject stealing from the location. She said he was a light skinned male with a tattoo above his right eye, wearing baggy pants, a brown/greenish jacket, and was in his mid 30's. Primavera said she saw the suspect walking with the paper towels and told him to put the stuff back and he told her "you don't tell me what to do." Primavera said the suspect then exited the store with the stolen merchandise.

Gabriel L. Soto (w/m, 3/4/93) is a known suspect in our District that has committed

several retail thefts in the past and I know that he has a tattoo above his right eye. He has also been mentioned during our roll call meetings as being a commonly known subject that has committed retail thefts in our District.

On 1/12/21, P.O. Laux formulated a photo array and I put the photos in the folders and shuffled them. At 10:05 pm, we conducted the photo array Primavera at Walgreen's in the employee breakroom.

Primavera said she 75% with the subject in folder #3 because of his eyes.

We went to the last known address for Soto at 2003 W. Lincoln Ave and were unable to locate him.

Soto currently has an open case with Milwaukee County for retail theft and disorderly conduct. Case# 20CM001542. Soto has been arrested in the past for an armed robbery that occurred at 3045 S. 13th St. (See Case# 202670109). Soto currently has one prior retail theft municipal conviction with the City of Milwaukee (Citation #J9807RB15K).

P.O. Laux obtained a copy of the incident on DVD and placed it on MPD inventory #21001474. The photo array was placed on inventory #21001470.

## Video observations:

The suspect is observed entering the front entrance door at 7:52 pm and exits the same door at 7:53 pm without paying for items (packages of Bounty paper towels).
