..Title

Substitute resolution approving levying of assessments and construction of assessable public improvement projects at various locations and appropriating funds for these purposes with the City cost of these projects approved by this resolution is estimated to be \$33,365 for a total estimated cost of \$91,600.

..Analysis

This resolution confirms the report of the Commissioner of Public Works, as modified by the Common Council Committee, on projects for which Public Hearings have been held. The resolution authorizes the levying of special assessments and directs the installation and construction of said public improvements. The City cost of these projects approved by this resolution is estimated to be \$33,365. The total estimated cost of these projects is \$91,600.

..Body

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions, determining it necessary and in the public interest to construct and levy special assessments for the following improvements:

1st Aldermanic District

N. 42nd St. – W. Kiley Ave. to W. Good Hope Rd. (ST211230108) Installing traffic calming speed hump(s). (Assessable Reconstruction Paving Fund – \$4,830; Nonassessable Reconstruction Paving Fund -- \$1,000). The total estimated cost for this project including the requested amount is \$13,300. This project is anticipated to be completed during the 2023 construction season.

N. 52nd St. – W. Villard Ave. to W. Custer Ave. (ST211230107) Installing traffic calming speed hump(s). (Assessable Reconstruction Paving Fund – \$4,760; Nonassessable Reconstruction Paving Fund -- \$1,000). The total estimated cost for this project including the requested amount is \$11,700. This project is anticipated to be completed during the 2023 construction season.

W. Fiebrantz Ave. – N. 19th Pl. to N. 20th St. (ST211230125) Installing traffic calming speed hump(s). (Assessable Reconstruction Paving Fund – \$845; Nonassessable Reconstruction Paving Fund -- \$1,000). The total estimated cost for this project including the requested amount is \$6,900. This project is anticipated to be completed during the 2023 construction season.

N. 47th St. – W. Burleigh St. to W. Auer Ave. (ST211230136) Installing traffic calming speed hump(s). (Assessable Reconstruction Paving Fund – \$1,820; Nonassessable Reconstruction Paving Fund -- \$1,000). The total estimated cost for this project including the requested amount is \$11,700. This project is anticipated to be completed during the 2023 construction season.

N. 54th St. – W. Parkway Dr. to W. Hampton Ave. (ST211230131) Installing traffic calming speed hump(s). (Assessable Reconstruction Paving Fund – \$5,750; Nonassessable Reconstruction Paving Fund -- \$1,000). The total estimated cost for this project including the requested amount is \$16,400. This project is anticipated to be completed during the 2023 construction season.

S. 9th St. – W. Madison St. to W. Scott St. (ST211230137) Installing traffic calming speed hump(s). (Assessable Reconstruction Paving Fund – \$860; Nonassessable Reconstruction Paving Fund -- \$1,000). The total estimated cost for this project including the requested amount is \$9,100. This project is anticipated to be completed during the 2023 construction season.

S. 14th St. – W. Harrison Ave. to W. Arthur Ave. (ST211190204) Installing traffic calming speed hump(s). (Assessable Reconstruction Paving Fund – \$1,440; Nonassessable Reconstruction Paving Fund -- \$1,000). The total estimated cost for this project including the requested amount is \$6,900. This project is anticipated to be completed during the 2023 construction season.

S. 17th St. – W. Lincoln Ave. to W. Grant St. (ST211230121) Installing traffic calming speed hump(s). (Assessable Reconstruction Paving Fund – \$1,960; Nonassessable Reconstruction Paving Fund -- \$1,000). The total estimated cost for this project including the requested amount is \$8,600. This project is anticipated to be completed during the 2023 construction season.

13th Aldermanic District

S. 25th St. – W. Euclid Ave. to W. Oklahoma Ave. (ST211230138) Installing traffic calming speed hump(s). (Assessable Reconstruction Paving Fund – \$2,100; Nonassessable Reconstruction Paving Fund -- \$1,000). The total estimated cost for this project including the requested amount is \$7,000. This project is anticipated to be completed during the 2023 construction season.

Further Resolved, That said Commissioner of Public Works is authorized and directed to proceed with said work in accordance with said report pursuant to Section 66.0703 and any other pertinent sections of the Wisconsin Statutes and in the manner directed by Section 115-42 of the Milwaukee Code of Ordinances; and, be it

Further Resolved, That the proper departments take such action as is required of them to assess the abutting or adjacent properties and collect such assessment in the manner directed by Section 115-42 of the Milwaukee Code of Ordinances; and, be it

Further Resolved, That the City Comptroller is authorized to transfer such funds which are available for this purpose to the appropriate capital Project/Grant accounts; and, be it

Further Resolved, That the projects do not involve any parcels of agricultural land which are eligible for deferred special assessments under the provisions of Section 14.30 of the Milwaukee City Charter; and, be it

Further Resolved That a portion of the speed hump projects will be utilizing ARPA (American Rescue Plan Act) funds: The project/grant number is RG1515236105; and, be it

Further Resolved, That the Department of Public Works is authorized to use the funding as specified in the above description of work; and, be it

Further Resolved, That projects N. 42nd St. (ST211230108), N. 52nd St. (ST211230107), W. Fiebrantz Ave. (ST211230125), N. 47th St. (ST211230136), N. 54th St. (ST211230131), S. 9th St. (ST211230137), S. 14th St. (ST211190204), S. 17th St. (ST211230121), S. 25th St. (ST211230138) will be billed after January 1, 2025, but not before 12 months after the project contract has been completed.
