

We wish to appeal the decision on this file. We did not expect that the police records would not list the Nintendo 64 game that was taken from our house, called Knockout Kings 2000, which was mentioned in the investigative narrative, written by Det. St. Onge on 10/4/00. When we had called the department of property control, before the items were sent to the Milwaukee Country Store, we were told that it was in inventory. It was not retrieved from the store, however, as were the rest of the items which were delivered to us. We were told that to find it is like searching for a needle in a haystack. After reading your letter in which you deny our claim, I realize that you must not have talked with Det. St. Onge, who promised to tell you that indeed there had been a Nintendo 64 game in our inventory. We were given back only the two Games Boy systems and two games for that system. The inventory control department's list of what they returned to us should indicate that we were only given games for game boy and not the Nintendo 64 game cartridge.

We request that Det. St. Onge and Captain Stuhmer be present at the hearing.



Circumstances: Our son had stolen Nintendo & Game Boy items from a neighbor's house. Det. Robert St. Onge and officers came to our home with a list, made by the victims, of items missing from their home. Because some of these were games for a Nintendo 64 system, Det. St. Onge took any and all Nintendo 64 games knowing that some were ours. The detective stated that any items that were not identified by the neighbors would be returned to our family the same night, after he showed them to the family. The Game Boys and the Nintendo 64 game that the family did not claim were put into inventory with the police department under inventory number 140554. We requested their return on numerous occasions but Det. St. Onge kept stalling us. He told us that we could not claim them without having a receipt proving that we had purchased them. We no longer had receipts and could not prove we had purchased them. By the time we complained to his supervisor that we were not allowed to have our items, our possessions were sent to "The Country Store". Captain Stuhmer made every effort to retrieve them and replace them in inventory. Eventually, all items were returned to us except a Nintendo 64 Game. Det. St. Onge called us several weeks ago and told us that there was no way to track the game down and that we needed to make a claim to the city for the cost to replace the game and so we are filing this claim. On the reverse side of this complaint is a copy of our receipt for a Nintendo 64 game that we recently purchased to replace the one that was taken from our home. We want \$63.35 at this time. Thank you.
