long as I have lived here.



also said they are not going to enforce any gun policy meaning they will not engage in a no gun

policy because this is their clinental.

They are not going to place a padlock on the cage behind the building, and no lights because they do not own the building. Now 1, , an all know each other and are either not own the building. Now related or friends.

I had a conversation about the guns in the store and said the students of Washington High School all have guns and carry them in their pants at the school. I think the school has metal detectors but I'm not sure about that. He continued to argue his point saying one guy came into the store showing his new gun he just bought from a cop. This is all hearsay but I have found an element of fact with the talk in the neighborhoods.

He also said they have 1/2 inch of bullet proof glass so he is not worried. The students, teachers, and

the neighbors do not live all day in a bullet proof glass box.

Alderman Rainey these kids are living in violence, supplemented by drugs and sex. They are still kids and still developing and are the future of Black America. So now these businesses are implanting themselves next to schools, profiteering from the location and stupidity of the kids' lack of worldly experience and wisdom. We know better, we have lived long enough to understand how kids go for brightly colored candies.

Let me tell you a story, a doctor in England was doing experiments with drug addiction trying to determine if addiction was just physical, he placed a rat in a cage and gave it two water bottles one with water and one with water and heroine in it. The rat quickly went to the bottle with heroine and refused the plain water. Alexsander thought it was a biological addiction. He thought more and decided this rat needed more to its environment like a rat community and park with things to do and food that was good. The rat bonded with other rats, ate well and was stimulated with some purpose. That rat and the other rats refused the heroine tainted water and only drank from the pure water bottle. The implication being it is the cage you are in and the purpose you have in life which may help determine if one can survive addiction. I think the time is now to take the steps necessary for businesses to bring to the licensing process a measure of good neighborship and security not just for their personal but for the neighbors and in this case the schools environmental health and safety. This is how communities thrive by mutual collaboration. We need to have each other's back. These stores just keep spending money for lawyers, and changing legal paper ownership, how about we accept they are going to be a part of our community but ensure they take the necessary steps for safety, legalities, and responsiveness of actions to protect the area, not just a bullet proof glass cage.
